19	to approve the paper ballot allocation for the
20	August 2nd Primary Election. We've done this
21	before. She told me there were no changes. Each
22	precinct gets at least 25 packaged ballots. Some
23	get 50. I don't believe I saw any, any more than
24	50 for Republican or Democrat, but it's possible
25	there are. But at any rate, there are no changes

8	adopt the voting machine and paper pollbook
9	allocation formula in Exhibit B compiled by the
10	board staff for the August 2nd, 2022 Primary

24	voter registration system, so he's very proficient
25	with that system. He also supervises and trains

3	him. Travis is very personable and very hands-on,
4	and I think he'll make a good fit for that
5	department and working with our supervisor,
6	Sara Ziemba, who has been leading that department
7	since the last manager left.

9	for approval to promote Travis Simmons.

24	course, we will be doing two pages for test decks.
25	We'll be doing two pages for any of the training

2	sufficient.
3	If we get into a situation where we
4	do realize there's a third page of the ballot for
5	the City of Columbus most likely, we would do a
6	supplemental order around September 15th. And we
7	just, we don't have enough information to know that
8	we're going to have a two- or three-page ballot
9	right now.
10	MEMBER MARINELLO: But it won't go
11	to waste, so you could order it now and use it.
12	DIRECTOR WHITE: Part of the
13	challenge we have here, too, is storage and where
14	we store, because they come on pallets. And so you
15	order another half million pieces of ballots, I
16	mean, how many pallets is that? Five or six?
17	MR. KELLY: That's going to be six,
18	six and a half pallets.
19	DIRECTOR WHITE: Yeah. So then we
20	have a storage issue.
21	MR. KELLY: It does have to be
22	stored under a DNR lock.
23	DIRECTOR WHITE: And it has to be
24	under climate control. So we only have certain
25	areas within the building where we can store that

2	MEMBER SEXTON: What is the deadline
3	for the local issues and issues? Isn't that
