

PROPOSED BOND ISSUE

SOUTH-WESTERN LOCAL SCHOOL DISTRICT

SHALL BONDS BE ISSUED BY THE SOUTH-WESTERN LOCAL SCHOOL DISTRICT, FRANKLIN COUNTY, OHIO, FOR THE PURPOSE OF PURCHASING REAL ESTATE AND EASEMENTS, CONSTRUCTION AND IMPROVEMENT OF FIRE PROOF SCHOOL BUILDINGS, PURCHASE OF FURNITURE AND FURNISHINGS, AND SITE IMPROVEMENTS IN THE SUM OF TWO MILLION FIVE HUNDRED THOUSAND DOLLARS (\$2,500,000.00) AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE 1.7 MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO SEVENTEEN CENTS (\$.17) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY-THREE YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?

SHALL BONDS BE ISSUED BY THE BOARD OF EDUCATION OF UPPER ARLINGTON CITY SCHOOL DISTRICT, FRANKLIN COUNTY, OHIO, FOR THE PURPOSE OF ACQUIRING LAND FOR SCHOOL PURPOSES, CONSTRUCTING AND IMPROVING FIREPROOF SCHOOL BUILDINGS AND PURCHASING FURNISHINGS AND EQUIPMENT FOR SCHOOL BUILDINGS IN THE SUM OF NINE HUNDRED SIXTY THOUSAND DOLLARS (\$960,000.00) AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION, ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE NINE-TENTHS (.9) MILL FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO NINE CENTS (\$.09) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY (20) YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?
