A Majority Affirmative Vote is Necessary for
Passage.

A replacement of 2.5 mills of an existing levy and an increase of 0.5 mill, to constitute a tax for the benefit of Hamilton Township for the purpose of PROVIDING AND MAINTAINING FIRE APPARATUS, APPLIANCES, BUILDINGS, OR SITES THEREFOR, OR SOURCES OF WATER SUPPLY AND MATERIALS THEREFOR, OR THE ESTABLISHMENT AND MAINTENANCE OF LINES OF FIRE ALARM TELEGRAPH, OR THE PAYMENT OF PERMANENT, PART-TIME, OR VOLUNTEER FIREMEN OR FIRE FIGHTING COMPANIES TO OPERATE THE SAME, INCLUDING THE PAYMENT OF THE FIREMEN EMPLOYER'S CONTRIBUTION REQUIRED UNDER SECTION 742.34 OF THE REVISED CODE, OR TO PURCHASE AMBULANCE EQUIPMENT, OR TO PROVIDE AMBULANCE OR EMERGENCY MEDICAL SERVICES OPERATED BY A FIRE DEPARTMENT OR FIRE FIGHTING COMPANY at a rate not exceeding 3 mills for each one dollar of valuation, which amounts to \$0.30 for each one hundred dollars of valuation, for a period of five years, commencing 1999 tax year.

WESTERVILLE CITY SCH DIST PROPOSED
TAX LEVY (Repl) (ISSUE #8)

A Majority Affirmative Vote is Necessary for
Passage.

A replacement of a tax for the benefit of the Westerville City School District for the purpose of CURRENT EXPENSES at a rate not exceeding 9.2 mills for each one dollar of valuation, which amounts to \$0.92 for each one hundred dollars of valuation, for a period of two years, commencing 1999 tax year.

M. and midnight on Sunday, at licensed premises where the sale of food and other goods and services exceeds fifty per cent of the total gross receipts of the permit holders at the premises?

A Majority Affirmative Vote is Necessary for Passage.

Shall the sale of wine and mixed beverages of the same types as may be legally sold in this precinct on other days of the week, be permitted in this City of Columbus, Ward "44", Precinct "J" for consumption off the premises where sold, between the hours of one P. M. and midnight on Sunday?

LOCAL OPTION COLUMBUS 56-A (ISSUE #11)

A Majority Affirmative Vote is Necessary for Passage.

Shall the sale of beer and intoxicating liquor be permitted on Sunday by Vittorio Investments, Inc., doing business at Champions Municipal Golf Course, an applicant for a D-6 liquor permit, who is engaged in the business of catering and operating the food and beverage service at Champions Golf Course at 3900 Westerville Road, Columbus, Ohio 43224 in this precinct?

12a L O 67-F

LOCAL OPTION COLUMBUS 67-F (ISSUE #12a)

A Majority Affirmative Vote is Necessary for Passage.

Shall the sale of intoxicating liquor, of the same types as may be legally sold in this precinct on other days of the week, be permitted in this City of Columbus, Ward "67", Precinct "F" for consumption on the premises where sold, between the hours of one P. M. and midnight on Sunday?

#15 METRO PARKS

COLUMBUS AND FRANKLIN COUNTY METRO PARKS TAX LEVY (Repl & Incr) (ISSUE #15)

A Majority Affirmative Vote is Necessary for Passage.

A replacement of 0.55 mill of an existing levy and an increase of 0.1 mill to constitute a tax for the benefit of the Columbus and Franklin County Metropolitan Park District (commonly known as Metro Parks) for the purpose of CONSERVING NATURAL RESOURCES; DEVELOPING, IMPROVING, MAINTAINING, AND OPERATING BLACKLICK WOODS, SHARON WOODS, BLENDON WOODS, HIGHBANKS, BATTELLE-DARBY CREEK, PICKERINGTON PONDS, CHESTNUT RIDGE, SLATE RUN, CLEAR CREEK, THREE CREEKS METRO PARKS, INNISWOOD METRO GARDENS AND OTHER PROPERTIES OF THE PARK DISTRICT; AND ACQUIRING, DEVELOPING, IMPROVING, MAINTAINING, AND OPERATING ADDITIONAL LANDS FOR PARK PURPOSES at a rate not exceeding 0.65 mill for each one dollar of valuation, which amounts to \$0.065 for each one hundred dollars of valuation, for a period of ten (10) years, commencing 1999 tax year.

#17 BEX CH AMEND

CITY OF BEXLEY PROPOSED CHARTER AMENDMENT (ISSUE #17)

A Majority Affirmative Vote is Necessary for Passage.

Shall the amendments to the Bexley City Charter proposing to change the form of government from the Council-Mayor plan to the Council-City Manager plan, by replacing an elected Mayor as the City's chief executive officer with a City Manager appointed by Council and an elected Auditor as the City's chief financial officer with a Finance Director appointed by the City Manager, with the concurrence of Council, be adopted? If the amendments are adopted, the Mayor/City Manager change would be effective January 1, 2000, and the Auditor/Finance Director change would be effective January 1, 2002.

VILLAGE OF GROVEPORT PROPOSED
CHARTER AMENDMENT (4.05) (ISSUE #18)

A Majority Affirmative Vote is Necessary for
Passage.

Shall Section 4.05 of the Charter of the Village of
Groveport, Ohio, be amended to require a
three-fourths affirmative vote of the members of
Council for enactment of emergency ordinances or
resolutions? Emergency ordinances or resolutions
receiving a majority vote but not the required
three-fourths affirmative vote shall become
effective as non-emergency legislation.

VILLAGE OF GROVEPORT PROPOSED
CHARTER AMENDMENT (4.06) (ISSUE #19)

A Majority Affirmative Vote is Necessary for
Passage.

Shall Section 4.06 of the Charter of the Village of
Groveport, Ohio, be amended to require Council to
declare an Ordinance to be an emergency
measure only in the event of a demonstrated threat
to the public peace, health, safety and welfare of
the Village or its residents?

VILLAGE OF GROVEPORT PROPOSED
CHARTER AMENDMENT (6.01) (ISSUE #20)

A Majority Affirmative Vote is Necessary for
Passage.

Shall Section 6.01 of the Charter of the Village of
Groveport, Ohio, be amended to require a person
appointed as Administrator, and not a resident of
the municipality at the time of appointment, to
become a resident within six months of
appointment?

#21 GRVPT CH AM

VILLAGE OF GROVEPORT PROPOSED
CHARTER AMENDMENT (9.02) (ISSUE #21)

A Majority Affirmative Vote is Necessary for
Passage.

Shall Section 9.02 of the Charter of the Village of
Groveport, Ohio, be amended to prohibit the
Village from entering into employment contracts
with Village employees or Village officials holding
appointive office with respect to their positions with
the Village? All such contracts existing on the date
of this amendment shall be terminated by the
Village pursuant to the terms of those contracts, if
so provided in the terms.

SCHOOL AND COMMUNITY USE;
RENOVATING AND IMPROVING EXISTING
SCHOOL BUILDINGS AND FACILITIES,
INCLUDING IMPROVING ACCESS FOR THE
DISABLED; FURNISHING AND EQUIPPING
THE SAME, INCLUDING TECHNOLOGY FOR
CLASSROOM INSTRUCTION; LANDSCAPING

amount of \$27,100,000, to be repaid annually over
a maximum period of 28 years, and levy a property
