Franklin County Launches Two Initiatives For March 19, 2024, Primary

The Franklin County Board of Elections (BOE) created a new position called **Election** Support Specialist (ESS) and deployed 25 ESSs to 75 voting locations during the November 2023 General Election, as part of a successful pilot program. An ESS, who receives more than 30 hours of training and replaces the former Day Driver, provides immediate expertise and guidance to poll workers at voting locations during Monday Setup and on Election Day. As enthusiasm builds over the ESS position, BOE Director Antone White shares, "the Election Support Specialist program is another step in professionalizing our election operations and providing ultimate support for our poll workers on Election Day."

With the March 19, 2024, Primary, the BOE will assign an ESS to each voting location. Learn more about this exciting program by visiting the ESS table at Practice Makes Perfect.

GENERAL INFORMATION

VOTING LOCATION MANAGER

PEO Payroll for Monday Setup and Election Day is tracked using Touchpad. Names of poll workers assigned to your location are preloaded on your Touchpads. To add a poll worker's name for payroll, select "ADD WORKER," and follow the prompts. Payroll steps are on page 34 of the PEO Training Manual for the March 19 Primary.

VOTING MACHINE JUDGE

Login and logout on each Touchpad you use to process voters on Election Day. To login, select "START" and enter your First Name and Last Name on the login screen. Your VLM will provide you with a password required to advance to the next screen. When you are ready to go for break or lunch, logout by selecting "DEVICE INFO / LOGOUT" from the drop-down menu, and choosing "LOGOUT TEMPORARILY."

Attach a Scanner to every tabletop Ballot Marker in your location. Authority to Vote (ATV) Slips printed from Touchpads have a bar code that you scan to bring up a voter's correct ballot on the Ballot Marker. Put the blank Ballot Card in the Ballot Marker BEFORE you scan the ATV Slip.

Compare the voter's name and address on the yellow Provisional Ballot Envelope to what is on the Reason For Paper Ballot Slip (RFPB). If they match, use the Ballot Style and Precinct Identifier on the RFPB Slip to complete the bottom of the envelope. If they do not match, use the Yellow Street Guide to find the voter's correct Ballot Style and Precinct Identifier; complete the Provisional Ballot Envelope using that information.

PROBLEMS & SOLUTIONS

A voter presents an EXPIRED Ohio Driver's License as a photo ID for voting on Election Day:

Inform the voter that the expired Ohio Driver's License cannot be used for voting, and ask the voter for another photo ID from the list of VALID FORMS OF ID on page 68 of the PEO Training Manual for the March 19 Primary.

The voter is unable to provide a valid photo ID for voting on Election Day:

Follow the steps under the heading IF THE VOTER IS UNABLE TO PROVIDE VALID PHOTO ID OR PROVIDES EXPIRED ID on page 85 of the PEO Training Manual.

Can a PEO serve in any voting location for an election where the PEO is a candidate on the ballot for a precinct or precincts in that location?

No, because R.C. 3501.15 prohibits a PEO from serving in any voting location for an election where the PEO is a candidate on the ballot for a precinct or precincts in that location, except if the PEO is an unopposed candidate for a political party county central committee.


Can a PEO serve in any voting location for an election where the PEO's family member or business associate is a candidate for elected office?

No, a PEO cannot serve in any voting location for an election where the PEO's family member or business associate is a candidate for elected office in a precinct or precincts in that location, unless the candidate is unopposed, including no write-in candidates for the office.

Ohio Secretary of State Frank LaRose and his office recently celebrated a year of @VerifyOhio, a digital

The graduation ceremony took place in January at the Ohio Association of Election Officials (OAEO) Winter Conference. OAEO partners with Ohio State to create a unique continuing education (CE) and certification program for Ohio's election officials. Every six months, election officials may take CE courses geared toward election administration, and become certified upon completing four core courses and four elective courses. To keep certification current, graduates must complete a graduate class every three years.
