

PROPOSED TAX LEVY

SOUTH-WESTERN CITY SCHOOL DISTRICT

AN ADDITIONAL TAX FOR THE BENEFIT OF SOUTH-WESTERN CITY SCHOOL DISTRICT FOR THE PURPOSE OF CURRENT EXPENSES AT A RATE NOT EXCEEDING THREE AND SIXTY-FIVE HUNDREDTHS (3.65) MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO THIRTY-SIX AND ONE-HALF CENTS (\$.365) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR FIVE (5) YEARS.
