limitation, for the benefit of Truro Township (Name of Subdivision)

for the purpose of

PROVIDING AND MAINTAINING FIRE APPARATUS, APPLIANCES, BUILDING, OR SITES THEREFOR, OR SOURCES OF WATER SUPPLY AND MATERIALS THEREFOR, OR THE ESTABLISHMENT AND MAINTENANCE OF LINE OF FIRE ALARM MATERIALS THEREFOR, OR THE ESTABLISHMENT AND MAINTENANCE OF LINES OF FIRE ALARM TELEGRAPH, OR THE PAYMENT OF PERMANENT, PART-TIME, OR VOLUNTEER FIREMEN OR FIRE FIGHTING COMPANIES TO OPERATE THE SAME OR TO PURCHASE AMBULANCE EQUIPMENT, OR TO PROVIDE AMBULANCE OR EMERGENCY MEDICAL SERVICE OPERATED BY THE FIRE DEPARTMENT OR FIRE FIGHTING COMPANY

Said tax being:

a replacement of tax of 4.0 mills

at a rate not exceeding 4.0 mills for each one dollar of valuation, which amounts to \$0.40 for each one hundred dollars of valuation, continuing period of time

- 1. This notice shall be published in a newspaper of general circulation in the subdivision once a week for four consecutive weeks prior to the election, excepting notice of Tax Levy for Memorials shall be published in accordance with provisions of Sec. 345.03 R. C.
