OHIO CAMPAIGN FINANCE REPORT ADDENDUM

Three deposits were incorrectly made to the Grubb for Judge Account. The deposits were in cash and totaled \$1200.00. These funds were legal fees paid to the law firm of McCord & Akamine, L.L.P.

A member of the firm was making deposits without the benefit of deposit slips. As a result, he requested the McCord & Akamine, L.L.P., account number from the bank teller. The account number for the Grubb for Judge Committee was given instead of the McCord & Akamine, L.L.P. account number.

These mistaken deposits are listed in "Statement of Contributions Received" (form 31-A). A check for \$1200.00 will be issued from the Grubb for Judge Committee account to the McCord & Akamine, L.L.P., account to correct this error. This transaction will be reflected on the 2007 annual report, as the correcting check was not issued in 2006.
