Ohio Campaign Finance Report – Addendum

Committee for Cindy Lazarus
Termination Report – July 31, 2009

The “Amount Brought Forward From Last Report” is the amount brought forward from the amended Campaign Finance Report (CFR) that is also being filed today.

The entire history of the Committee’s financial activity (dating back to its inception in 1984) has been audited, and amended CFRs are being filed today.

There remains an over-report of \$20.02 – that is, the 25-year-old chain of CFRs shows that the Committee should have \$20.02. In fact, the Committee has no assets.

The source of this unexplained discrepancy could be activity at any point between 1984 and 2008. The audit (for which Ms. Lazarus expended personal funds) occupied a certified public accountant for over 125 hours and examined all 2,649 bank transactions. It would be unreasonable to expect that further work would identify the source of the \$20.02 over-report.
