4	DIRECTOR ANTHONY: I would like to call
5	the Franklin County Board of Elections meeting to
6	order. I will do the roll call.
7	Kimberly Marinello?
8	BOARD MEMBER MARINELLO: Here.
9	DIRECTOR ANTHONY: Zachary Manifold?
10	BOARD MEMBER MANIFOLD: Here.
11	DIRECTOR ANTHONY: And Douglas Preisse?
12	CHAIRMAN PREISSE: Here.
13	DIRECTOR ANTHONY: And Michael Colley is
14	absent.
15	The first item on the agenda is we had a
16	candidate that passed away unfortunately. He died
17	February the 21st. In your packet of information
18	you'll see his obituary. He was running for the
19	Republican Central Committee seat.
20	And we asked Ron O'Brien's office,
21	Mr. Harold Anderson, to give us an opinion as to what
22	we should do since he died more than five days before
23	the election. And, in your packet, you have attached
24	his the Prosecutor's opinion.

And if you would like to give a little
 more detail, Mr. Anderson.

3 MR. ANDERSON: I think it's relatively 4 self-explanatory. When we face a situation such as 5 this, any votes that are cast for the deceased 6 candidate, after the date of their death, are not 7 counted. And because the death occurred more than 8 five days before the primary, the Board has to take 9 some steps to remove or to provide notice to voters that the person, the candidate, has passed away. 10

11 DIRECTOR ANTHONY: And so, what you have 12 attached is the notices that we'll be -- one that 13 we'll put here on the voting machines and we put them on the voting machines on Election Day; and then a 14 15 notice that we will put into the mail for absentee ballots. And folks requesting an absentee ballot for 16 17 that precinct and that district where Mr. Garbe 18 lived, they will receive this notice only. So it 19 won't go to all voters; it will only go to voters that are in Mr. Garbe's district. 20

And so, in order to make it official, we need several motions and that's before you right now. We have to accept his obituary and, right now, the only obituary was printed in The Columbus Dispatch,
