5	the Franklin County Board of Elections meeting to
6	order. I will do the roll call.
7	Kimberly Marinello?
8	BOARD MEMBER MARINELLO: Here.
9	DIRECTOR ANTHONY: Zachary Manifold?
10	BOARD MEMBER MANIFOLD: Here.
11	DIRECTOR ANTHONY: Douglas Preisse?
12	CHAIRMAN PREISSE: Here.
13	DIRECTOR ANTHONY: And Michael Colley?
14	BOARD MEMBER COLLEY: Here.
15	DIRECTOR ANTHONY: Everybody is here and
16	accounted for.
17	The first item on the agenda is to
18	approve the minutes of the January 25th, January
19	13th, and the February not necessarily in that
20	order February 6th meeting.
21	BOARD MEMBER MARINELLO: Mr. Chairman, I
22	move the Board approve the minutes of the January
23	13th, January 25th, and February 6th, 2012 meetings
24	of the Franklin County Board of Elections as

submitted. 1 2 DIRECTOR ANTHONY: Is there a second? 3 BOARD MEMBER COLLEY: Second. 4 DIRECTOR ANTHONY: All those in favor, 5 say aye. 6 BOARD MEMBERS: Ave. 7 DIRECTOR ANTHONY: And since this is our 8 reorganizational meeting along with our regular 9 meeting, we would like to start with the reorganization of the Franklin County Board of 10 11 Elections, and, to do that, we have to appoint a 12 temporary chair. 13 BOARD MEMBER MANIFOLD: I move that the Board appoint Douglas Preisse as the temporary chair 14 15 of the purpose of reorganization. DIRECTOR ANTHONY: Is there a second? 16 17 BOARD MEMBER COLLEY: Second. 18 DIRECTOR ANTHONY: All those in favor, 19 say aye. 20 BOARD MEMBERS: Aye. 21 DIRECTOR ANTHONY: Then the next item on 22 the agenda would be that we have to appoint a 23 Director and Deputy Director, but in order of the Director, first. 24

1	And I want you all to know that I am
2	interested in serving as the director for the Board
3	of Elections for the next two years. And I do I
4	will do a good job. I think the staff works well
5	with me. And, as you know, we have an election
6	tomorrow and a big election on November 6th. And
7	I and I will certainly I certainly enjoy it and
8	I certainly am requesting that I be reappointed to
9	the position of Director of the Franklin County Board
10	of Elections.
11	BOARD MEMBER MARINELLO: I move that the
12	Board appoint William Anthony as the Director of the
13	Board of Elections at a compensation rate of \$54.4548
14	per hour.
15	BOARD MEMBER MANIFOLD: I'll second.
16	DIRECTOR ANTHONY: All those in favor,
17	say aye.
18	BOARD MEMBERS: Aye.
19	DIRECTOR ANTHONY: And thank you very
20	much. I certainly appreciate it. My one child and
21	my new child on the way loves you.
22	The next item on the agenda would be the
23	appointment of the Deputy Director and that will be
24	Dana Walch.

1	DEPUTY DIRECTOR WALCH: And, as Bill
2	said, I would very much appreciate reappointment.
3	I've enjoyed my two-and-a-half months I've been at
4	the Board so far, and I enjoy it very much and look
5	forward to the election tomorrow and the election in
6	November, and very much request and would be humbled
7	by your support reappointing me as the Deputy
8	Director. I appreciate your support.
9	BOARD MEMBER COLLEY: Mr. Chairman, I
10	move that the Board appoint Dana Walch as the Deputy
11	Director of the Board of Elections at the
12	compensation rate of 54.4448 per hour.
13	BOARD MEMBER MARINELLO: Second.
14	DIRECTOR ANTHONY: All those in favor,
15	say aye.
16	BOARD MEMBERS: Aye.
17	DIRECTOR ANTHONY: And now, I guess Dana
18	and I need to be sworn-in by the Honorable Ron
19	O'Brien.
20	MR. O'BRIEN: And I think we probably
21	should do them separately, sometimes you can do
22	things jointly, but since you're the Director, Bill,
23	why don't you raise your right hand and repeat after

10	perform my duties as the Director of the Franklin
11	County Board of Elections to the best of my
12	abilities."
13	MR. O'BRIEN: He's official.
14	DIRECTOR ANTHONY: Thank you.
15	(Applause.)
16	MR. O'BRIEN: Now we will do Mr. Walch.
17	
18	Thereupon, Dana Walch was sworn-in as
19	follows:

21	"I, Dana Walch, do solemnly swear that I
22	will support the Constitution of the United States of
23	America and the State of Ohio, and will enforce the
24	laws, protect and preserve the records and property

pertaining to elections, and perform my duties as the 1 2 Deputy Director of the Franklin County Board of 3 Elections to the best of my abilities." 4 Thank you very much. 5 (Applause.) 6 BOARD MEMBER MARINELLO: Congratulations, 7 Dana. 8 DIRECTOR ANTHONY: Thank you, Ron. 9 Now we have to appoint a permanent Chair. 10 Is there a motion on the floor to appoint 11 a permanent Chair? 12 BOARD MEMBER COLLEY: Mr. Chairman, I 13 move this Board appoint Douglas Preisse as Chairman of the Board of Elections. 14 15 DIRECTOR ANTHONY: Is there a second? BOARD MEMBER MANIFOLD: I'll second. 16 17 DIRECTOR ANTHONY: All those in favor, 18 say aye. 19 BOARD MEMBERS: Aye. 20 DIRECTOR ANTHONY: The second item on the 21 agenda is we have a new hire, his name is Daniel 22 Brill. We would like to hire him in the position of 23 the CIS. As you know --24 BOARD MEMBER MANIFOLD: GIS.

1	DIRECTOR ANTHONY: CIS is a program.	
2	GIS. We've had an opportunity to sit down and talk	
3	with him and believe he'll do a great job. He brings	
4	a wealth of knowledge and experience for this	
5	position. He will be replacing Matt Shade who	
6	resigned back in December, so we are in need of a	
7	person to do the mapping and other items in that	
8	department.	
9	He's here in the audience this afternoon.	
10	Mr. Brill, let everyone know who you are. Stand up.	
11	Do you want to say anything?	
12	MR. BRILL: Well, I'm looking forward to	
13	working with you all at the Board of Elections and	
14	I'm just happy to be here today.	
15	BOARD MEMBER MARINELLO: Thank you.	
16	DIRECTOR ANTHONY: So we are looking at	
17	him starting tomorrow, March the 6th, and we're going	
18	to pay him, I think it's 37-5 a year. So a motion	
19	would be in order if you guys so approve.	
20	BOARD MEMBER MANIFOLD: Mr. Chairman, I	
21	move that the Board hire Daniel Brill as an employee	
22	of the Board of Elections in the Elections Technology	
23	Department, beginning March 6th, 2012, at a	
24	compensation rate of \$18.0288 per hour.	

1	DIRECTOR ANTHONY: Is there a second?		
2	BOARD MEMBER MARINELLO: Second.		
3	BOARD MEMBER COLLEY: Second.		
4	DIRECTOR ANTHONY: All those in favor,		
5	say aye.		
6	BOARD MEMBERS: Aye.		
7	DIRECTOR ANTHONY: We also have a matter,		
8	as you all recall, three months ago, one of our		
9	employees, James Beier, had he had sugar diabetes		
10	real bad and he had to have part of his right leg		
11	amputated. He since has been on leave without pay		
12	pending his retirement. Some issues came up with his		
13	retirement because he's unable to get a birth		
14	certificate, so, anyway, that's getting worked out.		
15	So he asked me if we could extend him		
16	through the maximum which would be May 22nd, 2012,		
17	and, at that point, he may be gone he may actually		
18	retire before then, but he wasn't sure how much		
19	difficulty that would be for him to get the legal		
20	stuff resolved regarding his retirement application		
21	to OPERS.		
22	Any questions on that?		
23	(No response.)		
24	DIRECTOR ANTHONY: I can get in a little		

1 more detail, but I don't want to get involved in his 2 personal business. 3 BOARD MEMBER MARINELLO: Mr. Chairman, I 4 move that the Board extend the leave-without-pay 5 status of Board employee James Beier until May 22nd, 2012. 6 7 DIRECTOR ANTHONY: Is there a second? 8 BOARD MEMBER COLLEY: Second. 9 DIRECTOR ANTHONY: All those in favor, 10 say aye. 11 BOARD MEMBERS: Ave. 12 DIRECTOR ANTHONY: Motion carries. 13 The next item on the agenda, each year --I mean, not each year, but it is time for us to renew 14 15 our contract with E.E. Ward Moving Company. They're the company that basically hauls all of our election 16 17 DREs and all that equipment and supplies to each of 18 the polling locations each year, and they pick it 19 out -- I mean, they pick it up, they deliver it, and 20 they pick it up and bring it back to the warehouse. 21 They've done an excellent job. 22 We have an opportunity to extend the current contract, so I brought before the Board a 23 request to extend their contract from April 6th, 2012 24

through April 5th, 2013, and it needs a Board action 1 2 if there's no questions. 3 BOARD MEMBER MANIFOLD: Does anybody --4 do we know what the pricing is? Anybody know what it 5 is? It says, "Remains the same." 6 DIRECTOR ANTHONY: It remains the same. 7 I don't know. It's -- I could get that for you if 8 you need. 9 MS. BROWN: You have the contract; it 10 says on there. 11 DIRECTOR ANTHONY: It does? 12 MS. BROWN: The pricing remains the same in the originally approved contract. 13 14 DIRECTOR ANTHONY: So do you need to know 15 what the original contract was? 16 BOARD MEMBER MANIFOLD: No. I was just 17 asking. MS. BROWN: It was approved by the Board 18 in 2010. 19 20 BOARD MEMBER MARINELLO: So they didn't 21 raise it. 22 MS. BROWN: Right. 23 DIRECTOR ANTHONY: No, they didn't raise 24 it.

1 CHAIRMAN PREISSE: I remember looking at 2 it and asking questions more closely at that time, I 3 can't remember what it was, though. I was satisfied 4 with --5 BOARD MEMBER MANIFOLD: Okay. 6 CHAIRMAN PREISSE: -- the scope of work 7 and the experience they've had because they've done 8 it for quite some time with, as I can recall, no 9 problems. 10 BOARD MEMBER MANIFOLD: Sounds good. 11 DIRECTOR ANTHONY: And the contract that 12 we'll be passing around is one that the PFM, they put 13 together for us, they do the bidding for us, so this is -- we asked them that we needed an extension, so 14 15 this is the paperwork that they gave us to allow for that extension. 16 17 Was there a second? 18 BOARD MEMBER MANIFOLD: I have to make 19 the motion. 20 DIRECTOR ANTHONY: Oh, I'm sorry. 21 BOARD MEMBER MANIFOLD: Mr. Chairman, I 22 move that the Board extend the contract of E.E. Ward 23 Moving and Storage Company, LLC, through April 5, 2013, for the transportation of voting machines. 24

17	line, prior to the closing of the polls at 7:30,	
18	shall be permitted to vote.	
19	DIRECTOR ANTHONY: Is there a second?	
20	BOARD MEMBER COLLEY: Second.	
21	DIRECTOR ANTHONY: All those in favor,	
22	say aye.	
23	BOARD MEMBERS: Aye.	
24	DIRECTOR ANTHONY: We will need a motion	

1 to go into recess if there is no further business 2 before the Board. 3 BOARD MEMBER MANIFOLD: Mr. Chairman, I 4 move that the Board recess this meeting of the Board 5 of Elections subject to re-call by the Chair until after the close of the election being held on 6 7 Tuesday, March 6th. 8 DIRECTOR ANTHONY: Is there a second? 9 BOARD MEMBER COLLEY: Second. 10 DIRECTOR ANTHONY: All those in favor, 11 say aye. 12 BOARD MEMBERS: Aye. 13 DIRECTOR ANTHONY: We stand in recess until the call of the Chair. 14 15 (Thereupon, the Franklin County Board of 16 Elections recessed at 3:18 p.m.) 17 18 19 20 21 22 23 24
