16	from \$95 to \$101 a month. For a family it's going
17	from \$95 to \$207.
18	BOARD MEMBER MANIFOLD: 195.
19	DIRECTOR ANTHONY: Yeah, 195. I can't
20	see. So we need to have the Board vote on that. Do
21	you all need more information on it?
22	BOARD MEMBER SINNOTT: We don't have a
23	while lot of discretion over this, do we?
24	DIRECTOR ANTHONY: Well, we no.

1 BOARD MEMBER MANIFOLD: Well, agencies 2 can set their own. 3 DIRECTOR ANTHONY: We can set our own, 4 but it's much easier to do what they're doing. 5 BOARD MEMBER MARINELLO: Mr. Chairman, I 6 move the Board adopt the new standard monthly 7 employee health benefit contribution rate of \$101 per 8 month for employee coverage only, and \$207 per month for family coverage as prescribed by the Franklin 9 County Commissioners for the time period April 1st, 10 2013 through March 31st, 2014. 11 12 DIRECTOR ANTHONY: Is there a second? 13 BOARD MEMBER MANIFOLD: Second. 14 DIRECTOR ANTHONY: All those in favor, 15 say aye. 16 BOARD MEMBERS: Aye. DIRECTOR ANTHONY: And the only thing on 17 18 that for the 101 is for, make sure it's clear for employees with at least one child. Well, what this 19 20 thing says. 21 DEPUTY DIRECTOR WALCH: It's basically 2.2 for an employee without a spouse. 23 DIRECTOR ANTHONY: Yes, exactly right. That's all I had. 24
