1 2 PROCEEDINGS 3 \_ \_ \_ \_ 4 DIRECTOR ANTHONY: Good morning, 5 everyone. 6 BOARD MEMBER SINNOTT: Good morning. 7 DIRECTOR ANTHONY: I would like to call 8 the Board of Elections Special Meeting to order. I 9 will do the roll call. 10 Kimberly Marinello? 11 BOARD MEMBER MARINELLO: Here. 12 DIRECTOR ANTHONY: Gregory Haas? 13 BOARD MEMBER HAAS: Here. 14 DIRECTOR ANTHONY: Douglas Preisse? 15 CHAIRMAN PREISSE: Here. 16 DIRECTOR ANTHONY: Bradley Sinnott? 17 BOARD MEMBER SINNOTT: Here. 18 DIRECTOR ANTHONY: Mr. Chair, we are all 19 here and accounted for and I hope everyone had a 20 Merry Christmas. 21 The first item on the agenda is voter 2.2 registration challenges. 23 BOARD MEMBER SINNOTT: It's actually the 24 only thing on the agenda.

5 1 DIRECTOR ANTHONY: That's the only thing 2 on the agenda. 3 DEPUTY DIRECTOR WALCH: Do we want, 4 Renee, do you want to go first? 5 Ms. Bicking, do you have anything you 6 want to present today or just what you already 7 submitted? 8 MS. BICKING: No. It's whatever I 9 submitted and then, if I need to talk later, I would 10 like to have the opportunity to do so. 11 DEPUTY DIRECTOR WALCH: There are 10 12 voter registration challenges here, so I'll turn it over to Renee Klco, our Voter Services Manager, to 13 tell us what we found on each one. 14 15 MS. KLCO: John Malinky, after he got divorced he moved into his office and registered 16 17 there. He's now in the process of changing his address to Delaware County, so we'll be able to merge 18 19 his voter registration from here to there, so I 20 recommend we do nothing with that until we do the 21 merge. 2.2 Mr. Moreno, he had registered in 2007 at 23 a commercial address, but has never voted. I 24 recommend that we send a letter to him asking for a

1	residential address. If that gets returned to us
2	then we'll let it go through the purge process. And
3	I would recommend the same thing for Darrell Barbery
4	and Dennis Davy.
5	CHAIRMAN PREISSE: Because of the same
6	situation?
7	MS. KLCO: We don't know what the
8	situation is. Sometimes you can't tell by a
9	photograph, but if they do respond to our letters
10	then we can do something more with them. If the
11	letters are returned then we'll let them go through
12	the purge process. They're all inactive now so they
13	should be purged fairly soon.
14	Harold and Karen Ross, they are also
15	registered at a commercial address. Voters are
16	allowed to register in hotels and motels, so I would
17	do nothing with those.
18	CHAIRMAN PREISSE: What is that address?
19	MS. KLCO: It's on Rickenbacker Parkway.
20	DEPUTY DIRECTOR WALCH: It is a it
21	does appear to be a hotel, but voters are permitted
22	to be registered from a hotel address if that is the
23	residence that they claim as their primary residence
24	here in Franklin County.

7 1 MS. KLCO: Robert Ouail and Deborah 2 Mills, their address no longer exists. They haven't 3 voted in quite a while. I would like to restrict the 4 address, put them in a pending status so they can't 5 vote from that address and then let them go through 6 the purge process. 7 Keith Jenkins and Shawn Wright have never 8 voted, that address does not exist, and I'd like to 9 do an administrative purge on those two. 10 DIRECTOR ANTHONY: Can you explain what 11 an administrative purge means for the board members? 12 MS. KLCO: Means I don't have to wait for 13 the purge process, I can just do an administrative 14 purge now. They registered in 2004 and have never 15 voted. 16 CHAIRMAN PREISSE: Well, you said the 17 address does not exist. 18 MS. KLCO: Right. 19 BOARD MEMBER SINNOTT: So the difference 20 between Quail and Mills, and Jenkins and Wright, is 21 that Jenkins and Wright have never voted. 2.2 MS. KLCO: Right. And since the last two 23 were registered in 2004, they should have purged out 24 already, but since they haven't I would like to do an

8 1 administrative purge on that. 2 DEPUTY DIRECTOR WALCH: Do any of the 3 members of the board have a question for Ms. Klco? 4 Or Ms. Bicking, Ms. Carol Bicking is here, who filed 5 the challenges. Do members of the board have 6 questions for either of them? 7 CHAIRMAN PREISSE: I don't. Anyone else? 8 DIRECTOR ANTHONY: Then a motion would be 9 in order to accept the recommendation by Renee Klco. 10 BOARD MEMBER MARINELLO: Mr. Chairman, I 11 move the Board accept the recommendation of the Board 12 of Elections staff listed in Exhibit A, regarding the 13 voter registration challenges filed by Ms. Carol 14 Bicking of 1599 Climbing Fig Drive, Blacklick, Ohio. 15 DIRECTOR ANTHONY: Is there a second? 16 BOARD MEMBER SINNOTT: Second. 17 DIRECTOR ANTHONY: All those in favor say 18 aye. 19 BOARD MEMBERS: Aye. 20 DIRECTOR ANTHONY: Motion carries. 21 DEPUTY DIRECTOR WALCH: That's it. 2.2 DIRECTOR ANTHONY: Unless Ms. Bicking, 23 you wanted to say anything, we stand adjourned. 24 MS. BICKING: Well, I just wanted to say

5	in terms of the addresses on Rickenbacker, I called
6	that Baymont hotel and the person that answered the
7	phone said that somebody is only able to live there

10	there for a while. That's as long as they're allowed
11	to stay there.
12	CHAIRMAN PREISSE: Okay. Interesting.
13	Thank you. Okay.
14	DIRECTOR ANTHONY: Any other
15	CHAIRMAN PREISSE: Move to adjourn.
16	BOARD MEMBER SINNOTT: Second.
17	DIRECTOR ANTHONY: We stand adjourned.
18	All in favor?
19	BOARD MEMBERS: Aye.
20	DIRECTOR ANTHONY: Then we stand
21	adjourned.
