3	MR. ANTHONY: Good afternoon, everyone.	
4	I would like to call the Franklin County Board of	
5	Elections Special Meeting to order.	
6	I will do roll call.	
7	(Roll call taken. Mr. Haas absent.)	
8	MR. ANTHONY: Mr. Chairman, we have a	
9	quorum. The one and only item on the agenda is the	
10	remaking of absentee ballots.	
11	MR. SHELL: Of the original ballots you	
12	gave us the authority to process at our last meeting,	
13	all those that were deemed valid and ready to be	
14	counted were opened, scanned through. Of the 6,700	
15	and however many it was I don't have the number in	
16	front of me. I apologize 161 of those needed to	
17	be remade to be included in the official canvass of	
18	results.	
19	We had a number of them that were what we	
20	traditionally call the "right church, wrong pew" type	
21	situation. They were in the correct polling location	
22	but got a ballot style that was not exactly for their	
23	precinct, but they are in the right location so that	
24	ballot counts. We just have to remake it for those

3 races that they are eligible to cast a vote in. 1 And then there were a few other ones that 2 3 would not process for some of the same reasons we had 4 with absentees. Somehow the ballot got damaged in 5 some way. We did find that there were a few in there 6 that when they got printed, when the ballot got 7 printed, they actually got printed upside down. Ιt 8 is all right, the ballot is all correct and 9 everything, but it was printed upside down, so when it goes through the reader, the reader won't read it 10 right. It's a valid ballot. It's all okay and 11 12 everything printed on it. It was okay. 13 MS. MARINELLO: Only one like that? 14 MR. SHELL: No. There were a few, I don't remember the exact number, that were upside 15 down ballots. 16 17 CHAIRMAN PREISSE: Tell the vendor. 18 MR. SHELL: We're the vendor, so duly 19 noted, Mr. Chairman. 20 Again, the ballot was correct. It just 21 was the wrong way on the paper for it to be able to 2.2 go through the reader, so we will have a bipartisan 23 staff go ahead and put it the right way so it can go 24 through the reader.

4 Then we have one ballot that is not 1 2 included in the 161 that we are asking you to be able 3 to be remade. We have one that we want you to take a 4 look at that was indeterminate on some marking for 5 the approval of the Board to agree and count that 6 one. 7 The first thing is the 161 that are 8 If you have any questions. there. 9 CHAIRMAN PREISSE: I don't have any That was a good description. 10 questions. 11 MS. MARINELLO: I move that the Board 12 authorize the staff remake 161 provisional ballots 13 and that these remade ballots shall be tabulated and included in the official canvass results for the 2014 14 General Election. 15 16 MR. SINNOTT: Second. 17 MR. ANTHONY: All those in favor say aye. 18 (Vote taken; motion passes.) MR. ANTHONY: Motion carries. 19 20 MR. SHELL: There is one additional 21 provisional ballot that the bipartisan staff had a 2.2 little trouble determining voter intent. 23 CHAIRMAN PREISSE: Is this with regard 24 to, I assume, the squiggle marks that are made on

the other ones? 1 2 MR. SHELL: The machine stopped it as an 3 overvote, which is why we even looked at it. When 4 they started looking at it, they noticed there were 5 some squiggly lines, but then the person was 6 consistent pretty much through most of their marking 7 of the ballot. 8 If you see on a few of the races, there 9 are two candidates marked in the same race, but then on a few of them there are, for lack of a technical 10 11 term, squiggle marks through them. 12 CHAIRMAN PREISSE: So the question is if 13 we can determine voter intent in these four races. 14 All the rest would count. 15 MR. SHELL: You might check the back, 16 too, Mr. Chairman. I don't know if there is anything 17 on the back that is similar to it or not. 18 CHAIRMAN PREISSE: Does not appear to my 19 eye to be. 20 MR. SHELL: Yes, the question before the 21 Board is are those overvotes, or do you want to 2.2 accept them for the markings that do not have the 23 aforementioned, the previously mentioned, squiggle 24 marks.

6 1 MR. SINNOTT: I think we would be 2 referring to this as No. 15. I will put that for 3 reference here in the corner. 4 CHAIRMAN PREISSE: Very good. Do you 5 have an opinion? 6 MR. SINNOTT: I think I know what the 7 voter was trying to do. 8 CHAIRMAN PREISSE: I think I do, too. MS. MARINELLO: Well, so you think --9 10 CHAIRMAN PREISSE: There's a consistency 11 in the voter's intent. 12 MR. SINNOTT: I think this one had a hard 13 time following the zip card. 14 CHAIRMAN PREISSE: This is the strongest indication of that. 15 16 MR. SINNOTT: Well, if we are trying to 17 recognize voter intent. 18 CHAIRMAN PREISSE: I believe I recognize voter intent. 19 MR. SINNOTT: Yes. 20 21 CHAIRMAN PREISSE: I would say we 2.2 recognize the voter's attempt to unvote and then 23 vote. MS. MARINELLO: Yes. 24

2	marked No. 15, as the Board members having had an
3	opportunity to inspect it, I will move that the
4	ballot be counted, and in instances where there are
5	double markings in particular races, that this ballot
6	be interpreted as a vote for Tom Letson, John
7	O'Donnell, Chris Brown, and Monica Hawkins.
8	MS. MARINELLO: I second.
9	MR. ANTHONY: All those in favor say aye.
10	(Vote taken; motion passes.)
11	MR. ANTHONY: Motion carries.
12	That concludes the business of the Board
13	today. Is there a motion to adjourn?
14	MS. MARINELLO: So moved.
15	MR. SINNOTT: Second.
16	MR. ANTHONY: All those in favor say aye.
17	(Vote taken; motion passes.)
18	(The meeting adjourned at 3:22 p.m.)
