1 Wednesday Afternoon Session, 2 December 23, 2015. 3 4 DIRECTOR ANTHONY: I'd like to call the 5 Franklin County Board of Elections Special Meeting to 6 order. I will do roll call. 7 Kimberly Marinello. 8 MS. MARINELLO: Here. 9 DIRECTOR ANTHONY: Gregory Haas. 10 MR. HAAS: Here. 11 DIRECTOR ANTHONY: Doug Preisse. 12 CHAIRMAN PREISSE: Here. 13 DIRECTOR ANTHONY: And Brad Sinnott. 14 MR. SINNOTT: Here. 15 DIRECTOR ANTHONY: Mr. Chairman, we have 16 a quorum. Everyone is present. 17 The first item on the agenda would be the 18 approval of the minutes from the November 2, 2015 19 meeting, the November 17, 2015 meeting, the 20 November 19, 2015 meeting, and the November 23, 2015 21 meeting. 2.2 MR. HAAS: I move that the Board approve 23 the minutes of the November 2, 2015, November 17, 24 2015, November 19, 2015, and the November 23, 2015

meetings of the Franklin County Board of Elections as 1 2 submitted. 3 DIRECTOR ANTHONY: Is there a second? 4 CHAIRMAN PREISSE: Second. 5 All those in favor? 6 (Vote taken; motion passes.) 7 DIRECTOR ANTHONY: We will move on to 8 Exhibit B in our agenda, and that's the certificate 9 or denial of issues and options for the March 26 10 ballot. 11 Carla, do you want to go over these? 12 MS. PATTON: The front of Exhibit B will 13 state the Revised Code sections which stipulates the 14 requirements for candidates to sign the Declaration 15 of Candidacy prior to circulation and also the fact 16 that the Circulator Statement must be completely 17 filled in. 18 The candidates that appear within this 19 exhibit have all failed to either sign their 20 Declaration of Candidacy, completely fill out the 21 Circulator Statement or failed to collect the number 2.2 of valid signatures that were required to make the 23 ballot. 24 The reason is listed under each

1	candidate, so it would be our recommendation that
2	these candidates not be certified to the ballot.
3	There were also a couple filings for
4	offices that do not exist, for example, Urbancrest
5	County Central Committee and Obetz Central Committee
6	do not exist. I believe we had a State Central
7	Committee that was also filed, which is not on the
8	ballot for this election.
9	CHAIRMAN PREISSE: I think I've asked
10	this question repeatedly and I should remember the
11	answer, but do we notify these folks that this has
12	happened?
13	MS. PATTON: They will receive a notice.
14	CHAIRMAN PREISSE: But not in advance?
15	MS. PATTON: Not in advance, no. I
16	believe these filings were all taken in on the last
17	day of filing; therefore, it was done so without the
18	advanced knowledge that these were not actual seats.
19	MR. SINNOTT: What is the process after
20	that? A candidate being disqualified from the ballot
21	says, Oh, no, you misunderstand. This is what's
22	true. What happens? What's the candidate's relief?
23	MS. PATTON: For County Central Committee
24	I believe they are permitted to file as a write-in

for the valid office or for the office they failed to 1 2 make the ballot for. 3 MR. SINNOTT: That is not my question. 4 It is more for the lawyers. 5 MR. SOULAS: There is a protest 6 proceeding, and I think Tim calculated it is 75 days 7 prior to the election, so there is a process for them 8 to come before the Board and explain why they think 9 the result should be different. 10 MR. SINNOTT: So there is a protest that 11 is registered? 12 MR. SOULAS: Yes. 13 DIRECTOR ANTHONY: If we did that, we 14 would hear the protest? Or who would hear that 15 protest? 16 MR. SOULAS: The Board. 17 DIRECTOR ANTHONY: The Board would hear 18 that protest? 19 MR. SOULAS: Yes. 20 DIRECTOR ANTHONY: So it has to happen 21 74 days before the election? 2.2 MR. LECKLIDER: The protest has to be 23 filed 74 days before the election. 24 DIRECTOR ANTHONY: Okay.

MR. LECKLIDER: Which falls on January 1. 1 2 DIRECTOR ANTHONY: We would have a 3 meeting within so many days? 4 MR. SOULAS: The statute does not specify 5 a specific number of days. 6 DIRECTOR ANTHONY: Can we direct them to 7 go directly and file with the court? 8 MR. SOULAS: No. They need to be given 9 the opportunity to develop the record before the 10 Board. 11 DIRECTOR ANTHONY: All right. So then we 12 would have a hearing either to deny their protest or 13 uphold the protest? 14 MR. SOULAS: Correct. 15 MR. LECKLIDER: Mr. Director, what the 16 language of the statute specifically states is: Upon 17 filing the protest, the election officials shall 18 promptly fix the time for hearing it and shall 19 forthwith mail notice of the filing of the protest 20 and the time fixed for hearing to the person whose 21 candidacy is so protesting. 2.2 DIRECTOR ANTHONY: Okay. That answers my 23 questions. Thank you, sir. 24 So did everybody get a chance to review

the names on this list? Any questions or discussion 1 2 on it? 3 MR. SINNOTT: I move that the Board deny 4 certification to the candidates appearing on 5 Exhibit B on the basis that their petitions were 6 either not filed timely or found by staff to be 7 invalid or insufficient and that these candidates 8 will not appear on the March 15, 2016 Primary 9 Election ballot. 10 DIRECTOR ANTHONY: Is there a second? 11 MS. MARINELLO: Second. 12 DIRECTOR ANTHONY: All those in favor? 13 (Vote taken; motion passes.) DIRECTOR ANTHONY: Motion carries. We 14 15 will so notify all the folks on the list and give 16 them the appropriate information. 17 MS. PATTON: It will be in the mail this 18 evening. 19 DIRECTOR ANTHONY: Thank you. 20 MR. SINNOTT: Thank you. 21 DIRECTOR ANTHONY: Go to Exhibit C, the 22 questions and issues recommended for the ballot. 23 MS. PATTON: On Exhibit C there were five 24 tax-related issues that were filed timely. They have

been reviewed, and they are sufficient to, as far as 1 2 we're concerned, be approved to the ballot. 3 In addition to the tax-related issues, 4 there were also six local option filings for a total 5 of nine questions that the staff has reviewed the 6 signatures, and they have met all the requirements of 7 the required number of valid signatures, and the 8 petitions were properly filled out and filed on time. 9 Therefore, we are recommending that all issues on 10 Exhibit C be ordered to the ballot. 11 DIRECTOR ANTHONY: Any questions on C? 12 MR. HAAS: I move that the Board certify 13 to the March 15, 2016 Primary Election ballot those 14 issues listed on Exhibit C and that these issues were 15 filed timely and found to be valid and sufficient. 16 DIRECTOR ANTHONY: Is there a second? 17 MR. SINNOTT: There is. 18 DIRECTOR ANTHONY: All those in favor? 19 (Vote taken; motion passes.) 20 DIRECTOR ANTHONY: The motion carries. 21 We will move on to Exhibit D, if you 2.2 would, Carla. 23 MS. PATTON: Exhibit D we had three local 24 option filings that did not meet the minimum number

of required signatures required to make it to the 1 2 ballot. Those three petitions contained a total of 3 five questions, so it is our recommendation it not be 4 certified for the Primary Election ballot. 5 MS. MARINELLO: I move that the Board 6 deny certification to the issues appearing on Exhibit 7 D on the basis that their petitions were either not 8 filed timely or found by staff to be invalid or 9 insufficient and these issues will not appear on the 10 March 15, 2016 Primary Election ballot. 11 DIRECTOR ANTHONY: Is there a second? 12 CHAIRMAN PREISSE: Second. DIRECTOR ANTHONY: All those in favor? 13 14 (Vote taken; motion passes.) 15 DIRECTOR ANTHONY: That motion carries as 16 well. Go back to Exhibit A. Is there a new 17 18 Exhibit A? 19 MR. MACKEY: I have given the court 20 reporter the official Exhibit A that excludes 21 Mr. Preisse and Ms. Marinello so we can handle them 22 separately. 23 MS. MARINELLO: So I can make the motion? 24 DIRECTOR ANTHONY: Yes.

MARINELLO: I move that the Board 1 2 certify to the March 15, 2016 Primary Election ballot those candidates listed on Exhibit A and that these 3 4 petitions were filed timely and found to be valid and 5 sufficient. 6 MR. SINNOTT: Second. 7 DIRECTOR ANTHONY: All those in favor? 8 (Vote taken; motion passes.) DIRECTOR ANTHONY: Motion carries. 9 10 What is the next motion? 11 MR. SINNOTT: You're saying you have 12 removed Ms. Marinello and Mr. Preisse from Exhibit A? 13 MR. SOULAS: So they will be handled 14 separately. 15 MR. SINNOTT: All right. Then I move 16 that the Board certify to the March 15, 2016 primary 17 Election ballot Kimberly Marinello and Douglas 18 Preisse for the offices that they are seeking, and 19 that these petitions were filed timely and found to 20 be valid and sufficient. 21 MR. SOULAS: May I recommend you do each 22 individually? That way you can have a majority vote. 23 Do one at a time. 24 MR. SINNOTT: Okay. I move that the

13 Board certify to the March 15, 2016, Primary Election 1 2 Ballot Kimberly Marinello for the office of 3 Democratic Central Committee and that the petition be 4 found timely filed, valid, and sufficient. 5 DIRECTOR ANTHONY: I will do roll call. 6 MR. HAAS: Second. 7 DIRECTOR ANTHONY: It has been moved and 8 seconded. I will do a roll call. 9 Kimberly Marinello. 10 MS. MARINELLO: Abstain. 11 DIRECTOR ANTHONY: Greg Haas. 12 MR. HAAS: Yes. 13 DIRECTOR ANTHONY: Doug Preisse. 14 CHAIRMAN PREISSE: Yes. 15 DIRECTOR ANTHONY: Brad Sinnott. 16 MR. SINNOTT: Yes. 17 CHAIRMAN PREISSE: Motion carries. 18 MR. SINNOTT: I move the Board certify to 19 the March 15, 2016, Primary Election ballot Douglas 20 Preisse for the Office of State Senate, which has 21 been filed and that the petition be found timely 2.2 filed and valid and sufficient. 23 DIRECTOR ANTHONY: Is there a second? 24 MR. HAAS: Second.

13	withdraw prior to certification. We will let you

15	Jeff, do you have the list?
16	MR. MACKEY: Aaron Schlabach.
17	DIRECTOR ANTHONY: He was a candidate for
18	the 23rd District Senate.
19	MR. PAYNE: He was running for the
20	Statehouse.
21	DIRECTOR ANTHONY: Cheryl Grossman
22	withdrew as a candidate for State Senate in the 16th
23	District.
24	Bruce Bailey withdrew as a candidate for

Republican Central Committee, Westerville Ward 2. 1 2 And Rebecca Hutson withdrew as a 3 candidate for the Democratic Central Committee, 4 Groveport. 5 And their names shall not be on the 6 ballot in March. 7 MS. MARINELLO: I move that the Board 8 accept the requests of Aaron C. Schlabach to withdraw 9 as candidate for State Representative in the 23rd 10 District; Cheryl L. Grossman to withdraw as candidate 11 for State Senate in the 16th District; Bruce Bailey 12 to withdraw as candidate for the Republican Central 13 Committee, Westerville, Ward 2; and Rebecca Hutson to 14 withdraw as candidate for the Democratic Central 15 Committee, Groveport, and that their names shall not 16 appear on the March 15, 2016 Primary Election ballot. 17 DIRECTOR ANTHONY: Is there a second? 18 CHAIRMAN PREISSE: Second. 19 DIRECTOR ANTHONY: All those in favor? 20 (Vote taken; motion passes.) 21 CHAIRMAN PREISSE: That motion carries as 2.2 well. 23 The next item we have to do is the 24 Election Administration Plan during the Presidential

1	cycle. I want to go on the record that David Payne
2	did one heck of a job coordinating this for us, and
3	we have to do one in the primary and we have to do
4	another one right before the General Election.
5	You have the document before you. We
6	need you all to sign it, and then we will give this
7	to the Secretary of State's Office. This plan says
8	how we are going to do the election step by step,
9	every aspect of election.
10	MR. PAYNE: The Secretary of State sends
11	out a template and then our staff simply fills it in.
12	There are ten categories: Precinct Election Official
13	Recruitment, Training, and Accountability. That was
14	basically Steve Bulen.
15	There's Resource Allocation, paper
16	ballots, machine allocation. There's Election Day
17	Communications; Materials and Supplies, Election Day
18	Contingencies, meaning if our folks don't show up,
19	what do we do, if we are short on equipment what do
20	we do.
21	There's Security, and they're both here
22	at our early vote center as well as all of our
23	polling locations; Voter Registration, which is mail
24	processing and keying by hand, entering, scanning

1	absentee ballots, everything we need that goes with
2	the polling places, accessibility, which is ADA
3	requirements. And then there is a Master Calendar
4	that basically shows, for the most part, everything
5	we do at the Board of Elections that requires a
6	date-specific start and a date-specific end.
7	So I believe that Suzanne e-mailed the
8	plan to all of you. You have a hard copy in front of
9	you. I don't know if there are any questions you
10	might have. This is due to the Secretary of State, I
11	believe, the 15th of January.
12	MR. SINNOTT: Is there anything in the
13	136-page document you want to draw to our attention
14	in particular?
15	MR. PAYNE: I don't necessarily think so,
16	but if there is anything in these categories you are
17	concerned about. Obviously, we have reference to the
18	electronic pollbooks that will be, hopefully,
19	implemented in March.
20	Part of our training guide has not been
21	updated yet, so we have to do an amendment to this at
22	some point once we get all of our training and all of
23	our training materials together. That's probably the
24	newest thing that we have, are the electronic

1 pollbooks. 2 CHAIRMAN PREISSE: Just thumbing through 3 some of Plan A and B for emergency communications and 4 power loss, there is reference to the sheriff. What 5 happens on election day vis-a-vis the Board's interface with the Sheriff's Office? 6 7 MR. PAYNE: For one thing, the sheriffs 8 are actually here. 9 CHAIRMAN PREISSE: Out in the field. 10 They don't staff anyplace? 11 MR. PAYNE: No. 12 CHAIRMAN PREISSE: It say the PEOs are 13 instructed to call the Sheriff's Office directly. 14 DIRECTOR ANTHONY: That's correct. 15 MR. PAYNE: Depending on --CHAIRMAN PREISSE: How is that 16 17 communicated in training sessions with our PEOs? MR. PAYNE: Steve, do you want to address 18 19 that, how we train our PEOs in case of an emergency 20 out in the polling location? 21 MR. BULEN: We review that in our voting 2.2 location manager training, and it's printed in the 23 manual in two separate places. One of them is 24 prevalent, right on the back of the manual, the

1	Sheriff's Office phone number for emergencies.	
2	MR. PAYNE: One of the things, I think	
3	maybe the reason you're asking that, because there's	
4	a heightened sense of security. One of the things	
5	that Steve and I talked about is making a special	
6	emphasis about security, and if anybody has any	
7	questions, any concerns, they need to address those	
8	quickly so we'll have staff here. The Sheriff's	
9	Office is actually here.	
10	CHAIRMAN PREISSE: The number that staff	
11	has printed on the manual, is that a general number	
12	to the Sheriff's Office, or is there a specific	
13	number?	
14	MR. BULEN: It's the general number to	
15	the Sheriff's Office.	
16	DIRECTOR ANTHONY: What we've done in the	
17	past, they escalate the calls if it comes from a	
18	Board of Elections official.	
19	CHAIRMAN PREISSE: Did you say	
20	"escalate"?	
21	DIRECTOR ANTHONY: If the call is from	
22	and they say it's Board related, it's handled as a	
23	priority. And these are things that we we have a	
24	security meeting with the Sheriff's Department prior

1	to every election, and we are ready for the March	
2	election. They do have a command they do have a	
3	person here at our Board. If those calls come in,	
4	their switchboard is told those calls are taken	
5	priority. They send out the dispatch. The sheriff	
6	crews are right there.	
7	CHAIRMAN PREISSE: But the number goes to	
8	the sheriff, not here.	
9	DIRECTOR ANTHONY: Right.	
10	CHAIRMAN PREISSE: That is given to the	
11	PEOs.	
12	DIRECTOR ANTHONY: It's the sheriffs	
13	number, not a number here. We don't act as a buffer	
14	or middle person. It goes directly to the Sheriff's	
15	Office.	
16	CHAIRMAN PREISSE: This seems far afield,	
17	but I will ask it. This occurs to me now. What	
18	concealed carry provisions cover this facility and	
19	any other voting facility? I have no idea.	
20	DIRECTOR ANTHONY: Most of the places,	
21	they have a sign out. Most of the places, our voting	
22	locations, are places where you cannot do the conceal	
23	and carry. I mean, we've never had that incident	
24	happen that I can recall with somebody.	

1 MR. PAYNE: Steve, do you know about the 2 polling locations themselves as it relates to 3 concealed carry? 4 MR. BULEN: Not on an individual basis, 5 but as the director said, most of them are public 6 facilities, schools, churches, those type of things, and they have a policy of no concealed handguns 7 8 allowed in the building. 9 MR. PAYNE: There's no signage that we 10 have that would either --11 DIRECTOR ANTHONY: We don't add 12 additional signage. We do not. Most facilities, 13 since they are public facilities, they already have 14 "no firearms," similar to what we have on ours. 15 MR. PAYNE: I will mention, if there are 16 concerns of the Board on any of these, we do have the 17 ability to amend this report, so if you see something 18 that relates to security or any other matter you 19 think we need to update or do differently, we can 20 certainly do that. 21 DIRECTOR ANTHONY: I will make sure, have 22 our guys double-check all the sites and see what they 23 do have. 24 CHAIRMAN PREISSE: Just a question that

occurred to me because we were talking about the 1 2 sheriff. 3 DIRECTOR ANTHONY: We will follow up on 4 that one, sir. 5 MR. HAAS: I move that the Board accept 6 the 2016 Primary Election Administration Plan and 7 authorize staff to send it to the Secretary of State 8 in conformance with the Secretary of State's 9 directive 2014-16. 10 DIRECTOR ANTHONY: Is there a second? 11 MR. SINNOTT: There is. 12 MR. LECKLIDER: The directive, it's in 13 conformance with directive 2015-23. 14 MR. PAYNE: Yes, I'm sorry. So the 15 motion should actually say directive 2015-23. 16 MR. SINNOTT: That's the way I already 17 understood the motion, Greg. 18 MR. HAAS: I move that the Board accept 19 the 2016 Primary Election Administration Plan and 20 authorize staff to send it to the Secretary of State 21 in conformance with the Secretary of State's 2.2 directive 2015-23. 23 MR. SINNOTT: Second. 24 DIRECTOR ANTHONY: All those in favor?
