1 Monday Afternoon Session,  
2 November 7, 2016.

3 - - -

4 DEPUTY DIRECTOR PAYNE: It looks like we  
5 have a quorum. I will take roll.

6 Kim Marinello.

7 MEMBER MARINELLO: Here.

8 DEPUTY DIRECTOR PAYNE: Greg Haas.

9 MEMBER HAAS: Here.

10 DEPUTY DIRECTOR PAYNE: Doug Preisse.

11 CHAIRMAN PREISSE: Here.

12 DEPUTY DIRECTOR PAYNE: Brad Sinnott.

13 MEMBER SINNOTT: Here.

14 DEPUTY DIRECTOR PAYNE: All members are  
15 accounted for.

16 The first item on the agenda is the  
17 approval of minutes. We have minutes from  
18 September 6 and September 22 that were sent to you.  
19 Unless there are any corrections, I would be looking  
20 for a motion to approve those minutes.

21 MEMBER MARINELLO: Mr. Chairman, I move  
22 that the Board approve the minutes of the  
23 September 6, 2016, and September 22, 2016, meetings  
24 of the Franklin County Board of Elections as

1 submitted.

2 MEMBER SINNOTT: Second.

3 DEPUTY DIRECTOR PAYNE: All in favor  
4 signify by saying aye. All those opposed same sign.

5 Motion carries.

6 The next item is paper ballot allocation  
7 for the November 8 General Election. This is the  
8 same paper ballot allocation that you've approved  
9 twice. We are required to approve it twice. A  
10 directive came out since our last meeting that said  
11 in addition to approving it twice, one time has to be  
12 within 30 days of the election. So we are going to  
13 approve this paper ballot allocation for yet a third  
14 time.

15 And, Carolyn, do you have any comments on  
16 this paper ballot allocation?

17 MS. GORUP: No. It's the same numbers  
18 you saw before.

19 DEPUTY DIRECTOR PAYNE: And our  
20 requirements are what?

21 MS. GORUP: The requirements as of the  
22 most recent was that we did 20 percent more than the  
23 provisional ballots in the largest of '08 or '12 and  
24 15 percent of the votes in the location.

1           DEPUTY DIRECTOR PAYNE: And so just to --  
2 this is the same paper ballot allocation that they  
3 have approved?

4           MS. GORUP: Same paper -- we exceeded  
5 those requirements when we originally did it, so  
6 we're all good.

7           DIRECTOR LEONARD: Yeah. It's typically  
8 required that one of the two approvals occur within  
9 30 days, and the last one was not within 30 days.

10          DEPUTY DIRECTOR PAYNE: Was not within 30  
11 days and we will be doing it a third time. I would  
12 be looking for a motion if somebody was so inclined.

13          MEMBER MARINELLO: I move that the Board  
14 adopt the paper ballot allocation formula in Exhibit  
15 A compiled by the Board staff for the November 8,  
16 2016, General Election.

17          CHAIRMAN PREISSE: Second.

18          DEPUTY DIRECTOR PAYNE: All those in  
19 favor signify by saying aye. All those opposed same  
20 sign.

21                   Motion carries.

22                   The next item is voting machine  
23 allocation. Again, we have to do that for a third  
24 time, although on this one our -- we did have one

1 location that we are changing the machine allocation  
2 and that's at the Ohio Union. Previously we had 29  
3 machines allocated for the Ohio Union, and we've gone  
4 to add 5 more, so the new allocation is 34 machines,  
5 an increase of 5. Just so you know, we had 18  
6 machines sitting back in case we have to replace a  
7 machine at a polling location. With taking 5 way, we  
8 will now have 13 machines in reserve.

9           DIRECTOR LEONARD: The allocation  
10 requirement, in order to meet the Secretary of  
11 State's requirements of machine allocation to  
12 registered voters, because of the increase in voter  
13 registration before the cutoff -- before the  
14 registration deadline, that increase of registration  
15 required that there be an additional number of  
16 machines allocated to that particular location in  
17 order to comply with the Secretary of State  
18 requirement.

19           DEPUTY DIRECTOR PAYNE: And the  
20 requirement is one machine per 175 active voters.

21           MEMBER HAAS: I move that the Board adopt  
22 the voting machine allocation formula in Exhibit B  
23 compiled by the Board staff for the November 8, 2016,  
24 General Election.

1 MEMBER MARINELLO: Second.

2 DEPUTY DIRECTOR PAYNE: All those in  
3 favor signify by saying aye. All those opposed same  
4 sign.

5 Motion carries.

6 The remaking of absentee ballots. So we  
7 have been -- the staff has been going through opening  
8 the ballots and separating them from the envelopes.  
9 We have 38 ballots that have either rips or tears or  
10 water. At any rate they will not go through our  
11 optical scan machine, so we need authorization from  
12 the Board to remake 38 ballots. If you want to take  
13 a look at some of those, that's fine.

14 CHAIRMAN PREISSE: Is there a -- what has  
15 happened to these ballots to this point and are you  
16 handing these to us with some kind of recommendation  
17 from --

18 DEPUTY DIRECTOR PAYNE: I am just asking  
19 for authorization to remake these ballots because  
20 they won't run through the optical scan machines.

21 DIRECTOR LEONARD: Yes. They were  
22 damaged in some way, shape, or form in the delivery  
23 to the Board of Elections and, therefore, whether  
24 they had water damage, some of them again were placed



1 in the envelopes and they had tears, and other damage  
2 that made them incapable of being processed.

3 MEMBER SINNOTT: So this is the situation  
4 of bipartisan staff meets, they reach a decision if  
5 they can about what the voter's intent was, and then  
6 they recreate a ballot in each instance based on the  
7 points they can agree. If there is disagreement, it  
8 comes to us.

9 DEPUTY DIRECTOR PAYNE: That is correct.

10 DIRECTOR LEONARD: These ballots are not  
11 an issue of the voter intent. They are simply that  
12 they are damaged to the point where they can't be  
13 read by the machine; and, therefore, someone will  
14 re -- a Democrat and Republican will together remake  
15 the ballot so it is in a form that can be read by the  
16 machine.

17 DEPUTY DIRECTOR PAYNE: If you agree  
18 those indeed should be remade, I would be looking for  
19 a motion.

20 MEMBER HAAS: I move that the Board  
21 authorize the staff to remake 38 absentee paper  
22 ballots and that these remade ballots shall be  
23 tabulated and included in the unofficial canvass on  
24 election night.

1 DEPUTY DIRECTOR PAYNE: All those in  
2 favor signify by saying aye.

3 CHAIRMAN PREISSE: Second.

4 DEPUTY DIRECTOR PAYNE: I'm sorry. I'm  
5 looking for a second.

6 CHAIRMAN PREISSE: Second.

7 DEPUTY DIRECTOR PAYNE: All those in  
8 favor signify by saying aye. All those opposed.

9 Motion carries.

10 We are looking for a motion to open the  
11 polls tomorrow at 6:30 a.m. and closing tomorrow  
12 evening at 7:30, recognizing that anybody in line  
13 before 7:30 will be permitted to vote.

14 MEMBER MARINELLO: I move that the polls  
15 be declared open for the Tuesday, November 8, 2016,  
16 General Election beginning at 6:30 a.m. and closing  
17 at 7:30 p.m. and that in accordance with Ohio Revised  
18 Code Section 3501.32, any voter in line prior to the  
19 close of polls at 7:30 p.m. shall be permitted to  
20 vote.

21 CHAIRMAN PREISSE: Second.

22 DEPUTY DIRECTOR PAYNE: All those in  
23 favor signify by saying aye. All those opposed same  
24 sign.

1 Motion carries.

2 Just prior to going to the motion for  
3 recess, I did want to mention that so far we've had a  
4 fantastic turnout here at the Early Vote Center.  
5 We've had over 80,000 Franklin County voters come  
6 through our Early Vote Center. We've had an  
7 additional 151,000 registered Franklin County voters  
8 request an absentee ballot.

9 So our Early Vote Center is far and away  
10 the most successful Early Vote Center of any of the  
11 88 counties. I talked to Cuyahoga County last night,  
12 and they had 39,000 compared to our 80,000 going into  
13 the Early Vote Center so.

14 DIRECTOR LEONARD: So we -- again, the  
15 reaction we got from many voters has been  
16 resoundingly positive. As I told the staff, David  
17 and I spoke before the staff yesterday morning of the  
18 Early Vote Center, just commended them because they  
19 are the face of the Franklin County Board of  
20 Elections to all these voters who are coming in.  
21 They have been doing a tremendous job of, you know,  
22 giving everybody great quality customer service,  
23 smile on their face, a voice of reassurance, and  
24 helpfulness to our voters. They have done really a

1 great job of doing the Board of Elections proud as we  
2 represent to the rest of the voters who come here.

3 DEPUTY DIRECTOR PAYNE: And our wait  
4 times are considerably better than other counties and  
5 part of that reason -- well, a large part of that  
6 reason is we had Professor Ted Allen from the Ohio  
7 State University come in here with two students doing  
8 an analysis of where to put the machines, where to  
9 put the tables, how to queue people, the fact that we  
10 give them the forms outside that they can fill so  
11 there's no backlogs. And literally it's the same  
12 formula that they use at Disney World to queue  
13 people, and it's been -- the help has been  
14 immeasurable. Again, I just wanted to mention.

15 CHAIRMAN PREISSE: I have had many  
16 comments, all positive, from various people that  
17 chose to contact me so.

18 MEMBER HAAS: Same here.

19 DIRECTOR LEONARD: Pass those along.

20 MEMBER SINNOTT: Before we recess what's  
21 the best guess when we will be needed later this  
22 month?

23 DEPUTY DIRECTOR PAYNE: Well, I mean, we  
24 have got to go through the provisional ballots. It

1 really will determine how many provisional ballots we  
2 have. That's going to be -- if it's 30,000, we can  
3 probably get done somewhere around Thanksgiving. We  
4 have to have a meeting before the 29th to certify, so  
5 I'll know better frankly tomorrow after I know how  
6 many provisional ballots.

7 MEMBER SINNOTT: So at least one other  
8 meeting before the 29th of November.

9 DIRECTOR LEONARD: Yes.

10 DEPUTY DIRECTOR PAYNE: That's correct.

11 MS. BROWN: There will need to be two.  
12 Confirm remakes and then we have to -- you have to  
13 allow us to open them so there will have to be two  
14 before certification.

15 DEPUTY DIRECTOR PAYNE: You have given us  
16 the authorization.

17 MS. BROWN: Because there will be so many  
18 to open, I mean, I guess you could recess for a  
19 couple -- five or six hours until we open them but.

20 MEMBER SINNOTT: Didn't we have a better  
21 design for this in a recent time to allow for only a  
22 single meeting though?

23 DEPUTY DIRECTOR PAYNE: Correct, yeah.  
24 You've given us the authorization to, but it does

1 have to be the --

2 CHAIRMAN PREISSE: Well, wait a minute.  
3 Let's play that out.

4 MEMBER SINNOTT: Go ahead.

5 DEPUTY DIRECTOR PAYNE: So what Suzanne  
6 is saying you give us the authorization to open and  
7 remake any of those ballots that are necessary to be  
8 remade.

9 MEMBER SINNOTT: That reduces the two  
10 meetings down to one.

11 MS. BROWN: But there will be remakes on  
12 those as well.

13 DEPUTY DIRECTOR PAYNE: As well.

14 MS. BROWN: Once we open them and scan  
15 them there will be remakes on those.

16 DEPUTY DIRECTOR PAYNE: In the past they  
17 have given us the authorization to go ahead and  
18 remake them.

19 MS. BROWN: Remake them?

20 MEMBER SINNOTT: Okay. Let us find the  
21 motions that we have made in the past.

22 DIRECTOR LEONARD: We will look at that.  
23 Again, obviously we want to accommodate to ensure in  
24 such a way that minimizes the number of meetings that

1 we need to have, and we will let you know as soon as  
 2 we can when we anticipate those meetings need to take  
 3 place.

4 MEMBER SINNOTT: I move that the Board  
 5 recess this meeting of the Board of Elections,  
 6 subject to recall by the Chair, until after the close  
 7 of the election being held on Tuesday, November 8,  
 8 2016.

9 DEPUTY DIRECTOR PAYNE: All those -- I  
 10 need a second.

11 CHAIRMAN PREISSE: You keep stepping on  
 12 our seconds.

13 DEPUTY DIRECTOR PAYNE: I do, I do. I'm  
 14 sorry.

15 MEMBER HAAS: Second.

16 DEPUTY DIRECTOR PAYNE: All those in  
 17 favor of that. All those opposed same sign.

18 Motion carries.

19 We're in recess.

20 (Thereupon, at 3:19 p.m., the meeting was  
 21 recessed.)

## **Exhibit B**

### **Machine Allocation**

Since our last machine allocation, we have added 24,014 new voters. The Board took the number of active voters in a location and removed the number of voters who voted absentee Prior to October 29, 2016 and recomputed the number of machines required using the maximum allowed of 1 machine for every 175 voters. The Secretary of State also requires a minimum of 2 machines at a voting location. The Board supplies a minimum of 3 voting machines per voting location. All locations remained within the required limits, with the exception of the Ohio Union. At this location, we are recommending an increase of 5 machines. The increase of 5 machines would take the number of 29 machines to 34 at the Ohio Union.

The warehouse has removed 5 machines from the holdback of 18 machines, leaving 13 machines for any necessary emergency replacements.
