All those in favor of 5 the motion signify by saying aye. 6 (Vote taken.) 7 All opposed, DEPUTY DIRECTOR PAYNE: 8 same sign. 9 (No response.) 10 DEPUTY DIRECTOR PAYNE: Motion 11 carries. 12 The next item on the agenda is a 13 voter challenge. And I'm going to call on Sara 14 Ziemba, the head of our voter registration 15 department -- or voter services, to talk about that 16 item 17 MS. ZIEMBA: Good afternoon 18 My name is Sara Ziemba. I'm the everyone. 19 supervisor in the Voter Services Department here. 20 And we have a challenge brought to 21 us from a registered voter, Patricia Slaughter, of 22 2704 Petzinger Road in Columbus against Mark 23 Cochran who is also currently registered at 24 2704 Petzinger Road in Columbus. 25 In your packet you've got her

8 1 challenge form that she affirms she's lived at the 2 address since January of 1990 and that the 3 individual, Mark Cochran, has been registered there 4 since 2015 but has never lived at that address in 5 the entire 30-plus-year period she's lived at the 6 home on Petzinger. 7 You also have in your packet the 8 voting histories and brief comments regarding both 9 Mark Cochran's voting history and Patricia 10 Slaughter's history. 11 On Mark Cochran, he was registered 12 in 2015 and that was the last registration or 13 activity -- voter-initiated activity we have had 14 from him since he registered in 2015. He's never 15 voted, he's never returned any confirmation notice, 16 signed a petition, has done nothing to indicate 17 that he exists, lives at 2704 Petzinger, or wants 18 to remain registered at that address. 19 He received a supplemental notice in 20 2018, which is part of the non-discriminatory NVRA 21 list maintenance process that the Secretary of 22 State has us carry out on their behalf to keep our 23 rolls up to date and accurate. He did not respond 24 to that notice. 25 And then in 2022, earlier this year,

9 1 in March, as the second part of that NVRA 2 supplemental process, we sent another confirmation 3 notice to Mr. Cochran at 2407 Petzinger, letting 4 him know that if he doesn't do any voter activity 5 before July of this year, 2022, he will be removed 6 from the voter rolls because of the extended period 7 of inactivity. So he is currently scheduled to be 8 removed as part of the NVRA supplemental process in 9 July of 2022 in accordance with the Ohio Secretary 10 of State's directive 2022-23. 11 The next document you'll have is 12 Patricia Slaughter's voting history, and it goes 13 all the way back to when we started tracking it 14 back in 1990. You can see she's voted consistently 15 throughout the entire time we have been tracking it 16 on our system that I could get. 17 She has been registered to vote in 18 Franklin County since 1977. And you'll notice I 19 highlighted a brief period of time in 2007 where 20 there was an online registration that mistakenly --21 on our part at the Board of Elections we mistakenly removed her address. And so she voted 22 23 provisionally the next time she went to vote and 24 that moved her address back to the 2704 Petzinger 25 which coincided with her testament on her voter

1	challenge form that she has lived there since 1990.
2	And you can see that I highlighted the change,
3	where it was the Board of Elections that moved her
4	address.
5	She votes regularly, she lives at
6	the home, and her registration and voting history
7	would indicate that she is being truthful in her
8	statement that Mark Cochran does not and has not
9	ever lived at that address.
10	The last set of papers that you'll
11	have are all of the documentation that we have on
12	file for Mr. Cochran and the relevant information
13	we have from Ms. Slaughter. And the first document
14	there is Mark Cochran's 2015 voter registration
15	form. That was the one and only piece of
16	documentation that we have from this individual.
17	The next one you'll see are a couple
18	of returned pieces of mail that Ms. Slaughter
19	received at her home, 2407 Petzinger Road, and she
20	has returned to us letting us know that no one
21	it was addressed to Mr. Cochran and she returned it
22	to us letting us know that no one lives at that
23	home by that name. Those pieces of return mail
24	were from 2016 and 2018. So this has been going on
25	for several years, as you can see.

2	Patricia Slaughter's 2007 voter registration form
3	that corrected her address back to 2407 Petzinger
4	after there was an internal Board of Elections
5	error that moved her. So she voted provisionally
6	that time and got her address corrected.

7	And then the last document that you
8	have is her original 1977 voter registration form
9	here in Franklin County.
10	CHAIRMAN PREISSE: You don't see
11	many of those.
