SHALL BONDS BE ISSUED BY THE BOARD OF EDUCATION OF THE UPPER ARLINGTON CITY SCHOOL DISTRICT, FOR THE PURPOSE OF ACQUIRING REAL ESTATE FOR SCHOOL PURPOSES, CONSTRUCTING, IMPROVING AND REMODELING FIREPROOF SCHOOL BUILDINGS, PURCHASING FURNITURE, FURNISHINGS AND EQUIPMENT FOR SCHOOL BUILDINGS AND IMPROVING SCHOOL SITES IN THE SUM OF TWO MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$2,800,000.00) AND A LEVY OF TAXES TO BE MADE OUTSIDE OF THE TEN MILL LIMITATION, ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE 2.11 MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO 21.1 CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION FOR A MAXIMUM PERIOD OF TWENTY (20) YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS.






