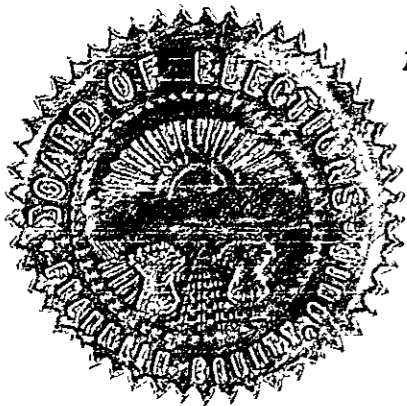

(A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE)

SHALL BONDS BE ISSUED BY THE BOARD OF EDUCATION OF THE WORTHINGTON CITY SCHOOL DISTRICT FOR THE PURPOSE OF CONSTRUCTING SCHOOL BUILDINGS, ACQUISITION OF REAL ESTATE, ADDITIONS AND IMPROVEMENTS TO EXISTING SCHOOL FACILITIES, FURNISHING AND EQUIPPING THE SAME AND SITE DEVELOPMENT IN THE SUM OF TEN MILLION EIGHT HUNDRED SEVENTY THOUSAND DOLLARS (\$10,870,000) AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE ONE AND EIGHT-TENTHS MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO EIGHTEEN CENTS (\$0.18) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY-THREE YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?
