4 CHAIRMAN ANTHONY: Let's call the
5 meeting to order, please.

6 MR. DAMSCHRODER: Mr. Colley?

7 MR. COLLEY: Yes.

8 MR. DAMSCHRODER: Ms. Marinello?

9 MS. MARINELLO: Yes.

10 MR. DAMSCHRODER: Chairman
11 Anthony?

12 CHAIRMAN ANTHONY: Yes.

13 MR. DAMSCHRODER: We have three
14 members present, Mr. Chairman. Board Member
15 Carolyn Petree called earlier and says she
16 regrets she will not be able to attend
17 today. So we do have a quorum necessary to
18 continue with business today.

19 CHAIRMAN ANTHONY: Okay.

20 MR. DAMSCHRODER: The first item
21 on the agenda is a certification of the
22 primary election results. The agenda is
23 wrong, it's written general election, it
24 should be the May 8, 2007, primary election.

1 CHAIRMAN ANTHONY: It is supposed
2 to be the primary election?

3 MR. DAMSCHRODER: Yes.

4 CHAIRMAN ANTHONY: Entertain a
5 motion?

6 MS. MARINELLO: Mr. Chairman, I
7 move that the Board certify the results of
8 the May 8, 2007, general election --

9 MR. DAMSCHRODER: Primary.

10 MS. MARINELLO: -- primary
11 election as submitted.

12 CHAIRMAN ANTHONY: Is there a
13 second?

14 MR. COLLEY: Second.

15 (A vote was taken.)

16 MR. DAMSCHRODER: The motion
17 carries.

18 The last item on the agenda is --
19 we addressed part of these at the last
20 meeting. It's going to be a series of
21 withdrawals and certifications of candidates
22 in light of Patsy Thomas's appointment to
23 the Municipal Court bench. Her nominating
24 committee has submitted Hearcel Craig to

1 replace Ms. Thomas on the ballot as a
2 candidate for the Columbus City Council.

3 CHAIRMAN ANTHONY: Okay.
4 Entertain a motion?

5 MR. COLLEY: Second it.

6 MR. DAMSCHRODER: We need to
7 entertain a motion first.

8 MS. MARINELLO: The nomination had
9 been timely submitted by the nominating
10 committee of the former candidate Patsy A.
11 Thomas. I move that the Board certify the
12 nomination of Hearcel Craig to the 2007
13 general election ballot as a candidate for
14 the office and member of the Columbus City
15 Council.

16 CHAIRMAN ANTHONY: Is there a
17 second?

18 MR. COLLEY: Second.

19 (A vote was taken.)

20 MR. DAMSCHRODER: The motion
21 carries.

22 That's all the business that we
23 had on the agenda for today's meeting.

24 CHAIRMAN ANTHONY: I'll entertain

1 a motion to adjourn.

2 MS. MARINELLO: I make a motion
3 that we adjourn.

4 MR. COLLEY: Second.




