- 1 MR. PICCININNI: It's 14 days.
- DIRECTOR WHITE: I'm not a lawyer.
- 3 Pat's the lawyer. I think it's clear what the
- 4 voter's intent is. And if we really want to -- I
- 5 think she'd want us -- if we err on -- err on the
- 6 side of the voter.
- 7 BOARD MEMBER MARINELLO: That's what
- 8 we're supposed to do, is the voter intent.
- 9 MR. PICCININNI: It's voter intent
- 10 when you cannot read the ballot. You can read
- 11 the ballot.
- 12 CHAIRMAN PREISSE: Would your opinion
- 13 change when you see the name of the voter? It
- 14 has lots of Z's and ends in an I.
- MR. PICCININNI: That doesn't matter.
- 16 CHAIRMAN PREISSE: My sense is that
- it's a valid ballot the way it is, and it's
- 18 not -- what's your sense?
- 19 BOARD MEMBER MARINELLO: Well, I just
- 20 thought that, you know, voter intent is what
- 21 we're here for, true, but.

- 6 it. She blew it. No, I think she blew it.

- 8 it? Okay. Then you'd count it as is. I'm
- 9 sorry.
- BOARD MEMBER ANTHONY: That we count
- 11 this ballot as it was submitted to us.
- 12 CHAIRMAN PREISSE: Second.

- 14 (Board votes aye unanimously.)

- 20 The voter marked for Troper, then put an X
- 21 through Troper, then colored in Miller and
- 22 attached a note saying that the voter wanted to
- 23 vote for Miller.
- 24 CHAIRMAN PREISSE: It's attached in

- 1 the inside on the --
- DEPUTY DIRECTOR DAMSCHRODER: To the
- 3 ballot.
- 4 MR. PICCININNI: Did they cross out
- 5 and then change it back and forth?
- 6 DEPUTY DIRECTOR DAMSCHRODER: Yes,
- 7 they did. Yep.
- 8 BOARD MEMBER ANTHONY: That's
- 9 different than that last one, to me.

- BOARD MEMBER ANTHONY: Kim, what are
- 19 you saying?
- 20 BOARD MEMBER MARINELLO: I think it's
- 21 Lazarus.
- BOARD MEMBER ANTHONY: You think it's
- 23 Lazarus? Me, too.
- 24 CHAIRMAN PREISSE: I think so.

- 1 BOARD MEMBER ANTHONY: Upon review and
- 2 inspection, it appears the intent of the voter
- 3 was to vote for Cindy Lazarus. I move that the
- 4 following ballot be remade to -- that Ballot No.
- 5 666 be remade to evidence that vote.
- 6 CHAIRMAN PREISSE: And I second the
- 7 motion.
- 8 DIRECTOR WHITE: All in favor?
- 9 (Board votes aye unanimously.)
- 10 DIRECTOR WHITE: Any nay's?
- 11 (No response.)
- 12 DEPUTY DIRECTOR DAMSCHRODER: The next
- one, election-day ballot, is overvoted in the
- 14 contest for Clerk of the Court of Common Pleas.
- 15 The staff recommendation is that it is a vote for
- 16 Phil Harmon.
- BOARD MEMBER COLLEY: Looks good to
- 18 me.
- 19 BOARD MEMBER MARINELLO: Yep.
- 20 CHAIRMAN PREISSE: I agree.
- BOARD MEMBER ANTHONY: Mr. Chair, upon
- 22 review and inspection, it appears that the intent
- 23 of the voter was to vote for Phil Harmon for
- 24 Clerk of Common Pleas -- Clerk of the Court of

- 1 Common Pleas. I move that the Board remake
- 2 Ballot No. 662 to evidence that vote.
- 3 CHAIRMAN PREISSE: I second it.
- 4 DIRECTOR WHITE: All in favor?
- 5 (Board votes aye unanimously.)
- 6 DIRECTOR WHITE: Any nay's?
- 7 (No response.)
- 8 DIRECTOR WHITE: The motion is
- 9 carried.
- 10 DEPUTY DIRECTOR DAMSCHRODER: The next
- 11 one is overvote in the contest for president. It
- 12 appears to be a vote for McCain.
- BOARD MEMBER ANTHONY: Mr. Chair, upon
- 14 review and inspection, it appears that the intent
- of the voter was to vote for John McCain. I move
- 16 that Ballot No. 665 be remade to evidence that
- 17 vote.
- 18 CHAIRMAN PREISSE: Second.
- 19 DIRECTOR WHITE: All in favor?
- 20 (Board votes aye unanimously.)
- 21 DIRECTOR WHITE: Any nay's?
- 22 (No response.)
- DIRECTOR WHITE: Motion carries.
- DEPUTY DIRECTOR DAMSCHRODER: The next

- 1 one is overvote in the contest for 7th
- 2 Congressional District. It appears to be a vote
- 3 for Conner, C-o-n-n-e-r.
- 4 BOARD MEMBER ANTHONY: Mr. Chair, upon
- 5 review and inspection of this ballot, it appears
- 6 that the voter's intent was to vote for Bill
- 7 Conner for Representative to Congress, the 7th
- 8 District. I move that Ballot No. 667 be remade
- 9 to evidence that vote.
- 10 CHAIRMAN PREISSE: Seconded.
- 11 DIRECTOR WHITE: All in favor?
- 12 (Board votes aye unanimously.)
- DIRECTOR WHITE: Any nay's?
- 14 (No response.)
- 15 DIRECTOR WHITE: Motion carries.
- 16 DEPUTY DIRECTOR DAMSCHRODER: The next
- one is overvoted in the 29th proposed tax levy.
- 18 It appears to be a vote for the levy.
- BOARD MEMBER ANTHONY: Mr. Chair, upon
- 20 review and inspection, it appears the intent of
- 21 the voter was to vote for Issue 29, the proposed
- 22 tax levy. I move that Ballot No. 668 be remade
- 23 to evidence that vote.
- 24 CHAIRMAN PREISSE: Second.

- 1 DIRECTOR WHITE: All in favor?
- 2 (Board votes aye unanimously.)
- 3 DIRECTOR WHITE: Any nay's?
- 4 (No response.)
- 5 DIRECTOR WHITE: Motion carries.
- 6 DEPUTY DIRECTOR DAMSCHRODER: All
- 7 right. The next one, the poll workers gave the
- 8 voter both a Democrat primary ballot and an
- 9 issues-only ballot. The voter did not mark a
- 10 vote for either the 29th or the 27th tax
- 11 questions on the Democrat ballot, but did vote
- 12 them on the issues-only ballot. The voter intent
- is pretty clear in terms of what they've marked.
- 14 CHAIRMAN PREISSE: Well, this is -- is
- this a paper preference ballot, or what is that?
- 16 DEPUTY DIRECTOR DAMSCHRODER: Yes.
- 17 It's a paper preference ballot that the poll
- 18 workers put in an envelope and marked on the
- 19 envelope that it was a paper ballot. But they
- 20 gave them both sheets of paper, both the Democrat
- 21 ballot and the issues-only ballot.
- 22 And the voter did not vote any issues
- 23 on the Democrat. So it's not -- the voter didn't
- 24 cast -- the voter had one more ballot -- actual

- 1 ballot card than they were supposed to have had,
- 2 but they didn't vote twice in any contest that
- 3 appeared on both ballots.
- 4 BOARD MEMBER ANTHONY: So you're just
- 5 going to remake one ballot?
- 6 CHAIRMAN PREISSE: So did they vote
- 7 twice but on different things?
- 8 DEPUTY DIRECTOR DAMSCHRODER: My
- 9 personal view is that they probably did not
- 10 intentionally vote twice.
- 11 CHAIRMAN PREISSE: They voted two
- 12 times, though.
- DEPUTY DIRECTOR DAMSCHRODER: Well, it
- 14 was in the same envelope. They voted two
- 15 different cards. I would be -- I'd be willing to
- 16 wager that what happened was they got an issues-
- only, marked it, and said, well, I want to vote
- 18 for Democrat candidates, too. The poll workers
- 19 tore it off, they voted it, and they put it in
- 20 the envelope.
- MR. PICCININNI: As opposed to what
- 22 they should have done, which was void the issue-
- 23 only ballot.
- 24 DEPUTY DIRECTOR DAMSCHRODER:

- 1 Precisely.
- 2 CHAIRMAN PREISSE: They probably were
- 3 afraid to do that.
- 4 BOARD MEMBER ANTHONY: Yeah. They
- 5 didn't want to tear nothing up in front of a
- 6 voter. So usually run just one ballot on that
- 7 one.
- 8 DEPUTY DIRECTOR DAMSCHRODER: Right.
- 9 If that's what the Board wants to do.
- 10 DIRECTOR WHITE: Yeah. I would think
- 11 you should make one ballot showing the voter's
- 12 intent. It's pretty clear they were going to
- 13 vote for it.
- 14 BOARD MEMBER ANTHONY: Mr. Chair --
- 15 MR. PICCININNI: Hold on. Does this
- 16 ballot actually need to be remade, or can't you
- 17 just run it through?
- DEPUTY DIRECTOR DAMSCHRODER: We'll
- 19 have to remake it. Because if we run it through,
- 20 it will count -- the public count will increase
- 21 by two.
- MR. PICCININNI: Got you.
- BOARD MEMBER ANTHONY: Mr. Chair, upon
- 24 review and inspection, it is the intent of the

- 1 voter to vote a primary ballot, not an issues-
- 2 only ballot. I move that the Board remake the
- 3 ballot to reflect that desire. The Ballot No. is
- 4 538.
- 5 CHAIRMAN PREISSE: I second that
- 6 motion.
- BOARD MEMBER ANTHONY: Oh, there's two
- 8 of them on there.
- 9 DEPUTY DIRECTOR DAMSCHRODER: We
- 10 numbered it. So go ahead and get both numbers in
- 11 the resolution.
- BOARD MEMBER ANTHONY: 538 was for the
- issue-only, and No. 539 was for the Ohio
- 14 Democratic primary.
- 15 DIRECTOR WHITE: Motion's been
- 16 seconded. All in favor?
- 17 (Board votes aye unanimously.)
- DIRECTOR WHITE: Any nay's?
- 19 (No response.)
- DIRECTOR WHITE: Motion carries.
- 21 DEPUTY DIRECTOR DAMSCHRODER: All
- 22 right. Now we turn to 17-year-old ballots. And
- 23 when you see these, you'll notice that on some of
- 24 them, the vote for the issue is covered up and

- 1 the vote for State Central Committee is covered
- 2 up with a white label.
- We did that at a staff level because
- 4 voters -- 17-year-old voters cannot vote issues
- 5 or for state or county central committee.
- 6 MR. PICCININNI: And these are the
- 7 voters that asked for a paper ballot?
- 8 DEPUTY DIRECTOR DAMSCHRODER: No. All
- 9 17-year-old's had to vote on paper. And so to
- 10 reduce the number of ballot styles, we went ahead
- 11 and just printed everything with the candidates
- 12 on there. We covered up the votes that they
- 13 voted for, was what we've done in the past.
- 14 The first two overvoted for County
- 15 Commissioner. It appears to be votes for
- 16 O'Grady.
- BOARD MEMBER MARINELLO: How many of
- 18 those did you get, the 17-year-old paper ballots,
- 19 do you think?
- 20 DEPUTY DIRECTOR DAMSCHRODER: I don't
- 21 know if I -- we can get you that number.
- BOARD MEMBER MARINELLO: Oh, that's
- 23 all right.
- BOARD MEMBER ANTHONY: Mr. Chair, upon

- 1 review and inspection, it appears that the intent
- 2 of the voter was to vote for John O'Grady for
- 3 County Commissioner. I move that Ballot No. 674
- 4 and 671 be remade to evidence that vote.
- 5 CHAIRMAN PREISSE: Seconded.
- 6 DIRECTOR WHITE: All in favor?
- 7 (Board votes aye unanimously.)
- 8 DIRECTOR WHITE: Any nay's?
- 9 (No response.)
- 10 DIRECTOR WHITE: Motion carries.
- 11 DEPUTY DIRECTOR DAMSCHRODER: The next
- one is overvoted for president. It appears to be
- 13 a vote for Obama.
- BOARD MEMBER ANTHONY: Mr. Chair, upon
- 15 review and inspection of the ballot, the intent
- 16 of the voter was to vote for Barack Obama. I
- 17 move that Ballot No. 673 be remade to evidence
- 18 that vote.
- 19 CHAIRMAN PREISSE: Second.
- 20 DIRECTOR WHITE: All in favor?
- 21 (Board votes age unanimously.)
- DIRECTOR WHITE: Any nay's?
- 23 (No response.)
- DIRECTOR WHITE: Motion carries.

- 1 DEPUTY DIRECTOR DAMSCHRODER: The next
- one, they overvoted. The contest is, again,
- 3 president. It appears to be a vote for Huckabee.
- 4 BOARD MEMBER ANTHONY: Mr. Chair, upon
- 5 review and inspection, it appears that the intent
- 6 of the voter is to vote for Mike Huckabee. I
- 7 move that Ballot No. 676 be remade to evidence
- 8 that vote.
- 9 CHAIRMAN PREISSE: And I second the
- 10 motion.
- 11 DIRECTOR WHITE: All in favor?
- 12 (Board votes aye unanimously.)
- DIRECTOR WHITE: Any nay's?
- 14 (No response.)
- 15 DIRECTOR WHITE: Motion carries.
- 16 DEPUTY DIRECTOR DAMSCHRODER: The next
- 17 stack that Michael has is three ballots that just
- 18 need to be remade because they're either cut,
- 19 marred, taped, or whatever. The voters' intent
- 20 is clear. They have consistently marked --
- BOARD MEMBER COLLEY: Abundantly
- 22 clear?
- DEPUTY DIRECTOR DAMSCHRODER:
- 24 Abundantly clear. Absolutely.

- 1 CHAIRMAN PREISSE: Are these still --
- DEPUTY DIRECTOR DAMSCHRODER: They're
- 3 still 17-year-old voters.
- 4 CHAIRMAN PREISSE: What's the one
- 5 without the color?
- 6 DEPUTY DIRECTOR DAMSCHRODER: When you
- 7 print them ballot on demand here at the office,
- 8 it doesn't do color.
- 9 CHAIRMAN PREISSE: So that was --
- 10 DEPUTY DIRECTOR DAMSCHRODER: That's
- 11 somebody who came here in person.
- BOARD MEMBER MARINELLO: Interesting.
- BOARD MEMBER ANTHONY: Now, what are
- 14 these, Matt? I was --
- DEPUTY DIRECTOR DAMSCHRODER: Those
- 16 are ballots that are either torn or marred or
- 17 taped or cut or something.
- BOARD MEMBER ANTHONY: So you've got
- 19 to rerun --
- 20 DEPUTY DIRECTOR DAMSCHRODER: We're
- 21 going to recreate them. But there's no overvoted
- 22 contest and no voter intent questions, though.
- 23 CHAIRMAN PREISSE: Those are still
- 24 17-year-olds?

- 1 DEPUTY DIRECTOR DAMSCHRODER: Still
- 2 17-year-old ballots.
- BOARD MEMBER ANTHONY: Mr. Chair, upon
- 4 review and inspection of the ballots, I move that
- 5 the Board remake these ballots to reflect the
- 6 voters' intent. That would be Ballot No. 672,
- 7 670, and 669.
- 8 CHAIRMAN PREISSE: Seconded.
- 9 DIRECTOR WHITE: All in favor?
- 10 (Board votes aye unanimously.)
- 11 DIRECTOR WHITE: Any nay's?
- 12 (No response.)
- 13 DIRECTOR WHITE: Motion carries.
- DEPUTY DIRECTOR DAMSCHRODER: All
- 15 right. This one is overvoted in the contest for
- 16 Court of Common Pleas Clerk. It appears to be a
- 17 vote for Teater, T-e-a-t-e-r.
- BOARD MEMBER ANTHONY: Mr. Chair, upon
- 19 review and inspection of the ballot, the intent
- 20 of the voter was to vote for Dorothy S. Teater
- 21 for Clerk of Court of Common Pleas.
- I move that the Board remake Ballot
- No. 675 to evidence that vote.
- 24 CHAIRMAN PREISSE: Second.

- 1 DIRECTOR WHITE: All in favor?
- 2 (Board votes aye unanimously.)
- 3 DIRECTOR WHITE: Any nay's?
- 4 (No response.)
- 5 DIRECTOR WHITE: Motion carries.
- 6 DEPUTY DIRECTOR DAMSCHRODER: This
- 7 next one is a federal write-in absentee ballot
- 8 which is available for military and overseas
- 9 citizens who can't get their ballot in time to
- 10 return it. It's a valid vote for Obama that we
- 11 need permission to -- obviously, we can't read a
- 12 written-in ballot, so we had to make an optical
- 13 scan ballot that says Obama.
- 14 BOARD MEMBER ANTHONY: Just that one
- 15 vote?
- DEPUTY DIRECTOR DAMSCHRODER: Yep.
- 17 SPEAKER: There's another one on
- 18 there, too, congressional.
- 19 DEPUTY DIRECTOR DAMSCHRODER: Did they
- 20 write in there congressional? I didn't see it.
- BOARD MEMBER MARINELLO: This David
- 22 Robinson?
- DEPUTY DIRECTOR DAMSCHRODER: Oh,
- 24 okay. I'm sorry, I didn't see that. So it's

- 1 Obama and Robinson. Thank you, guys.
- BOARD MEMBER MARINELLO: They typed it
- 3 in. Does that normally come --
- 4 DEPUTY DIRECTOR DAMSCHRODER: Online.
- 5 BOARD MEMBER MARINELLO: Oh. Smart.
- 6 BOARD MEMBER ANTHONY: So does this
- 7 have a number on it?
- DEPUTY DIRECTOR DAMSCHRODER: Yeah.
- 9 BOARD MEMBER ANTHONY: Mr. Chair, I
- 10 move that the Board create a ballot to reflect
- 11 the vote of Barack Obama for president and Dave
- 12 Robinson for commissioner -- for Congress. Yeah,
- 13 for Congress. This will be Ballot No. 679.
- MR. PICCININNI: Which is an official
- 15 federal write-in absentee ballot.
- DEPUTY DIRECTOR DAMSCHRODER: Correct.
- 17 BOARD MEMBER ANTHONY: Yes.
- 18 CHAIRMAN PREISSE: Second.
- 19 DIRECTOR WHITE: All in favor?
- 20 (Board votes aye unanimously.)
- 21 DIRECTOR WHITE: Any nay's?
- (No response.)
- DIRECTOR WHITE: Motion carries.
- 24 DEPUTY DIRECTOR DAMSCHRODER: All

- 1 right. Last one is interesting. The poll worker
- 2 wrote on it that the voter voted an issues-only
- 3 ballot on the machine because the voter was given
- 4 the wrong authority-to-vote slip.
- 5 So the poll workers gave the person a
- 6 paper ballot so that they could vote the
- 7 candidates. And the voter made a note here that,
- 8 quote, I was given the wrong slip to vote, so the
- 9 attorney general said to vote provisional. I
- 10 want my vote to count, end quote.
- BOARD MEMBER ANTHONY: He voted on
- 12 both the machines and the paper ballot?
- 13 DEPUTY DIRECTOR DAMSCHRODER:
- 14 According to this, the poll worker said they
- 15 voted the issue-only on the machine, and then
- 16 they gave her a party ballot which is --
- 17 DIRECTOR WHITE: Did they vote the
- 18 issues again on the ballot?
- 19 DEPUTY DIRECTOR DAMSCHRODER: I don't
- 20 know. This has not been opened yet.
- MR. PICCININNI: They don't vote.
- 22 They've already voted.
- CHAIRMAN PREISSE: They voted on it,
- 24 and we -- what's the best evidence we have that

- 1 this voter voted only -- what is any evidence
- 2 that we have? We have the testimony of --
- 3 DEPUTY DIRECTOR DAMSCHRODER: We have
- 4 the testimony of a poll worker who wrote on
- 5 election-day that the vote -- that the voter,
- 6 quote, voted issues-only because the voter was
- 7 given wrong slip, end quote.
- 8 My personal view is, as much as I
- 9 would like to count the ballot, I think this is
- 10 the situation where the person has already put
- 11 their ballot in the ballot box, and you can't,
- 12 then, get another ballot to put in the ballot
- 13 box.
- MR. PICCININNI: They would have voted
- 15 twice. On the issues, they would have voted
- 16 twice.
- 17 DEPUTY DIRECTOR DAMSCHRODER: Assuming
- 18 they voted the issues on here.
- MR. PICCININNI: Assuming they voted
- 20 the issues there. But we have no way of knowing
- 21 that.
- DEPUTY DIRECTOR DAMSCHRODER: Right.
- 23 Exactly. Whereas, the case with the other
- 24 situation where we had the Democrat ballot and

- 1 the issues-only ballot put together in the same
- 2 envelope, we knew that the person hadn't voted
- 3 twice.
- 4 Here, we have a ballot in the ballot
- 5 box, a signature in the poll book, and the public
- 6 count on the machine advanced by one. And we
- 7 have another ballot for the same voter. My
- 8 recommendation would be not to count it, but.
- 9 DIRECTOR WHITE: If you look at No. 1
- 10 that Brian gave us from the Secretary of State's
- 11 office, it kind of addresses that issue.
- 12 CHAIRMAN PREISSE: Is this the follow-
- 13 up e-mail or the --
- DEPUTY DIRECTOR DAMSCHRODER: This is
- 15 the e-mail that came today. Which one is it,
- 16 Denny?
- 17 DIRECTOR WHITE: No. 1, more than one
- 18 ballot in the provisional envelope.
- MR. PICCININNI: That's more than one
- 20 ballot in the provisional envelope.
- DIRECTOR WHITE: Right. But that's a
- 22 provisional envelope. But if you read, it says,
- 23 apparently, some of your poll workers, for
- 24 whatever reason, instructed voters to complete

- 1 party ballots or even -- or you guys can read it.
- Can everybody see that No. 1? That
- 3 was Brian's answer.
- 4 MR. PICCININNI: I think it's
- 5 inapplicable in this particular situation.
- 6 Because the situation is, you have a vote on the
- 7 machine and now you have a vote on paper.
- 8 There's no way to back out the machine vote.
- 9 DIRECTOR WHITE: And I think that's
- 10 what this is kind of saying here, but in a
- 11 different situation.
- 12 DEPUTY DIRECTOR DAMSCHRODER: Right.
- 13 DIRECTOR WHITE: Just to give you a
- 14 little guidance on this. They're saying only one
- 15 ballot should be counted.
- DEPUTY DIRECTOR DAMSCHRODER: Right.
- 17 DIRECTOR WHITE: If you use that for a
- 18 guidance, I think that, basically, it can only
- 19 count as a vote on the machine.
- MR. PICCININNI: You know, I don't
- 21 understand this when you see that the ballot
- 22 comes up in just issues.
- 23 CHAIRMAN PREISSE: And then you
- 24 complete it.

- 1 MR. PICCININNI: And you complete it.
- 2 And you don't ask any questions?
- 3 CHAIRMAN PREISSE: If you don't push
- 4 vote, then you could still -- you know, you could
- 5 go --
- 6 DEPUTY DIRECTOR DAMSCHRODER: Right.
- 7 If you haven't pressed the confirm button at the
- 8 end of the ballot, you could -- the poll workers
- 9 could cancel that ballot and start a new voting
- 10 session for the voter so that they can correct --
- BOARD MEMBER ANTHONY: Or give them a
- 12 paper ballot?
- DEPUTY DIRECTOR DAMSCHRODER: Or,
- 14 yeah. Or cancel the ballot and give them a paper
- 15 ballot.
- 16 CHAIRMAN PREISSE: So we know
- 17 that -- I mean, we can verify that the voter got
- 18 an issues-only ballot, right?
- DEPUTY DIRECTOR DAMSCHRODER: Based on
- 20 what's written on that envelope, there. I mean,
- 21 we could go back and we could find that person's
- 22 name in the poll book, probably see where they
- 23 checked issues only, and then the number and the
- 24 signatures in the poll book should reconcile with

- 1 the number of ballots cast.
- 2 The number of issues-only checks
- 3 should reconcile with the number of issues only
- 4 on the machine. But there's always a slight
- 5 variation.
- 6 So I think, in this case, we have to
- 7 accept the statement of the poll worker that the
- 8 person voted an issues-only ballot on the machine
- 9 and dropped it in the ballot box, essentially, by
- 10 confirming it.
- BOARD MEMBER ANTHONY: They only get
- 12 the one vote, then.
- DIRECTOR WHITE: Right. One ballot.
- BOARD MEMBER ANTHONY: Right. And the
- 15 ballot they put in the machine.
- DEPUTY DIRECTOR DAMSCHRODER: Right.
- BOARD MEMBER ANTHONY: So how do we
- 18 vote on this, then?
- 19 DIRECTOR WHITE: Not to -- not to
- 20 accept it.
- MR. PICCININNI: We vote not -- a vote
- 22 not to -- it has to be a vote in the
- 23 affirmative. So it would have to be a vote to
- 24 count this provisional ballot.

- 1 DEPUTY DIRECTOR DAMSCHRODER: And then
- 2 it just dies for a lack of a second.
- 3 MR. PICCININNI: Or it has to fail.
- 4 It has to fail.
- 5 CHAIRMAN PREISSE: Wait a minute.
- 6 What are you saying?
- 7 DEPUTY DIRECTOR DAMSCHRODER: No, I
- 8 see what you're saying.
- 9 MR. PICCININNI: You have to vote no.
- 10 You have to vote not to count the ballot.
- 11 CHAIRMAN PREISSE: The question before
- 12 us is, do we count this ballot?
- 13 DEPUTY DIRECTOR DAMSCHRODER: Correct.
- BOARD MEMBER ANTHONY: No. Then I
- 15 move -- okay. I make a motion that we count this
- 16 ballot.
- 17 MR. PICCININNI: The motion has to be
- 18 made in the affirmative. Correct.
- 19 BOARD MEMBER ANTHONY: That we count
- 20 this ballot in -- what number is this?
- 21 CHAIRMAN PREISSE: The motion has to
- 22 be made in the affirmative?
- 23 DEPUTY DIRECTOR DAMSCHRODER: I don't
- 24 think it -- we didn't number it.

- 1 BOARD MEMBER ANTHONY: I got an ID
- 2 number. Should I read that?
- 3 DEPUTY DIRECTOR DAMSCHRODER: Sure.
- 4 BOARD MEMBER ANTHONY: The ID No. is
- 5 050028237. Is there a second?
- 6 BOARD MEMBER MARINELLO: Second.
- 7 DIRECTOR WHITE: It's been seconded.
- 8 MR. PICCININNI: If you don't want it
- 9 to count, vote no; if you want it to count, vote,
- 10 yes.
- BOARD MEMBER ANTHONY: Correct.
- 12 DIRECTOR WHITE: All in favor?
- 13 (No response.)
- 14 DIRECTOR WHITE: Everyone against?
- 15 BOARD MEMBER MARINELLO: No.
- 16 CHAIRMAN PREISSE: No.
- BOARD MEMBER ANTHONY: No.
- 18 DIRECTOR WHITE: Motion fails.
- 19 DEPUTY DIRECTOR DAMSCHRODER: Just
- 20 real quick, we do -- the Secretary of State, we
- 21 asked them, in writing, a couple of weeks ago for
- 22 some ruling on some provisionals. They just
- 23 ruled this afternoon. So we still have some
- 24 provisionals that we have to open and run through

- 1 the machines.
- 2 Hopefully, there won't be any
- 3 overvotes in those or voter intent issues. If
- 4 there are, we'll have to have you come back
- 5 probably Wednesday afternoon for a very, very,
- 6 very, very brief meeting to do those before we
- 7 can certify Friday.
- 8 There is the issue still pending about
- 9 the post-election audit under the Secretary of
- 10 State's program. She asked for 11 counties to
- 11 volunteer. Eleven counties have volunteered. I
- 12 don't think that precludes us from participation.
- We would have to ask the Secretary of
- 14 State for a waiver if we have a recount, an
- 15 automatic request of recount. Which we won't
- 16 know that until Friday.
- 17 BOARD MEMBER ANTHONY: Now,
- 18 what -- who actually does the audit?
- DEPUTY DIRECTOR DAMSCHRODER: The way
- 20 the directive was written, our staff -- we
- 21 actually pay our staff to do the audit.
- BOARD MEMBER ANTHONY: Okay. It's not
- 23 outside --
- DIRECTOR WHITE: That's if you do it

- 1 the way she's doing it, it's our staff.
- DEPUTY DIRECTOR DAMSCHRODER: Right.
- 3 Right. We could do it --
- 4 DIRECTOR WHITE: But I don't think
- 5 there's anything excluding the Board from hiring
- 6 somebody else to audit, if you want it
- 7 independent of us.
- 8 BOARD MEMBER ANTHONY: What's the
- 9 advantage of either?
- 10 DIRECTOR WHITE: Transparency.
- BOARD MEMBER ANTHONY: Transparency?
- 12 Yeah.
- DIRECTOR WHITE: You know, I think
- 14 it's hard -- I think it's hard to audit
- 15 yourself --
- 16 BOARD MEMBER ANTHONY: I do, too.
- 17 DIRECTOR WHITE: -- and have
- 18 credibility out there. Because the same people
- 19 that don't trust us now, are they going to trust
- 20 us if we audit ourselves?
- 21 And I think there's groups out there
- 22 that are available that would probably do this.
- 23 We'd have to pay them somehow or make them
- 24 temporary people. If the Secretary has a rule

- 1 that it has to be us. I don't know if there's
- 2 any law we have to do it.
- 3 DEPUTY DIRECTOR DAMSCHRODER: I mean,
- 4 in Cuyahoga, in 2006, they twice paid an outside
- 5 entity, the Cleveland State University Center for
- 6 Election Integrity, which is a very reputable
- 7 organization. They paid them to actually conduct
- 8 the audit.
- 9 You know, there is precedent for
- 10 that. I think under the Secretary of State's
- 11 directive, if we participate in her program, we
- 12 have to have our staff do it. So if we wanted
- outside people to do it, we'd be doing it outside
- 14 of the structure of the Secretary of State
- 15 directive.
- 16 BOARD MEMBER MARINELLO: Would this
- 17 help on the paper ballot thing, like, for and
- 18 against and if an audit came out --
- 19 DIRECTOR WHITE: Would this -- would
- 20 this help what?
- BOARD MEMBER MARINELLO: Like, her
- 22 theory on the electronic machines being so
- 23 horrible.
- DIRECTOR WHITE: I don't know. I

- 1 think some people out there is convinced, no
- 2 matter what you do, what you show them.
- 3 And I use the example of my mother.
- 4 She's always afraid of flying. I don't care how
- 5 many times I've told her, how many stats I've
- 6 showed her that it's, you know, safer to fly
- 7 versus going by car, she always felt more
- 8 comfortable riding in my car than getting on the
- 9 airlines with us.
- There's some people you're never going
- 11 to convince. Some you might. And that's what
- 12 the Board has to weigh in this whole situation,
- 13 that if you want to proceed with an audit, I
- 14 think it should be an independent audit.
- But we need to make sure the Secretary
- 16 of State's okay with that because we don't want
- 17 to, I don't think, be in opposition of what she's
- 18 doing also.
- So you guys need to put your minds
- 20 together and, you know, let us know how you want
- 21 to do it, and me and Matt would be more than
- 22 willing to help put something together and maybe
- just send her a letter saying we want to do an
- 24 audit; would you sign off on this procedure and

- 1 this protocol, would be my suggestion.
- DEPUTY DIRECTOR DAMSCHRODER: Well,
- 3 and I -- yeah. And I don't think the Board -- if
- 4 the Board wants to do something different than
- 5 the Secretary of State's directive, I don't think
- 6 the Board has to ask the Secretary's permission
- 7 to do that.
- 8 I think under the exact same statute
- 9 that she references -- or the Secretary of the
- 10 Boards can do other, you know, things beyond the
- 11 canvas to ensure the accuracy of the vote.
- 12 Obviously, I'm not quoting the statute directly,
- 13 but I think that's within the Board's purview to
- 14 do.
- 15 CHAIRMAN PREISSE: Just back up a tiny
- 16 bit here with how you opened the issue here.
- 17 Eleven other counties have already volunteered,
- 18 and that was her prescribed number, for whatever
- 19 reason. We didn't have any official
- 20 communication with the Secretary of State asking
- 21 for any waiver based on our little recount in
- 22 Bexley, right?
- DEPUTY DIRECTOR DAMSCHRODER:
- 24 Correct. And I think Bill called over there and

- 1 talked to somebody.
- BOARD MEMBER ANTHONY: And, Mr. Chair,
- 3 what I did, I called Antoinette and had her talk
- 4 to Jennifer and just ran it by them. You know,
- 5 if we wanted to do a post-election audit, would
- 6 they have a problem with it?
- 7 And I said that we would probably do
- 8 it a little differently than what they were doing
- 9 it. They're only counting 70 percent of the
- 10 votes. And I didn't know how they were doing the
- 11 audits, whether they were in-house or not.
- 12 And she got back to Jennifer, the
- 13 Secretary of State, and called me and told me
- 14 that she had no problem with us doing it. Now, I
- 15 haven't had any other further communication with
- 16 her at that point.
- 17 CHAIRMAN PREISSE: But the presumption
- 18 is that we had -- so, unofficially, the reaction
- 19 was, no problem if you do your own thing --
- BOARD MEMBER ANTHONY: That's correct.
- 21 CHAIRMAN PREISSE: -- because we're
- 22 looking at a recount here in Bexley, the
- 23 Bexley --
- 24 BOARD MEMBER ANTHONY: Well, there was

- 1 some concern that we do not put the recount in
- 2 that, in the mix, because it has to be a random
- 3 selection. So we'd take the Bexley precinct out.
- 4 CHAIRMAN PREISSE: And what did you
- 5 just say also at the beginning of this matter on,
- 6 we won't know till Friday whether there's an
- 7 automatic --
- 8 DEPUTY DIRECTOR DAMSCHRODER: We won't
- 9 know till Friday, for certain, unless there's an
- 10 automatic recount.
- BOARD MEMBER ANTHONY: And more than
- 12 just Bexley?
- 13 DEPUTY DIRECTOR DAMSCHRODER:
- 14 Correct. I mean, it's entirely possible. You
- 15 know, Canal Winchester Schools were closed,
- 16 Reynoldsburg Schools were closed, but not within
- 17 the 1/2 or 1 percent.
- 18 Based on all the provisionals and
- 19 other absentees that we've done and the overvoted
- 20 stuff, it's possible that other contests that
- 21 maybe weren't as close are now as close. Again,
- 22 we won't know that for sure until Thursday.
- DIRECTOR WHITE: I agree with Matt
- that you don't have to ask her approval to do

- 1 this, but I think we should so that she buys
- 2 into --
- 3 CHAIRMAN PREISSE: Well, I agree. If
- 4 we're going to do something, we ought to do it at
- 5 or above, if we can demonstrate that --
- 6 DIRECTOR WHITE: Right.
- 7 CHAIRMAN PREISSE: -- her standards
- 8 for this given test audit. Because we're trying
- 9 to gain credibility, preserve credibility.
- 10 BOARD MEMBER ANTHONY: Mr. Chair, if
- 11 we --
- 12 CHAIRMAN PREISSE: Were you going to
- 13 move to adjourn?
- 14 BOARD MEMBER ANTHONY: No, I'm
- 15 not -- not yet. Is there a time line?
- 16 DEPUTY DIRECTOR DAMSCHRODER: I think
- 17 the Secretary's time line for her directive is
- 18 that we have to begin no later than the 9th and
- 19 be finished with the audit no later than the
- 20 12th.
- BOARD MEMBER ANTHONY: Can we do that?
- 22 Are we able to get that done?
- 23 DEPUTY DIRECTOR DAMSCHRODER: Yeah. T
- 24 mean, that will require working through that

- 1 weekend, but that's not necessarily --
- 2 CHAIRMAN PREISSE: Internally, we
- 3 could get it done. If you were going to bring in
- 4 a third party, it's --
- 5 DIRECTOR WHITE: Well, she already has
- 6 11 counties doing it her way, the way she wants
- 7 the audit. I don't really think we should
- 8 handicap ourselves with her time frames, as long
- 9 as she buys into what we do.
- I think we should take the audit even
- 11 further steps, maybe increase the percentages,
- 12 have an outside credible, maybe, several sources
- 13 or organizations that are involved in it. It
- 14 would take longer to put together and to put the
- 15 process together, get involved.
- 16 BOARD MEMBER ANTHONY: You don't
- 17 think -- Mr. Chair, you don't think she'll take
- 18 this as a -- us trying to embarrass her?
- 19 DIRECTOR WHITE: We're not trying to
- 20 embarrass her. Let her sign off on whatever
- 21 procedure we use.
- 22 CHAIRMAN PREISSE: In a vacuum,
- 23 perhaps. But what we're trying to do is
- 24 subscribe to her suggested confidence-building

- 1 measure out there. Or, the reverse, if we have a
- 2 problem with this audit or any other county, this
- 3 might help expose it or confirm that we're okay.
- 4 So we're just -- hopefully, if we've
- 5 missed the window because of our recounts or what
- 6 have you, I think we still agree with her that it
- 7 might be a good idea to do a post-election audit.
- 8 DEPUTY DIRECTOR DAMSCHRODER: Well, I
- 9 think maybe two things we could do between now
- 10 and Friday is, one, obviously, we'll know whether
- 11 we do have an automatic recount probably on
- 12 Thursday. Obviously, before the meeting Friday.
- 13 Because we have to certify.
- 14 But Denny and I could also reach out
- 15 to a couple of organizations like the Brennan
- 16 Center for Justice and the Cleveland State
- 17 University Center for election integrity that
- 18 have both done post-election audits and see if we
- 19 can get a bid or a quote of what it would cost to
- 20 have respected outside third-party entities pull
- 21 together to conduct the audit for us.
- DIRECTOR WHITE: In the meantime, you
- 23 can check with her, if you guys are okay with
- 24 that, inform -- I mean, make sure that she's okay

- 1 with it. If we're going to go through all these
- 2 steps, I would like for her to be on board with
- 3 it, too.
- 4 BOARD MEMBER ANTHONY: All right.
- 5 I'll talk with her.
- 6 DIRECTOR WHITE: And we're not trying
- 7 to embarrass her or -- and the bottom line is,
- 8 you know, we want an audit.
- 9 BOARD MEMBER ANTHONY: We want to make
- 10 sure there's going to be an open and fair
- 11 election.
- 12 DIRECTOR WHITE: Let the chips fall
- 13 the way they fall.
- 14 CHAIRMAN PREISSE: Any other business?
- 15 DEPUTY DIRECTOR DAMSCHRODER: Just the
- 16 last one, real quickly. We put in everybody's
- 17 packet a draft overtime and compensatory time
- 18 policy. It's consistent with the County
- 19 Commissioner's policy for their employees.
- The way we've been doing it,
- 21 particularly, the payout and accrual of comp time
- is, frankly, not good. So we're trying to bring
- 23 it up to speed with both the rest of the county
- 24 policies and with the law.

- 1 DIRECTOR WHITE: Just review that and
- 2 take as much time as you want. Maybe go at the
- 3 next meeting, the following meeting, or the
- 4 regularly-scheduled meeting.
- 5 BOARD MEMBER ANTHONY: Mr. Chair --
- 6 DEPUTY DIRECTOR DAMSCHRODER: Ideally,
- 7 I'd like to have it done by Friday, only because
- 8 of some other things that have happened.
- 9 BOARD MEMBER ANTHONY: Do you want us
- 10 to vote on this?
- 11 DEPUTY DIRECTOR DAMSCHRODER: Not
- 12 tonight. Maybe Friday.
- 13 CHAIRMAN PREISSE: And we could put it
- 14 on the agenda with --
- 15 DEPUTY DIRECTOR DAMSCHRODER: For
- 16 Friday.
- 17 CHAIRMAN PREISSE: For Friday, for
- 18 consideration.
- DEPUTY DIRECTOR DAMSCHRODER: Right.
- BOARD MEMBER ANTHONY: Mr. Chair, I
- 21 move that we adjourn.
- BOARD MEMBER MARINELLO: Second.
- 23 CHAIRMAN PREISSE: Sounds like a good
- 24 idea. Anybody in favor?
