1 2 PROCEEDINGS DIRECTOR ANTHONY: I'd like to call the 5 Franklin County Board of Elections Meeting to order. I'll do a roll call. 6 Kim Marinello? BOARD MEMBER MARINELLO: Here. 8 9 DIRECTOR ANTHONY: Zach Manifold? 10 BOARD MEMBER MANIFOLD: Here. 11 DIRECTOR ANTHONY: Michael Colley? 12 BOARD MEMBER COLLEY: Here. 13 DIRECTOR ANTHONY: And Doug Preisse is not able to come. 14 15 First item on the agenda, I did 16 already. It's going to be one of the shortest 17 meetings in record here. 18 The next item on the agenda, we want to talk about the Election Administration Plan. 19 20 in '09, the Secretary of State, because of a 21 lawsuit filed by the League of Women Voters, they had the -- basically, had a list of the items that 22 23 every Board of Election had to complete and have a 24 plan on file. And what you have in front of you is

- 1 the outline of that plan as directed by the
- 2 Secretary of State.
- 3 Last year, towards the end of the year,
- 4 the Secretary of State -- we had submitted a plan,
- 5 basically, just following these -- I think there's
- 6 16 items in here. Something like that.
- 7 We followed them and we didn't have any
- 8 problems with them, but last year there was some
- 9 concern about our plan. And so Matt and I, at the
- 10 time, had decided that we needed to have a
- 11 professional company come in and take a look at our
- 12 Election Administration Plan, which was pretty much
- 13 our standard operating procedure.
- 14 It's what it really boiled down to, how
- 15 you do the election from the time you -- you know,
- 16 everything about it, actually: Voter registration,
- 17 how we -- how we prepare the machines, how we find
- 18 locations, how we allocate machines, how we train
- 19 poll workers, how we enter data. Every aspect of
- 20 our operation is actually covered by this Election
- 21 Administration Plan.
- So we submitted one, and that was
- 23 pretty much our operating procedures from each of
- 24 the departments. It ended, then, about a 500 page

- 1 report. And it was kind of hard to look at; hard
- 2 to read. And so we decided we would need to go in
- 3 and have a professional company come in and
- 4 actually produce one for us.
- 5 Cuyahoga County is the only county I
- 6 know of -- that I know of that has a real -- a plan
- 7 that really follows this. It looks like it was
- 8 professionally done. And so we basically -- not
- 9 copying theirs, but we're having -- this company's
- 10 called --
- DEPUTY DIRECTOR BURD: Babbage --
- DIRECTOR ANTHONY: -- Babbage --
- DEPUTY DIRECTOR BURD: -- Simmel.
- 14 DIRECTOR ANTHONY: Babbage Simmel.
- DEPUTY DIRECTOR BURD: Babbage Simmel.
- DIRECTOR ANTHONY: Babbage Simmel, what
- 17 a name. But this is what they do professionally.
- 18 They do a lot of writing -- business writing and
- 19 developing plans for how businesses operate.
- 20 So Matt and I sat down with them last
- 21 year, and we had them do a quote, and we talked to
- 22 them. And then Nathan and I had sat down with
- 23 them -- twice already?
- DEPUTY DIRECTOR BURD: Uh-huh.

- 1 DIRECTOR ANTHONY: Has it been twice?
- 2 Yeah.
- 3 And further showed them the outline of
- 4 what we would like to see done. And we would like
- 5 to get this done, because it is something, I think,
- 6 that will serve us well, and -- because it will,
- 7 basically, go to the day-to-day operation of our
- 8 Election Board, and I think it's something that we
- 9 need to do.
- So before we decide to -- just to vote
- on it, we thought we'd share this with you all so
- 12 you could at least take a look at it and the types
- of stuff that they're -- that they're going to be
- 14 doing for us.
- Now, in this -- like I said, this
- 16 little four-page or five-page -- this four-page
- 17 document turned into 500 sheets of paper by the
- 18 time we tried to get it down there, so there is a
- 19 lot of work within these four pages that I think is
- 20 something that we need and it needs -- you know, we
- 21 need to get it done as quickly as possible.
- DEPUTY DIRECTOR BURD: All right.
- 23 Yeah, the Secretary of State will ask for this, I
- 24 think it's 120 days prior to each even-year general

- 1 election. They'll also ask for it two months ahead
- of the next Presidential Primary, so we're trying
- 3 to be a little bit ahead of the curve in getting
- 4 this done now. It's going to take some time, with
- 5 a county of our size, to pull this information all
- 6 together in a very coherent document.
- 7 If you want to see our current plan,
- 8 you all approved it -- I think it was last
- 9 September.
- 10 BOARD MEMBER COLLEY: Yeah.
- DEPUTY DIRECTOR BURD: I can e-mail a
- 12 PDF to you. It is 586 pages. It's not easy on the
- 13 eyes, but if you want to see what we're using now,
- 14 I can get it to you, but we think that this
- 15 company, once we finalize the plans with them, will
- 16 be able to get us what we need; and, hopefully, get
- 17 us a plan that can be a model for the entire state,
- 18 so that's what we're hoping.
- BOARD MEMBER MARINELLO: How did you
- 20 find those people? They just --
- DIRECTOR ANTHONY: Matt knew of them.
- BOARD MEMBER MARINELLO: Oh.
- DIRECTOR ANTHONY: So I have no --
- BOARD MEMBER MANIFOLD: Are we on

- 1 contract yet, or --
- 2 DIRECTOR ANTHONY: They are on
- 3 state-term contract --
- BOARD MEMBER MANIFOLD: Okay.
- 5 DIRECTOR ANTHONY: -- so we don't have
- 6 to go through, you know, bidding this out or
- 7 anything, because they are on state-term contract.
- BOARD MEMBER MARINELLO: How much do
- 9 they charge?
- 10 DIRECTOR ANTHONY: Well, we're looking
- 11 at the cost. It's going to be anywhere between --
- 12 what was it?
- DEPUTY DIRECTOR BURD: Well, we haven't
- 14 really finalized yet.
- DIRECTOR ANTHONY: Yeah.
- DEPUTY DIRECTOR BURD: We're going back
- 17 and forth. There's a potential that they would
- 18 want to have one or two people here on almost a
- 19 full-time basis exploring our procedures. If they
- 20 do that, it could be a substantial amount of money.
- 21 It could be -- I think one quote they gave us was
- \$80,000, but we're still in talks with them about
- 23 what we can do to get a quote that works for
- 24 everyone.

- 1 If they do have to have people here for
- 2 months and months, it's going to be a pretty big
- 3 chunk of money, but we're not exactly finalized yet
- 4 with them on what that may be.
- 5 And this would be a one-time expense.
- 6 This would not be something we do every year. We
- 7 would get the basic look and feel of it and then
- 8 only revise it as needed from this point forward.
- 9 But we're not clear yet on exactly what the charge
- 10 would be, and we won't know that until we are ready
- 11 to bring it forward for more consideration.
- BOARD MEMBER MANIFOLD: Do we have
- 13 anything in our budget for -- are we allotted for
- 14 it, or --
- DIRECTOR ANTHONY: We were able to move
- 16 some stuff around for it --
- BOARD MEMBER MANIFOLD: Okay.
- DIRECTOR ANTHONY: -- and we had the
- 19 budget here. I don't know if it's -- talk to -- I
- 20 don't know. No, this, we just want to talk about
- 21 it --
- DEPUTY DIRECTOR BURD: We have a --
- DIRECTOR ANTHONY: -- but we were --
- 24 DEPUTY DIRECTOR BURD: We have a

- 1 professional services portion --
- DIRECTOR ANTHONY: Yeah.
- 3 DEPUTY DIRECTOR BURD: -- of the budget
- 4 that has funds available if we are to chose to use
- 5 it this way, but that's still something we want to
- 6 look into a little bit further, too.
- 7 BOARD MEMBER MANIFOLD: Okay. I know
- 8 when we had this discussion in the fall, the County
- 9 Commissioners agreed that we needed to have some
- 10 sort of --
- DEPUTY DIRECTOR BURD: Right.
- BOARD MEMBER MANIFOLD: -- professional
- document put together, so it's good.
- 14 DEPUTY DIRECTOR ANTHONY: Right. You
- 15 remember when we were there?
- BOARD MEMBER MANIFOLD: Yeah --
- DEPUTY DIRECTOR ANTHONY: Okay.
- 18 BOARD MEMBER MANIFOLD: -- with the
- 19 administrator.
- DIRECTOR ANTHONY: And we would have to
- 21 do it this budget cycle, so we would need to get it
- 22 done sooner than later.
- So that's all I had, and you also have,
- 24 I guess, our budget.

- DEPUTY DIRECTOR BURD: Yeah. This is a
- 2 report that our fiscal services manager passed out.
- 3 It just shows the year-to-date budget activity, so
- 4 if you want to review that. If you have any
- 5 questions, please give us a call. We can certainly
- 6 address questions next time we're together as well,
- 7 but she just put this together for us today. So
- 8 take a look at that if you can and then we'll
- 9 address any questions you may have later on.
- 10 DIRECTOR ANTHONY: And that's all I
- 11 had. Do you have anything else, Nathan?
- 12 DEPUTY DIRECTOR BURD: No, I have
- 13 nothing else for today.
- 14 DIRECTOR ANTHONY: And is there a
- 15 motion to adjourn?
- 16 BOARD MEMBER MANIFOLD: I think I make
- 17 a motion to adjourn.
- 18 DIRECTOR ANTHONY: Is there a second?
- 19 BOARD MEMBER MARINELLO: Second.
- 20 DIRECTOR ANTHONY: All those in favor
- 21 say aye?
- BOARD MEMBERS: Aye.
- DIRECTOR ANTHONY: We stand adjourned.
- 24 Thank you to everybody.
