DIRECTOR ANTHONY: We will now call the Franklin County Board of Elections Special Meeting to order. I will do the roll call. Kimberly Marinello.

MEMBER MARINELLO: Here.

DIRECTOR ANTHONY: Gregory Haas.

MEMBER HAAS: Here.

DIRECTOR ANTHONY: And Bradley Sinnott.

MEMBER SINNOTT: Here.

DIRECTOR ANTHONY: Mr. Chair, we have a quorum.

First item on the agenda will be approval of the minutes from February 1.

MEMBER MARINELLO: I move that the Board approve the minutes of the February 1, 2016, meeting of the Franklin County Board of Elections as submitted.

DIRECTOR ANTHONY: Is there a second?

MEMBER SINNOTT: There is.

DEPUTY DIRECTOR PAYNE: I'm sorry.

DIRECTOR ANTHONY: All those in favor say aye.

1           The next item on the agenda --

2           DEPUTY DIRECTOR PAYNE: Mr. Director, I  
3 was wondering if it would be appropriate, we had a  
4 member of our staff today pass away.

5           DIRECTOR ANTHONY: That would be  
6 appropriate.

7           DEPUTY DIRECTOR PAYNE: Brenda Essig and  
8 she was 53 years old and she had a number of  
9 grandchildren and had at least two daughters that I'm  
10 aware of and she took a leave of absence a couple of  
11 weeks ago and we just got word today, Renee, right,  
12 she passed away?

13          DIRECTOR ANTHONY: Wow.

14          MEMBER SINNOTT: What will we do as a  
15 Board in response? Fortunately this doesn't happen  
16 often. Do we do a card?

17          DEPUTY DIRECTOR PAYNE: I know a card was  
18 going around today, and I think a number of us will  
19 probably go to the calling hours.

20          MEMBER SINNOTT: That's very sad news.

21          DIRECTOR ANTHONY: She had been battling  
22 some illness too so. Great lady.

23          The next item on the agenda will be the  
24 selection of a Temporary Chairperson.

1                   MEMBER HAAS: I move that the Board  
2 appoint Brad Sinnott as the Temporary Chairman for  
3 the purpose of reorganization.

4                   MEMBER MARINELLO: Second.

5                   DIRECTOR ANTHONY: All those in favor.

6                   The motion carries, Mr. Chairman.

7                   The next item of business is to appoint a  
8 Director, and I would like to submit my name.

9                   MEMBER SINNOTT: I don't think you are a  
10 member of the Board.

11                   MEMBER MARINELLO: Okay. I move that the  
12 Board -- let me think about that for a minute. I  
13 move that the Board appoint William Anthony as the  
14 Director of the Franklin County Board of Elections at  
15 a compensation rate of \$59.24 per hour.

16                   DIRECTOR ANTHONY: Is there a second?

17                   MEMBER HAAS: Second.

18                   DIRECTOR ANTHONY: This group is hard.

19 All those in favor.

20                   The motion carries.

21                   I guess at this point I need to be sworn  
22 in. Is that the way it works or does it --

23                   DEPUTY DIRECTOR PAYNE: Or we can do both  
24 at the same time presuming there is another

1 appointment. I am not sure I did the proper amount  
2 of lobbying.

3 MEMBER SINNOTT: You are not a member of  
4 the Board either. Why don't we do it at the same  
5 time.

6 DIRECTOR ANTHONY: Okay. The second item  
7 on the agenda would be the appointment of my friend  
8 David Payne as the Deputy Director.

9 MEMBER SINNOTT: Well, I think that's an  
10 excellent recommendation, Director Anthony. I move  
11 that the Board appoint David Payne as the Deputy  
12 Director of the Franklin County Board of Elections at  
13 the compensation of \$59.24 per hour.

14 MEMBER HAAS: Second.

15 DIRECTOR ANTHONY: All those in favor.  
16 That motion carries as well.

17 We now have Judge Cindy Morehart in the  
18 audience, and she will swear the Board in.

19 MEMBER SINNOTT: Welcome, Judge.

20 JUDGE MOREHART: Thank you.

21 DIRECTOR ANTHONY: Anybody taking  
22 pictures? Should we step by the flag? Let's step by  
23 the flag. We're Americans.

24 (Judge Morehart swore in Mr. Anthony as

1 Director and then Mr. Payne as Deputy Director.)

2 MEMBER SINNOTT: Congratulations to Bill  
3 and David. We look forward to your continued  
4 service.

5 DEPUTY DIRECTOR PAYNE: Thank you.

6 DIRECTOR ANTHONY: The next item on the  
7 agenda would be the appointment of a -- of a Chairman  
8 of our Board of Elections.

9 MEMBER SINNOTT: Well, I have spoken to  
10 Doug Preisse. He has been serving as Chair, and he  
11 tells me he would be interested in continuing service  
12 if that's the pleasure of the Board, so I am pleased  
13 to move that the Board appoint Douglas Preisse as  
14 Chairman of the Franklin County Board of Elections.

15 DIRECTOR ANTHONY: Is there a second?

16 MEMBER MARINELLO: I'll second that.

17 DIRECTOR ANTHONY: All those in favor say  
18 aye.

19 MEMBER SINNOTT: Doug is appreciative I  
20 know.

21 DIRECTOR ANTHONY: He called and told me  
22 too.

23 Now for the appointment of we call all of  
24 our employees full-time clerks even though they have



1 working titles. By law they are all considered  
2 clerks. And at this point we need to appointment all  
3 of our full-time clerks, and we have a list on  
4 Exhibit A for you. And that will show you the -- all  
5 the employees and their hourly wage. Instead of  
6 going through them, we'll just submit this document.

7 DEPUTY DIRECTOR PAYNE: There were 44  
8 positions. 43 of those are presently filled. There  
9 is a vacant position that is a Democrat position that  
10 we could fill at some point, but I think we need to  
11 approve that, at least the pay for that position, if  
12 you are so inclined. And there are no pay raises in  
13 here other than the 2 percent pay raise that you --  
14 the Board was nice to approve at our last meeting.

15 MEMBER SINNOTT: All right. Well, then I  
16 move the Board appoint employees listed on Exhibit A  
17 as full-time clerks of the Board and fix as their  
18 hourly compensation the rates listed with their  
19 respective names.

20 DIRECTOR ANTHONY: Is there a second?

21 MEMBER HAAS: Second.

22 DIRECTOR ANTHONY: All those in favor say  
23 aye. And we will swear the employees in I believe  
24 tomorrow? Tomorrow morning.

1           The next item on the agenda would be  
2 every year we enter into a contract with Kids Voting,  
3 and we use the children, these kids, in the high  
4 schools as -- as our Youth at the Booth folks. We  
5 have been doing it now I am not even sure how many  
6 years now but for a number of years.

7           Steve, do you know how many years we have  
8 been doing this?

9           DEPUTY DIRECTOR PAYNE: You want to stand  
10 up and give 30 seconds of Youth at the Booth and this  
11 contract, if you wouldn't mind, Steve?

12          MR. BULEN: You said 45 earlier.

13          DEPUTY DIRECTOR PAYNE: What's that?

14          MR. BULEN: You said 45 seconds.

15          DEPUTY DIRECTOR PAYNE: Oh, okay, 45.

16          MR. BULEN: Mr. Chairman, members of the  
17 Board, we began our partnership with Kids Voting in  
18 2005, and since that time we've used 13,170 high  
19 school students to serve as precinct election  
20 officials, and those students represent 59 Franklin  
21 County high schools. And so we look forward to a  
22 continued relationship with them. This election we  
23 will use 270 students, and usually the spring is a  
24 little lower than the fall. For instance, last

1 election we had 638. They are a great resource and  
2 most serve as machine judges but would be great to  
3 have that relationship as we move forward.

4 DIRECTOR ANTHONY: And don't we have some  
5 that end up becoming poll workers after they get out  
6 of high school?

7 MR. BULEN: Yes, many of them stay  
8 location managers for us so.

9 DIRECTOR ANTHONY: It's a great program.  
10 We used to be on the Board of that, of Kids Voting,  
11 but they moved to the Education -- I know I  
12 shouldn't, Educational Service Center and ended up  
13 taking over the role of Kids Voting. And so since  
14 then they've been doing it, and we can, I hope,  
15 continue our support for this organization.

16 And when I go across the country, when we  
17 go to conferences and stuff, we talk about this, and  
18 some folks are like, wow, that's a great program. It  
19 really is. It takes voting and all that right to the  
20 high school, and hopefully we are teaching a  
21 generation of kids the importance of voting.

22 DEPUTY DIRECTOR PAYNE: I believe there  
23 is a contract and we ran that by the County  
24 Prosecutor's Office and they thought it seemed

1 appropriate.

2 MEMBER MARINELLO: I think it's a great  
3 program too, and I move that the Board give  
4 authorization to enter into a contract with the  
5 Educational Service Center of Central Ohio (Kids  
6 Voting Central Ohio) for an amount not to exceed  
7 \$45,000 and thank Kids Voting for their continued  
8 participation in the Franklin County Board of  
9 Elections' Youth at the Booth program.

10 MEMBER SINNOTT: Second.

11 DIRECTOR ANTHONY: All those in favor.

12 That motion carries.

13 I am passing around the contract that  
14 needs your guys' signature on it. There is two of  
15 them.

16 DIRECTOR ANTHONY: The next item on the  
17 agenda would be the purchase of 15 desktop computers.

18 Carol, you want to talk about that?

19 MS. GORUP: I will. I am not sure I want  
20 to.

21 Every year we buy computers to replace  
22 computers that are out of warranty, and we do it a  
23 few of them every year so we don't try to buy 44 new  
24 computers all at once. And the ones we retire

1 actually end up in our -- what we call our stable for  
2 special projects where we have to set up 25, 35  
3 computers for petition checking, provisionals. And  
4 that's about it. If you have any questions.

5 DIRECTOR ANTHONY: The total cost is  
6 \$14,700.10.

7 MEMBER SINNOTT: I move that the Board  
8 authorize the Director and Deputy Director to  
9 authorize the purchase of 15 desktop computers for an  
10 amount of \$14,700.10 to replace the computers no  
11 longer under warranty.

12 DIRECTOR ANTHONY: Is there a second?

13 MEMBER HAAS: Second.

14 DIRECTOR ANTHONY: All those in favor say  
15 aye.

16 That motion carries.

17 And then the next item on the agenda we  
18 have had a number of our employees this election  
19 cycle that are running for their party's central  
20 committee seat. And as such, some of them had a  
21 contested race and the law says if a person has a  
22 contested race, they should not be anywhere near the  
23 live ballot for that -- for that race for that area.  
24 And so we've put -- we've put together -- we put in

1 place a policy that will probably have to be revised  
2 every year to deal with this and I am going to have  
3 Zach get up and it's in your packet as Exhibit B.

4 And, Zach, you want to talk more about  
5 it, please?

6 MR. MANIFOLD: Yeah. Basically the  
7 Revised Code is pretty vague. There is only one  
8 section, 3501.15. I can hand it around to you guys.  
9 I need to take a look. There really -- we started  
10 realizing that, as Bill said, the only real  
11 prohibition in there is you can't -- it specifically  
12 allows elections officials to run for these races.  
13 The only prohibition is working as a poll worker in  
14 that precinct.

15 And so we thought, oh, boy, we really  
16 should probably have some -- at least in writing a  
17 policy or some safeguards down for -- for how our  
18 employees should, you know, try to limit access to  
19 ballots and kind of prevent any ethical conflicts.

20 And so we've got a couple of different  
21 things we did here that we have been using this for  
22 this -- for this election limiting, you know, that  
23 any -- any employees in the vote center that have a  
24 contested race will not be issued personal electronic

1 ballots, PEBs, so they cannot process voters on  
2 voting machines. They have no access to voting  
3 machines. The e-pollbooks in the vote center have  
4 all been programmed to let us know when a voter comes  
5 in from one of those precincts to pop it up and tell  
6 the keyer and the keyer then tells the supervisor and  
7 the supervisor ensures none of our employees are in  
8 the vote center at the time that voter is in the vote  
9 center.

10 Also absentee ballots by mail,  
11 prohibiting employees from participating in ballot  
12 extraction or tabulation of any ballots for this  
13 primary.

14 Also we also have a program that's called  
15 Xigbar which is how we -- an employee sitting at  
16 their computer, and the ID envelope pops up on the  
17 computer, that's how we validate ballots with the  
18 picture from the ID envelope, the employees in those  
19 contested races have their Xigbar access eliminated.  
20 That way they couldn't process any ballots, if any,  
21 of voters coming through.

22 Also our Relia-Vote sorter in the back  
23 that handles all the ballots coming in, we programmed  
24 it to specifically segregate anybody in the absentee

1 department that had a contested race, that those  
2 ballots would be put off to the side so that nobody  
3 that -- to ensure that none of our employees with  
4 contested races would have access to those -- to  
5 those ballots and then also to make sure they don't  
6 participate in validation, extraction, tabulation.

7           And then also Ray is here. Also we  
8 listed here the provisional ballot processing  
9 prohibiting those employees from processing any  
10 provisional ballot affirmations from those precincts  
11 in which the candidate's name appears on the ballot.

12           The IT department is going to supply a  
13 list of the LIDs which is location IDs so those  
14 locations where those candidates are on the ballots  
15 that they'll again segregate those ballots out and  
16 then also prohibiting employees from extracting  
17 provisional ballots.

18           I put down here at the bottom this policy  
19 would need to be updated probably with every central  
20 committee race just because it will vary on our  
21 ability -- it does vary on our ability to put these  
22 safeguards in place like, for instance, my department  
23 we only have -- we have three employees -- well,  
24 certainly employees that are trained to do the 650



1 ESS tabulators that tabulate absentee ballots. Right  
2 now, we are going to eliminate -- in this policy we  
3 are not going to have any employees with contested  
4 races, but in certain years you could have all three  
5 employees that are trained on equipment not be able  
6 to. We may need to make some adjustments in the  
7 future depending on what employees have races as far  
8 as what -- you can run these sorts of ballots and not  
9 these ones. Right now, we kind of took a more broad  
10 approach to this policy, but it may need to be  
11 tweaked at a future date.

12 MEMBER SINNOTT: Zach, how many members  
13 and employees have contested rates?

14 MR. MANIFOLD: That number has dropped.

15 MR. MACKEY: I think we are down to two.

16 DEPUTY DIRECTOR PAYNE: I think Don Clo  
17 and Beth Fulton doesn't have a contested primary but  
18 her mother is running for state committee so.

19 DIRECTOR ANTHONY: Howard Heard.

20 DEPUTY DIRECTOR PAYNE: Howard, that's  
21 three then.

22 MR. MANIFOLD: We started at eight or  
23 something. For instance, when we were first thinking  
24 about putting this together, we had a lot more

1 concerns about what -- how limited we could be, but  
2 now, we only have three races, so we were able to  
3 kind of put more safeguards in place.

4 MEMBER HAAS: All right. I move that the  
5 Board adopt the Elections Safeguard Policy for BOE  
6 employees with contested central committee races in  
7 the March 15, 2016, Primary on Exhibit B.

8 DIRECTOR ANTHONY: Is there a second?

9 MEMBER MARINELLO: Second.

10 DIRECTOR ANTHONY: All those in favor say  
11 aye.

12 That motion carries.

13 The next item on the agenda would be we  
14 had some candidates withdraw and that's on Exhibit C.  
15 Do you want to talk about this, Jeff?

16 MR. MACKEY: So we did have three  
17 judicial candidates come in this week, and over the  
18 last several weeks since the last meeting we have had  
19 seven Democratic County Central Committee candidates  
20 express their desire to withdraw from the Primary  
21 Election. They are listed there for you.

22 MEMBER SINNOTT: Well, that seems  
23 self-explanatory. I move that the Board accept the  
24 request of the following candidates on Exhibit C to

1 withdraw as a candidate and that their votes not be  
2 counted for the March 15, 2016, Primary Election.

3 DIRECTOR ANTHONY: Is there a second?

4 MEMBER HAAS: Second.

5 DIRECTOR ANTHONY: All those in favor.

6 Motion carries.

7 Is there a motion for adjournment?

8 MEMBER SINNOTT: There is.

9 MEMBER HAAS: So moved -- second.

10 DIRECTOR ANTHONY: Properly moved. Is  
11 there a second?

12 MEMBER HAAS: Second.

13 DIRECTOR ANTHONY: We stand adjourned.

15 2:04 p.m.)

## **Election Safeguards for Employees with Contested Central Committee Races – Primary Election 2016**

With certain Franklin County Board of Elections employees facing contested races for Central Committee offices, the Board has adopted the following plan to limit access to ballots on which they appear as a candidate so as to prevent any ethical conflicts.

### **Early Vote Center**

- Employees with contested central committee races will not be issued a PEB thereby precluding them from processing any voters on the electronic voting machines.
- The e-pollbooks have been programmed with a message that informs the processing clerks that a voter resides in one of the contested precincts. When the message appears, the clerks have been trained to notify their supervisor and the supervisor will ensure that none of the employees in contested central committee races are present in the Vote Center at the time of voting for those individuals.

### **Absentee Ballots by Mail**

- Employees with contested races will be prohibited from participating in ballot extraction or tabulation on any ballots for the March 15, 2016 primary election.
- Employees with contested races will have their access removed from the SigVar program that is utilized to validate absentee ballot ID envelopes.
- The Reliavote sorter has been programmed to segregate incoming ballots which contain contested central committee races of employees. Those ballots will be processed separately to ensure that no employee in a contested race has access to those ballots throughout the validation, extraction or tabulation process.

### **Provisional Ballot Processing**

- Employees with contested Central Committee races as well as family members of those candidates will be prohibited from processing any provisional ballot affirmations from precincts in which the candidate's name appears on the ballot.
- The IT department supplies a list of LIDs in which the ballot displays the candidate's name and those LIDs will be isolated from the employee. The employee is prohibited from processing any part of the affected provisional ballot affirmations.
- The employee will be prohibited in participating in provisional ballot extraction.

This policy may need to be reviewed for possible updating prior to each election where Central Committee races appear on the ballot. Employees impacted will vary from election to election and this could impact which safeguards are practical for election administration.
