3	MR. PAYNE: Let's call this meeting
4	to order. Appears we have a quorum. I will do a
5	roll to make sure.
6	Kim Marinello.
7	MS. MARINELLO: Here.
8	MR. PAYNE: Michael Sexton.
9	MR. SEXTON: Here.
10	MR. PAYNE: Michael Preasse.
11	CHAIRMAN PREASSE: Here.
12	MR. PAYNE: Brad Sennott.
13	MR. SENNOTT: Here.
14	MR. PAYNE: We indeed have a
15	quorum. There were no minutes to approve. So the
16	first item on the agenda is the paper ballot
17	allocation for August 7th. I believe this is the
18	third time that we've done it.
19	AUDIENCE PARTICIPANT: Yes, third
20	time within 30 days.
21	MR. PAYNE: Perfect. So let's do
22	that again.
23	AUDIENCE PARTICIPANT: You should
24	have Exhibit A. There's no changes to it, other
25	than we printed the complete report this time.

1	MR. SENNOTT: This seems akin to the
2	second reading.
3	MR. PAYNE: That's correct.
4	MS. MARINELLO: I move the board
5	adopt the paper ballot allocation form in Exhibit A
6	verified by the board staff for the August 7, 2018
7	special election.
8	MR. SENNOTT: Second.
9	MR. PAYNE: All of those in favor,
10	signify by saying aye.
11	CHAIRMAN PREASSE: Aye.
12	MS. MARINELLO: Aye.
13	MR. SENNOTT: Aye.
14	MR. SEXTON: Aye.
15	MR. PAYNE: All opposed, same sign.
16	The motion carries.
17	The next item is the voting machine
18	and E-pollbook allocation for the same election.
19	Again, this is the third time.
20	AUDIENCE PARTICIPANT: This is the
21	third and final reading, I hope. There's been no
22	changes. And we printed the entire report again.
23	MR. SEXTON: Seeing that, I move the
24	board adopt the voting machine allocation formula
25	in Exhibit B, compiled by the board staff for

1	4 August 7, 2018 special election.
2	MR. PAYNE: Is there a second?
3	CHAIRMAN PREASSE: Second.
4	MR. PAYNE: All in favor, signify by
5	saying aye.
6	CHAIRMAN PREASSE: Aye.
7	MR. SENNOTT: Aye.
8	MS. MARINELLO: Aye.
9	MR. SEXTON: Aye.
10	MR. PAYNE: All opposed, same sign.
11	Motion carries.
12	There are two candidates for
13	certification to the November ballot. They are
14	both Libertarians. I believe one you are
15	recommending we certify and the other you are
16	denying certification. So let's start with the one
17	where you are recommending certification.
18	MR. MACKEY: So the Libertarian
19	party circulated petitions this summer. July 13th,
20	Secretary of State informed us that the petition
21	seeking minor party status met the statutory
22	requirements, which led to the ability of
23	candidates to file by July 19th. On July 18th, we
24	received a petition for Jonathan Miller, a
25	candidate for the 15th Congressional District,

1	<sup>5</sup> reviewed the signatures, indicated he had seven
2	valid signatures. Five are required. Staff found
3	the petition was timely filed, valid and
4	sufficient.
5	MR. SENNOTT: So, Jeff, it would
6	appear Mr. Miller would appear on the ballot as a
7	Libertarian?
8	MR. MACKEY: Right.
9	MR. SENNOTT: I move the board
10	certify Jonathan Miller, Libertarian candidate for
11	the 15th Congressional District, to the November 6,
12	2018 general election ballot, and his petitions
13	were timely filed and found to be valid and
14	sufficient.
15	MR. PAYNE: Is there a second?
16	CHAIRMAN PREASSE: Second.
17	MR. PAYNE: All in favor, signify
18	aye.
19	CHAIRMAN PREASSE: Aye.
20	MR. SEXTON: Aye.
21	MS. MARINELLO: Aye.
22	MR. SENNOTT: Aye.
23	MR. PAYNE: All opposed, same sign.
24	Motion carries.
25	In the 12th Congressional District,

1	we have another Libertarian candidate file, I
2	believe you are recommending denying certification.
3	MR. MACKEY: Also, on July 18th,
4	Matthew O'Connor filed a petition for the 12th
5	Congressional District Libertarian party. After
6	reviewing his five signatures, staff found only
7	four to be valid, one was out of the district. He
8	did not meet the sufficient requirements of the
9	petition and we have not found it so.
10	MS. MARINELLO: I move the board
11	deny Matthew O'Connor, Libertarian candidate to the
12	12th Congressional District certification to the
13	November 6th, 2018 general election ballot on the
14	basis that his petitions were found by the staff to
15	be invalid and insufficient.
16	MR. PAYNE: Is there a second?
17	CHAIRMAN PREASSE: Uh-huh.
18	MR. PAYNE: All in favor, signify by
19	saying aye.
20	CHAIRMAN PREASSE: Aye.
21	MS. MARINELLO: Aye.
22	MR. SENNOTT: Aye.
23	MR. SEXTON: Aye.
24	MR. PAYNE: All opposed, same sign.
25	Motion carries.

1	MR. PAYNE: The next item, I just
2	want to address that we did have two local options
3	we were going to bring before the board because
4	this morning there were only two local options that
5	we had filed. Deadline for filing those were
6	August 8th. Today we had eight additional options
7	filed. We simply haven't had the time to go
8	through all of those hundreds or thousands of
9	signatures. So what we are recommending is what
10	we will recommend is not doing those two today
11	because we will have to do the other eight, we will
12	do those some other time.
13	MR. LEONARD: The only reason for
14	doing them today is in hopes they were the only
15	local options.
16	MR. SENNOTT: I don't know what the
17	problem is, we got them this morning.
18	MR. PAYNE: The other thing is we
19	are expecting another one
20	MR. MACKEY: At least two more.
21	MR. PAYNE: Even if we did those, we
22	would still have some others.
23	MR. SENNOTT: Fair enough.
24	MR. PAYNE: There is an item that we
25	would like to discuss of a legal matter, and I

1	don't know if the board would like to go into
2	executive session or do that in open session. But
3	if you care to go into executive session, we will
4	probably need a vote to do so.
5	MS. MARINELLO: Pursuant to Ohio
6	Revised Code Section 121.22(G), I move the Franklin

8	to discuss the imminent litigation.
9	MR. SENNOTT: Second.
10	MR. PAYNE: I believe this requires

2	MR. PAYNE: All those in favor,
3	signify by saying aye.
4	CHAIRMAN PREASSE: Aye.
5	MS. MARINELLO: Aye.

8	MR. PAYNE: All those oppose, same
9	sign.
10	We will open the polls tomorrow at
11	6:30 a.m.
12	I was going to say prior to
13	recessing, do we want to try to figure out dates
14	for the meeting for the
15	MR. LEONARD: We can do that on the
16	record or off the record.
17	MR. PAYNE: There was a directive
18	from the Secretary of State that was a little bit
19	confusing in that it said certification should
20	occur 21 days after the special election, on the
21	17th, which is not 21 days after the election. Our
22	liaison to the Secretary of State called them and
23	found out and they said we are going with the date
24	of the 24th.
25	MR. SENNOTT: So we have to do
l

1	certification by the 24th?
2	MR. PAYNE: We have to do
3	certification by the 24th.
4	MR. LEONARD: Typically, we do it
5	21 days after the election, which would be the
6	28th. But per the directive, it will be the 24th.
7	Given we are the most populous county, we probably
8	should be the last to do it for reporting sake. We
9	didn't last time, we had to go around and get
10	signatures. This one, by being on the very last
11	day, all counties can certify, that we will be able
12	to certify our results and report the results of
13	the other counties.
14	MR. SENNOTT: How soon will our work
15	and their work be completed?
16	MR. PAYNE: Well, it sort of depends
17	on the number of provisional ballots, and we won't
18	know that yet. But we can do a canvas of the other
19	counties after the election and see when they are
20	planning on filing. But typically, the Director is
21	right, we need to be the last county to certify.
22	MR. LEONARD: So set it for the
23	24th. Again, if we find out from a canvas of the
24	other counties that they plan on certifying earlier
25	in the week, we can choose to do the same. Again,

1	all of the counties are addressing one contest, and
2	fairly limited number of provisional ballots
3	likely.
4	MR. PAYNE: And the other item is
5	that, as we mentioned with local options,
6	Wednesday, August 8th is a filing deadline for
7	those, we have to certify those prior to
8	August 20th or on on August 20th or by
9	August 20th. So we are looking at potentially two
10	meetings. One to certify tomorrow's election by
11	the 24th, and the other meeting to certify local
12	options that are being filed on the 8th. Those
13	have to be certified by the 20th.
14	MR. SENNOTT: Is there any chance we
15	could do a single meeting on the 20th?
16	MR. PAYNE: We can check with
17	people.
18	MR. LEONARD: If the other counties
19	are planning to certify. Keep in mind, you really
20	can't start anything until the 20th, because ten
21	days after the date of the election to return
22	overseas absentees, and people have an opportunity
23	to correct provisional ballots that may have left
24	off information. So you really can't do anything
25	official until ten days after the date of the
l	

13 1 election, which would be Saturday, the 18th. So 2 for practical purposes, most counties won't -- that 3 first day they could even consider it would be the 4 20th. We can look into it. 5 MR. SENNOTT: It sounds like we are 6 looking at two meetings then. 7 MR. LEONARD: But they can both be 8 on the week of the 20th, one on Monday, one on 9 Friday. I was thinking also from a docket 10 perspective, your court work, if it's a Friday or a 11 Monday how much flexibility there is versus the 12 middle of the week. 13 MR. SENNOTT: Right now, it would be 14 fine for both Monday and Friday, I quess, for late 15 afternoon, I guess for the schedule. 16 MR. SEXTON: I'm good both of those 17 days. 18 CHAIRMAN PREASSE: I might be out of 19 town. 20 MR. LEONARD: The 20th will be very 21 short, all we are doing is dealing with local options and we are done. It shouldn't be more than 22 23 15 minutes to half hour. 24 MR. SENNOTT: The one on Monday? 25 MR. LEONARD: The one on Monday,

1	yes. The one on Friday will have to be a little
2	bit longer because of all of the steps we do to
3	present you with a provisional ballot, any renames,
4	we have to open, you approve the provisional
5	ballots, they open them, deal with voter intent
6	issues. So Friday would be a little longer.
7	MR. SENNOTT: Second session, so a
8	little time in the morning and little
9	MR. LEONARD: Little time in the
10	afternoon, right. And by the 20th, we should have
11	a better sense of how many provisionals we are
12	looking at. So we may have a better sense whether
13	Friday meeting would have to be a long one or not.
14	MR. SENNOTT: Okay. What I wrote
15	down is late afternoon meeting on the 20th, short
16	meeting on the morning of the 24th, and short
17	meeting on the afternoon of the 24th.
18	MR. LEONARD: Correct, that would be
19	likely scenario.
20	MR. SEXTON: I move the board recess
21	this meeting of board of elections subject to
22	recall until after the close of the election to be
23	held on Tuesday, August 7th.
24	MS. MARINELLO: Second.
25	MR. PAYNE: Kim Marinello.
