4 Monday Morning Session, 1 2 August 20, 2018. 3 DEPUTY DIRECTOR PAYNE: All right. 4 Ιt 5 looks like we have a quorum, but I will take roll to 6 make certain. 7 Kim Marinello. 8 MEMBER MARINELLO: Here. 9 DEPUTY DIRECTOR PAYNE: Michael Sexton. 10 MEMBER SEXTON: Here. 11 DEPUTY DIRECTOR PAYNE: Douglas Preisse. 12 CHAIRMAN PREISSE: Here. 13 DEPUTY DIRECTOR PAYNE: And Brad 14 Sinnott. 15 MEMBER SINNOTT: Here. 16 DEPUTY DIRECTOR PAYNE: We do indeed 17 have a quorum. 18 The first item on the agenda is the 19 withdrawal of referendum of the Upper Arlington 20 Ordinance, and I think we have Exhibit A. 21 Carla, do you want to talk to that? 22 MS. PATTON: And so we received from the 23 committee that put forth the referendum petition on 24 Upper Arlington Ordinance 27-2017 a letter dated 25 August 3rd, we received it on August 6th, requesting

5 that they withdraw the issue from the ballot on 1 2 November 6th, 2018. 3 MEMBER SINNOTT: So are these all the members of the committee or the majority? 4 5 MS. PATTON: Yes, sir. 6 MEMBER SINNOTT: All of them. 7 MS. PATTON: All three members that were 8 named as the committeemen on the ordinary referendum petition have signed this letter of withdrawal. 9 10 CHAIRMAN PREISSE: And that satisfies 11 the requirements for withdrawal? 12 MS. PATTON: Yes, it does. 13 DEPUTY DIRECTOR PAYNE: Are there any other questions or comments from the Board? If not, 14 I'd entertain a motion. 15 MEMBER SEXTON: Mr. Chairman, I move 16 17 that the Board accept the request of petitioners' 18 Exhibit A to withdraw a referendum for Upper 19 Arlington and that the referendum shall not appear on 20 the November 6th, 2018, election ballot. 21 DEPUTY DIRECTOR PAYNE: Is there a 2.2 second? 23 CHAIRMAN PREISSE: Second. 24 DEPUTY DIRECTOR PAYNE: All those signify by saying aye. 25

1	(Vote taken.)
2	DEPUTY DIRECTOR PAYNE: All opposed,
3	same sign.
4	(No response.)
5	DEPUTY DIRECTOR PAYNE: Motion carries.
6	The next item actually, the next two
7	items involve a protest for two local options that
8	this Board certified on July 9th at their meeting.
9	Carla, do you want to talk to let's
10	start with Long & 20th Carryout.
11	MS. PATTON: So Long & 20th Carryout
12	(Discussion off the record.)
13	MS. PATTON: As part of a looking at
14	business that was drying up as part of a question
15	that was given on the May 8th ballot this year, Long
16	& 20th has filed a 29-day rule petition, of which, as
17	David pointed out, we certified to the ballot on
18	November 6th, 2018. However, a protest has been
19	filed on that petition, of which you do have a copy
20	of the protest dated August 8th from Colleen
21	Guezennec. There are several points to this local
22	option protest. You have our response to it in a
23	typed up form. It looks similar to this
24	(indicating).
25	MEMBER SINNOTT: So that is it? Carla,

that's what the Board staff has prepared on the 1 2 subject? 3 MS. PATTON: Yes. 4 MEMBER SINNOTT: Okay. 5 MS. PATTON: It's a single sheet. Ιt 6 addresses the different points, so I don't -- however 7 you wish to proceed, if you want to go through it 8 point by point. The first issue that they pointed 9 out was that --10 MEMBER SINNOTT: Carla, before we do 11 that, if we may, so to sort of frame the issue, we 12 believe that there were 96 ballot signatures upon 13 initial review; correct? 14 MS. PATTON: On the initial review we 15 actually have 98 valid signatures on this particular location, on this particular petition. They needed 16 17 95. They filed 285. So of the 285 we found what we 18 believe to be 98 valid signatures. 19 CHAIRMAN PREISSE: Why does -- why does 20 Ms. Guezennec's letter say 96? 21 MS. PATTON: It may have been the 22 other -- there's another protest, which they would 23 have had 97. I'm not sure where she got the 96 from. 24 MEMBER SEXTON: This one here says 97. 25 MEMBER SINNOTT: The Tee Brother protest

8 speaks in terms of the Board having found 97 valid 1 2 signatures, and on Long & 20th is 96, according to 3 the protestor. MS. PATTON: I'm not -- I'm not sure 4 5 where Miss Guezennec came up with the 96, but our 6 numbers come out to 97 ballots. 7 MEMBER SINNOTT: So we examined every 8 signature, all --9 MS. PATTON: Yes. 10 MEMBER SINNOTT: -- 285 submitted? 11 MS. PATTON: Yes, we did. 12 MEMBER SINNOTT: And our initial review 13 came up with only 98 valid ones? 14 MS. PATTON: That's correct. 15 MEMBER SINNOTT: So that's what we're 16 working with as a floor. 17 MS. PATTON: Which was sufficient enough 18 at the time for us to recommend certification, of 19 which we did July 9th. 20 The first portion of the protest is 21 indicating that the precinct applies to precinct-wide 22 or a portion of a precinct. That is not true. They 23 filled out Petition 5-R, which is a site-specific 24 location, and nowhere does that indicate that it's a 25 precinct-wide nor a portion of a precinct on the face

1 of the petition.

2	The second item of the protest is that
3	the the holder on the the petitioner states
4	that they hold a C1, a C2, and a D5 permit on the
5	face of the petition. However, the protest states
6	that the holder only holds a C2 and C2X, of which we
7	have confirmed with Liquor Control since then. We
8	had not received confirmation from Liquor Control
9	prior to our certification of what permits they had
10	held. However, that is not part of the requirements
11	we are we are required to do of verifying the
12	permit numbers.
13	DEPUTY DIRECTOR PAYNE: And did you talk
14	to the Secretary of State as it relates to
15	MS. PATTON: I have spoke to the
16	Secretary of State, which consulted with legal over
17	there. They have never had a situation like this,
18	and so they have no legal opinion at this time as to
19	whether this is a fatal error or not, so that is in
20	your hands now to decide.
21	I will tell you they indicate that they
22	are C1, C2 liquor permit holders, and a D5 on the
23	petition. A C1 permit allows for beer off premises
24	in original sealed container. A C2 allows for wine
25	and mixed beverages in sealed containers for

carryout, and D5 allows for on premises beer, mixed 1 2 liquor sales. However, the permit -- the petitioner is a holder of a C2 and a C2X, which is wine and 3 mixed in a sealed container for carryout, and the C2X 4 5 is the old version of a C1, which is beer in a sealed 6 container for carryout. MEMBER SINNOTT: So, Carla, this issue 7 8 has to do with the face of the petition mistakenly 9 reciting the types of liquor permits currently held? 10 MS. PATTON: Correct. 11 MEMBER SINNOTT: Each type of permit 12 will allow the permit holder to sell different things 13 under different circumstances? 14 MS. PATTON: Correct. I have spoken 15 with Liquor Control. They would not have a problem 16 processing. If their issue were to appear and pass, 17 they would not have an issue with allowing the sales 18 to continue for this particular location. They just would not get the sales permitted by a D5. 19 Thev 20 would get what they currently hold a petition for --21 or a permit for. 22 MEMBER SINNOTT: Why don't you take us 23 to the next category of protest. 24 MS. PATTON: The next category of the 25 protest are printed signatures.

1	(Discussion off the record.)
2	MS. PATTON: The next category has to do
3	with printed signatures, non-cursive signatures. On
4	Page 5 of the protest you will see a list of the
5	signatures as they appear on the petition on the left
6	side and a copy of the signatures as they appear on
7	our Board's files on the right-hand side. Our
8	tradition as long we tend to give the benefit
9	of the doubt to the voter when signing. If we can
10	find a few letters connected together, we will give
11	them the signature typically.
12	MEMBER SINNOTT: Carla, on the document
13	you prepared it has Ms. Myles.
14	MS. PATTON: Correct.
15	MEMBER SINNOTT: You provided a sample
16	from a prior registration?
17	MS. PATTON: Correct. So Miss Myles is
18	actually part of the next point, which is a
19	non-genuine signature, which we which would be
20	indicated that we would believe that somebody else
21	had signed for the voter. However, the signature on
22	the petition as it appears on Page 6 of the protest,
23	the third signature, Jenelle Myles. The signature we
24	had originally on our file was a printed, but we did
25	find a newer a registration that does have her

12 cursive signature on there (indicating), which is a 1 2 match for what was signed on the petition. CHAIRMAN PREISSE: We don't have as part 3 of this packet what you're holding --4 MS. PATTON: That's on our response. 5 6 You have a copy, the exact copy of this signature. 7 It's on your copy of our response, under, "III, Not Genuine" (indicating). 8 9 CHAIRMAN PREISSE: Oh, I see. The other 10 non-genuine signature is in the third category there 11 under non-genuine signatures. 12 MEMBER MARINELLO: I'm trying to find 13 this Myles person still. 14 MS. PATTON: She's on Page 6 of the 15 protest. 16 (Discussion off the record.) 17 MEMBER MARINELLO: That's my Page 6. Am 18 I in the wrong thing? 19 CHAIRMAN PREISSE: You may --20 MS. PATTON: Are you on the Long & 20th? 21 DIRECTOR LEONARD: You're in the wrong 22 packet. 23 MEMBER SINNOTT: My protests were 24 switched in my folders when I sat down. 25 MEMBER MARINELLO: Okay.

13 1 MEMBER SEXTON: Well, going back, on 2 Page 5, we're just -- how many were -- I have one, 3 two, three, four -- eleven that are in question on Page 5? 4 5 MS. PATTON: Correct. 6 MEMBER SEXTON: And on Page 6 we have 7 four that are in question? MS. PATTON: That is correct. Our 8 9 findings on the Page 6 signatures, before that appear 10 on the signatures, we would -- my opinion would be 11 they would be valid signatures, that there is enough 12 consistency. There are similarities between what's 13 on signature file versus what's on the petition page. 14 MEMBER MARINELLO: On which ones? 15 MS. PATTON: On the four non-genuine 16 signatures on Page 6. 17 DIRECTOR LEONARD: They go over to Page 18 7 as well. 19 CHAIRMAN PREISSE: Some of these are --20 the Xeroxed copies are bad. It's hard to see. I'm 21 not sure how -- how should we adjust that? 22 MEMBER SINNOTT: Well, there are still 23 other issues presented by the protestor, I think. 24 CHAIRMAN PREISSE: There are still other 25 issues?

1	MS. PATTON: Yeah. The next one, Issue
2	4, is the elector's incorrect address that they
3	state. Ryan Wigginton, he wrote 214 North 17th
4	Street. We actually keyed him into our registration
5	as 218, and you have a copy on our findings of how he
6	wrote that address on his registration. We
7	attributed that to typographical error when entering
8	in the registration and had gone ahead and validated
9	Mr. Wigginton's signature on the petition based on
10	that information.
11	CHAIRMAN PREISSE: Okay.
12	MS. PATTON: In regards to Wiley Ross,
13	we concur that we had coded him to the wrong voter,
14	and so we would concur that he needs to be marked as
15	invalidated.
16	CHAIRMAN PREISSE: What does that mean,
17	"coded him to the wrong voter"?
18	MS. PATTON: We assigned we
19	attributed Wiley Ross as the signer of the Wiley
20	Ross signed the petition, but we gave it to Wiley
21	Butler rather than Wiley Ross, and as you can see by
22	the record within the protest, Mr. Ross is registered
23	at a wrong address than what he stated on the
24	petition. Therefore, we would agree that that should
25	be stricken as a validated signature.

15 1 MEMBER SINNOTT: Which would take us to 2 97 valid signatures? 3 MS. PATTON: Right. Issue 5 is the findings on the illegible signature. In our -- in 4 5 our findings presented to you, you will see who we 6 were able to give the credit to and comparison --7 with the signature in comparison to what's signed on the petition, that we were able to find signatures 8 9 that closely represented the voter at the address 10 stated and, therefore, gave him credit. 11 MEMBER SINNOTT: The addresses provided 12 for Sheline and Bradford match --13 MS. PATTON: They matched --14 MEMBER SINNOTT: -- the registration? 15 MS. PATTON: -- what's on the 16 registration. 17 In regards to Item 6, a duplicate 18 signature, the protest claims that the two lines that 19 you see are signed by the same person. They are not. 20 The first signature that you see at 926 East Broad 21 Street is Christopher Erwin, which you can see his 22 signature on the findings that we provided to you, 23 that that is a match of a signature, and he is 24 registered at that address, so we -- that is not a 25 duplicated signature.

1 CHAIRMAN PREISSE: All right. 2 MS. PATTON: Issue 7, the petitioner's 3 signature on petition and as a circulator. As a local option petitioner, you are not -- you are not a 4 5 candidate; therefore, you are allowed to sign your 6 petition for your business if you live within the precinct that the business is located within and the 7 petition is circulated, as long as you are not the 8 9 circulator. He did circulate a petition and sign 10 that petition, of which we did mark that signature as 11 invalid, of signing his own petition that he 12 circulated. However, he did sign another petition 13 that was circulated by someone else, of which we did 14 validate that signature. 15 MEMBER SINNOTT: We did --16 MS. PATTON: And he is registered within 17 the precinct that the petition was being circulated. 18 MEMBER SINNOTT: So he signed two 19 different petitions, one he was circulating himself, 20 so we discounted the signature on that one, but 21 counted it on the other? 22 MS. PATTON: That is correct. 23 CHAIRMAN PREISSE: Let me understand, 24 the current status is that we are counting? 25 MS. PATTON: We counted his signature on

17 1 the petition he did not circulate. 2 CHAIRMAN PREISSE: In the initial 3 examination? MS. PATTON: In the initial examination. 4 5 CHAIRMAN PREISSE: And in consideration 6 of the protest? 7 MS. PATTON: Yes. 8 CHAIRMAN PREISSE: I see, because he 9 changed his address. 10 MS. PATTON: Then the final item, I 11 believe that the protest is improper completion of 12 the circulator's statement. The circulator is 13 supposed to place the address at which he resides on 14 the circulator statement, which he did, as far as we 15 are concerned. He is registered at 1032 East Long 16 Street, and that is how he signed the circulator 17 petition. As far as whether the address is a 18 residence or not, that is beyond our -- he registered 19 at the address, and we had nothing indicating that 20 it's a residence. There are residences out there 21 that have -- there are businesses out there with 2.2 residences located above or somewhere on that 23 address, but that's not our -- that is not an address 24 we have restricted to business only at this time in 25 our records; therefore, we assumed that that's where

18 he resides. 1 2 CHAIRMAN PREISSE: What is this one, 3 Brad, this thing that's (indicating) --MEMBER SINNOTT: It's an affidavit. 4 5 So we show Ibrahim's address as being 6 3556 Whisper Circle Drive at present; is that 7 correct? 8 MS. PATTON: We have him registered at 9 1032 East Long Street. 10 MEMBER SINNOTT: 1032. 11 MS. PATTON: However, on -- it was on 12 his -- his liquor permit information as Whisper 13 Creek, but again, that -- we can't attest as to how 14 up to date that is, and that's beyond our reach for 15 checking someone's residency when registering. That 16 appears to be from a court case (indicating). 17 MEMBER SINNOTT: The protestor 18 represents that it's a -- something found in Franklin 19 County Municipal Court Clerk records as -- related to 20 a traffic offense in July of 2018. 21 CHAIRMAN PREISSE: Well, this is --22 MS. PATTON: In regards to a circulator 23 statement, the law does not require that a circulator 24 of a local option petition be registered; therefore, 25 that is one of those items that we don't check since

19 1 it's not a requirement that -- we simply check to 2 make sure that the information is filled in. MEMBER SINNOTT: So the staff's opinion 3 is that there is still 97 valid signatures after 4 5 considering each issue raised by the protest; is that 6 correct? 7 MS. PATTON: That is correct. However, 8 it's your discretion on the printed signatures as to 9 whether we accept those and validate those. 10 MEMBER MARINELLO: Those aren't included 11 in this? 12 MS. PATTON: Those are considered valid 13 signatures at this point in time. Those would be 14 part of the 97 valid signatures. 15 CHAIRMAN PREISSE: Is there anyone who 16 wants to speak in support of the protest that's in 17 the audience? Is there anyone who wishes to speak in 18 support of the protest, in favor of the protest? 19 Would you like to, ma'am? Could you 20 please come to the podium and state your name and 21 address for the stenographer. 2.2 MS. GUEZENNEC: My name is Colleen 23 Guezennec. 24 CHAIRMAN PREISSE: And I think we'll --25 we'll keep it to five minutes, if we can. Say your

20 1 name again, Colleen. 2 MS. GUEZENNEC: It's Colleen Guezennec. 3 CHAIRMAN PREISSE: Guezennec. Okay. We had it close. Thanks. 4 5 MEMBER SINNOTT: Are you a member of the 6 bar? I don't know if you're appearing here in your 7 personal capacity or as a representative of someone, a local representative? 8 9 MS. GUEZENNEC: Oh, no. I'm here as 10 myself. 11 MEMBER SINNOTT: Okay. Do you intend on 12 offering observations of fact or are you just going 13 to share with us argument? 14 MS. GUEZENNEC: I think I'm just going 15 to operate from fact because I think the facts are 16 strong enough. 17 MEMBER SINNOTT: Okay. 18 CHAIRMAN PREISSE: We typically swear 19 the speakers in for the record. 20 MS. GUEZENNEC: Would you like to do 21 that? 2.2 CHAIRMAN PREISSE: Yes, please. 23 (Ms. Guezennec was sworn.) 24 CHAIRMAN PREISSE: Thank you. 25 MS. GUEZENNEC: I'd like to start first

21 with -- on Page 4, non-cursive/printed signatures. 1 2 CHAIRMAN PREISSE: This is of your 3 protest document? 4 MS. GUEZENNEC: Yes. 5 CHAIRMAN PREISSE: Page? MS. GUEZENNEC: Four, Page 4. 6 7 CHAIRMAN PREISSE: Okay. 8 MS. GUEZENNEC: You know, actually, 9 let's see -- oh, yes. By the way, I want to rewind 10 just a bit. There seems to be -- there seems to be a little confusion. 11 12 Carla, did you say 98 validated 13 signatures? 14 MS. PATTON: Uh-huh. 15 MS. GUEZENNEC: So it's a little 16 difficult because what you do is you get the -- the 17 actual petition, and there's a lot of writing inside, 18 checkmarks, dots, you know, NRRs, NRAs; so we had to 19 learn the language, and when we went through -- this 20 is a group of residents collectively, and when we 21 counted, multiple people counted, and we were looking 22 for the text and we sent Matt Rushay -- I sent Matt 23 Rushay an e-mail saying that basically we couldn't 24 come up with 95, the magic number, 95. By the way, 25 this is in your packets. Okay. And I said, "Can you

1	please double check the Long and 20th files and count
2	the number of valid signatures. I have
3	double-checked the pages you sent, and my total
4	equals 92, three short of what was needed for 7-D
5	based on the required numbers you shared today,"
6	which was 95. "Thank you."
7	And Matt responded, "On two" two
8	parts or, "On two part-petitions, the number of
9	valid signatures written in the upper right-hand
10	corner of the front of the petition was not updated.
11	On one part-petition, the number of valid signatures
12	says '11' but 14 are marked as correct on the
13	backthe other part-petition says '3' but four were
14	actually validated."
15	Okay. So just FYI, from our point of
16	view, that left us really not knowing what signatures
17	they went back and added; okay? Right? That were
18	validated. But based on this so we're at 92. He
19	adds four more. That's 96, not 98. You see that
20	exchange, right, on the last page (indicating)?
21	Okay. I think you have to decide right
22	now are there 98 or are there 96. That's difficult.
23	Okay. Since I only have five minutes, let's get back
24	to the task. Non-cursive printed signatures, okay,
25	it says very clearly I don't want to insult

1 anybody. This is your business, not mine. The 2 reason I put that in there was not for your information, because you know this information, it 3 was for the -- it was for the neighborhood, so the 4 5 neighborhood could understand the thinking of what we 6 were doing, what we were finding; right? So we're 7 just not making this up. We went and looked at the laws. What are the laws, and we put them in the 8 9 document. Now, what wasn't pointed out is that on 10 the top of -- on the top of Page 5, I put four 11 signatures there. Those are four cursive signatures 12 from another petition. There were four petitions 13 turned in to the Board of Elections about this issue in Precinct B and D. If you look at the top of Page 14 15 4 -- 5, sorry, you will see Lori Christy managed to 16 write -- sign in cursive her name on a different 17 petition along with Delmar McGee, Renee Little, 18 and -- well, that's the best I could get. I think 19 his name is Walter, Walter Capers. Your rule -- it's 20 not -- I mean, it's not our rule. The rules say you 21 have to write in cursive. Those folks wrote in 22 cursive on other petitions but not on this one, so I 23 don't see how you could, with a straight face, say 24 hey, it's okay. It's okay that they didn't do it on 25 this petition.

24 1 It's not okay. So now we have two 2 issues, the number is did they have 98 or did they have 96? 3 CHAIRMAN PREISSE: You've exceeded the 4 time, so why don't you take one more minute and wrap 5 6 up. 7 MS. GUEZENNEC: One, two, three, four. You've already taken two away. These -- these four 8 9 are without -- beyond a shadow of a doubt that they 10 were able to write their name somewhere else. Ι 11 don't think that you can say well, you know, we can 12 sort of see where it looks the same. Look, the rule 13 states clearly, Page 4, each signature has to be 14 cursive. So I think we've more than made our case. 15 Thank you. 16 CHAIRMAN PREISSE: Thank you very much. 17 And is there anyone who wants to speak 18 against the protest? 19 (People step forward.) 20 CHAIRMAN PREISSE: How many of you are 21 going to speak? 2.2 MR. SULLIVAN: One. 23 CHAIRMAN PREISSE: Okay. Would you also 24 state your name and address for the record. 25 MR. SULLIVAN: My name is Keith

25 Sullivan, 2236 Marcia Drive. 1 2 (Discussion off the record.) 3 MR. SULLIVAN: Sullivan, S-u-l-l-i-v-a-n. 4 5 CHAIRMAN PREISSE: That was fast, too. 6 (Discussion off the record.) 7 MR. SULLIVAN: 2236 Macria, M-a-c-r-i-a 8 (sic). 9 CHAIRMAN PREISSE: I think we should 10 swear him in too. 11 (Mr. Sullivan was sworn.) 12 MR. SULLIVAN: Okay. I wrote three 13 things down that the lady had stated. First of all, 14 I was the petitioner on those -- for those signatures 15 for Long and Monroe, Silver Market. The 16 signatures -- I sat in this -- in the room across the 17 hall for about three hours each time I came up to try 18 to verify and make sure all these signatures were 19 right to make sure we could get it on the ballot. I 20 then turned them over to the Board of Elections, and 21 they certified them, right, as the signatures, I 2.2 quess. So I don't know where the issue of 95 or 98 23 comes in at all. Okay. 24 As far as signing your name or printing 25 your name, I couldn't find it anywhere where the

26

government requires you -- your signature not sign in 1 2 cursive because they don't even teach it in school anymore. You know, so that's about that. There was 3 an issue with -- that they have on page -- I think 4 5 it's the one where it says the petitioner's 6 signature. I'll just say that part. I signed all of 7 them, and I keep -- whenever I go out and petition, I carry this (indicating). I put it just like this; 8 9 right? If anyone answers the door and I have a 10 feeling that they're not that person that's supposed 11 to sign it, the first thing I do is ask for an ID; 12 you know, hey, you really live here. And usually I 13 know most of the people that live there because I've 14 been there since 19 -- in that community off and on 15 since 1963. I didn't just move into the 16 neighborhood. I've been there. What I would like to 17 say is this, these issues come up every four or five 18 years from somebody new that moved into the community 19 and is trying to stop the sale of alcohol and tobacco 20 in the community, which creates the conditions of 21 gentrification because the store is going to close. 22 There's no major food chain. People in that area, 23 they use these stores not just for beer and wine. 24 Sure, there's people that do, but they have Pampers 25 in there. They have female products in there, they

	27
1	have food. They have other things that is needed in
2	that neighborhood and there's no major food chains
3	around in that neighborhood anyway to supply those
4	things; right? So with them objecting to it, it's
5	just more of the same old/same old to me, because
6	they've done this three or four other times well,
7	three times that I helped defend, that I
8	CHAIRMAN PREISSE: Those may be valid
9	points, but they don't speak to the issues on the
10	paper at all, so the issues on the paper
11	MR. SULLIVAN: I'm not
12	(Discussion off the record.)
13	MR. SULLIVAN: I know the issues that
14	are on that paper because I signed those and I was
15	the petitioner. There was something about the liquor
16	license, the type of liquor license that they had,
17	right, and who owned that liquor license, and we have
18	the paper here, but we brought the liquor license
19	with us, if you'd like to see it.
20	CHAIRMAN PREISSE: I don't think we feel
21	that that is a sticking point, do we?
22	MEMBER MARINELLO: No.
23	CHAIRMAN PREISSE: Any questions?
24	MR. SULLIVAN: Any questions?
25	CHAIRMAN PREISSE: No. Thank you.

1	Carla, can you talk to the issue of the
2	98
3	MS. PATTON: I have gone through, so I
4	have a list of how our system has invalidated versus
5	validated, and I just went through, and there are 98
6	that were marked as validated within the voter
7	registration system. So, you know, as far as may
8	have somebody may have mistakenly handwritten the
9	wrong code on the actual part-petition or they may
10	have just added the numbers up wrong when we pointed
11	out the numbers on the petition itself, so
12	CHAIRMAN PREISSE: You're consulting
13	what document?
14	MS. PATTON: This comes out of our voter
15	registration system to which we validate signatures,
16	and I counted up all the validated signatures
17	throughout the entire list, and I came up with 98.
18	CHAIRMAN PREISSE: With were drawn from
19	the petitions?
20	MS. PATTON: Which came straight yes.
21	MR. LEONARD: There's a petition nodule
22	within our voter registration software that will
23	allow us to track each line as it's entered, what
24	name was looked up, whether it was found valid, so it
25	will actually give you each part-petition, each line

29 1 of the part-petition, and whether the signature on 2 that line of that part-petition was found valid or invalid. If it was found invalid, it will tell you 3 the reason why it was found invalid. 4 5 MEMBER SINNOTT: So our base number is 98? 6 7 MS. PATTON: Yes. 8 CHAIRMAN PREISSE: And so summarizing 9 the staff's response to the protest, we agreed with 10 the protestor in how many cases and did not give --11 and removed the signatures? 12 MS. PATTON: We did -- we did fully 13 concur that Wiley Ross should have been invalidated. 14 He was part of the issue for the elector's incorrect 15 address. We admit that that should be invalidated, 16 bringing us down to 97. 17 MEMBER SEXTON: Is this the one in 18 our -- is this the one in our packet on Page 8, Carla? 19 20 MS. PATTON: Yes. Yes, at the top of 21 Page 8, we do agree that that should have been 22 invalidated. In regards to the printed signatures, 23 we leave that up to your discretion. I believe our 24 staff had some reason to believe that they were 25 valid, whether they put a couple signatures together

30 1 or not. 2 MEMBER SEXTON: So then Wiley Ross, does 3 that -- how is he in the 98 valid signatures? MS. PATTON: He was marked as validated 4 5 because we gave credit to someone -- a different 6 Wiley at that address, so Wiley Butler was registered 7 at the address, and we gave him credit, and it should have been attributed to Wiley Ross who lives at a 8 different address. 9 10 CHAIRMAN PREISSE: In Point 7, circulator and signer, we had not -- we did not 11 12 validated that at the initial review; is that right? 13 MS. PATTON: We did not validate the 14 signature on the petition he circulated himself. CHAIRMAN PREISSE: So he was not part of 15 16 the 98 --17 MS. PATTON: No. 18 CHAIRMAN PREISSE: -- in that instance? 19 MS. PATTON: No. 20 CHAIRMAN PREISSE: Okay. 21 MEMBER SINNOTT: Well, we're sort of 22 tasked, as we often are, with coming up with some 23 sort of -- coming up with a fair process for the 24 consideration of multiple issues when they're 25 presented to us. Let me suggest that we work through

31 1 these issues succinctly, one by one. 2 The first subject of protest seems to be the issue related to the significance of the 3 description of the type of liquor permit presently 4 held. 5 CHAIRMAN PREISSE: I didn't think -- I 6 7 think that's the second issue. Am I misinterpreting this? This has to do with --8 9 MEMBER SINNOTT: Yes. As the protestor 10 describes it here, in this first -- the issue of --11 MS. PATTON: I believe the lack of 12 precinct designation on the part-petitions. 13 MEMBER SINNOTT: That's --14 MS. PATTON: However, there is no field 15 that allows for a designation of precinct on that 16 location -- petition. 17 MEMBER SINNOTT: I think it had to do 18 with the lack of designation of a specific precinct. 19 MS. PATTON: Correct. 20 MEMBER SINNOTT: Is there anyone on the 21 Board who would propose disqualification of the 22 petitions on that basis? 23 MEMBER MARINELLO: No. 24 MEMBER SEXTON: No. 25 MEMBER SINNOTT: Now, the second issue

32 has to do with the description of the type of liquor 1 2 permit held. Is there anyone on the Board who would 3 like to propose that as a basis? 4 MEMBER MARINELLO: No. 5 MEMBER SEXTON: No. 6 MEMBER SINNOTT: I think that takes us 7 over then to the printed signatures subject. Is there anyone who would propose disqualification of a 8 9 particular signature on account of printing as 10 opposed to the cursive-style legal mark required by 11 Revised Code Section 3501.38(B)? 12 MEMBER MARINELLO: Well, like Carla 13 said, they --14 (Discussion off the record.) 15 MEMBER MARINELLO: I'm sorry. You know, 16 her staff must have had a reason to validate them in 17 the first place. 18 MEMBER SINNOTT: I think that everything 19 checks out except for the cursive versus printed. Is 20 that right, Carla? 21 MS. PATTON: Correct. As I said before, we'll give the benefit of the doubt if we can find a 22 23 few connected letters or similarities from what they 24 placed on the petition with what's on file with our 25 Board.

33 1 MEMBER SINNOTT: I would suggest that we 2 pause for a moment and look at Lori Christy, Delmar 3 McGee, Sandra Toler. MEMBER SEXTON: Where is a Sandra 4 5 Toler -- oh, she's on Page 5? MEMBER SINNOTT: Page 5 of the protest, 6 7 yes. Those are the -- and the Ryan Archer name would 8 also be interesting. 9 CHAIRMAN PREISSE: I find significant 10 similarity in the last name Toler as it's rendered in 11 both examples. 12 MEMBER SINNOTT: Well, there seems to be 13 a fine line. Is there anybody who would propose the 14 disqualification of signatures on the basis of a lack 15 of cursive-style legal mark? 16 MEMBER MARINELLO: No. 17 MEMBER SEXTON: I would not. 18 CHAIRMAN PREISSE: I do. 19 MEMBER SINNOTT: This is an instance 20 where I can understand both sides of the argument, so 21 I would probably defer toward counting the signatures 22 and letting it go to the people. 23 MEMBER MARINELLO: I didn't hear you, 24 Brad, I'm sorry. What? 25 MEMBER SINNOTT: I said I -- I can

34 1 understand the arguments both ways about whether 2 these are printed or cursive signatures, so my inclination would be to defer to counting them so 3 4 that the people can have a vote. 5 MEMBER MARINELLO: I agree. 6 CHAIRMAN PREISSE: Walk us through the 7 next one. MEMBER SINNOTT: The next issue 8 9 presented relates to whether the signature that 10 appears on the petition is the signature of the 11 registered voter. 12 CHAIRMAN PREISSE: This is where, Carla, 13 you updated it on the response document. 14 MS. PATTON: Yes. On Jenelle Myles, 15 yes, we have given you an updated copy of her signature on the response, so a cursive-style 16 17 signature versus a printed signature. CHAIRMAN PREISSE: Okay. Thank you. 18 19 MEMBER SINNOTT: I think the question is 20 whether any Board Member would propose 21 disgualification of a signature on the basis that it 2.2 is not that of the registered voter? 23 CHAIRMAN PREISSE: I don't hear anybody. 24 MEMBER SINNOTT: The issue after that is 25 the Wiley Ross versus Wiley Butler subject.

35 MEMBER MARINELLO: He's not included 1 2 anyway, right, in the --3 MEMBER SINNOTT: He is at present. We have to exclude him. 4 5 MS. PATTON: We recommend excluding that 6 signature, as we did invalidate -- we did validate 7 the wrong individual in that case, so that is one signature we are recommending that we invalidate. 8 9 MEMBER SINNOTT: We'll continue the 10 discussion --11 MEMBER SEXTON: Where is his -- I see 12 him at the top of Page 8. 13 MS. PATTON: Yes. 14 MEMBER SEXTON: You're recommending invalidation? 15 16 MS. PATTON: We do, yes. We do concur 17 with the protestor on that, that we did improperly 18 validate the wrong individual with that signature. 19 CHAIRMAN PREISSE: We have to vote on 20 it. 21 MEMBER SINNOTT: I think we can probably 22 do that as part of the motion. I think we'll just continue the discussion, and then we'll have a 23 24 motion. 25 Then I believe the next issue is

36 1 legibility of signatures, and the protestor 2 identifies three signatures here on the bottom of Page 8 at the protest as being the ones in question. 3 4 CHAIRMAN PREISSE: We gave credit 5 because we can see similarities and the address 6 checked out? 7 MS. PATTON: Correct. We searched 8 voters by -- based on the address listed on the 9 petition and were able to find signatures that resembled that which was on the petition. 10 11 CHAIRMAN PREISSE: Okay. That makes it 12 good to me. 13 MEMBER SINNOTT: The next basis for 14 protest would be the allegation that there was a 15 double counting of the signature. 16 CHAIRMAN PREISSE: Right. 17 MS. PATTON: Currently both of those 18 signatures are validated and are part of the 98 valid 19 signatures, and our -- our findings show it is not 20 the same person signing those two lines. 21 CHAIRMAN PREISSE: You've got two 22 registered voters at that address. 23 MS. PATTON: Cleo Simon I believe may --24 may have been invalidated, but Chris Erwin was 25 validated as a legitimate signature.

37 1 MEMBER MARINELLO: Oh, I see. Based on 2 it says Simon or something? MS. PATTON: Right. So Cleo Simon is 3 not at the address, and we appropriately coded that 4 5 voter, whereas Christopher Erwin, the top one, was validated and is not a duplicate signature. 6 7 CHAIRMAN PREISSE: Okay. 8 MEMBER SINNOTT: Cleo Simon's signature 9 was not counted? 10 MS. PATTON: Correct. MEMBER SINNOTT: But Cleo Erwin's --11 12 MS. PATTON: Christopher Erwin. 13 MEMBER SINNOTT: Christopher Erwin's 14 was. 15 The next issue raised by the protestor 16 has to do with the petition signature listing on both 17 a -- being on the petition both as a signer and a 18 circulator. 19 CHAIRMAN PREISSE: Can you walk us 20 through that one? It was not counted? 21 MS. PATTON: Right. We invalidated the 22 signature on the part-petition that the gentleman circulated himself, but we did validate his signature 23 24 on the part-petition that was circulated by someone 25 other than him.

1	MEMBER SEXTON: So the one the one at
2	the top of Page 10 you validated, and the one on the
3	Circulator Statement below we did not; is that right?
4	MS. PATTON: So on Part 42 we did
5	invalidate. That's the signature from the petition
6	in which he circulated. However, he signed the
7	petition that he did not circulate, of which we did
8	validate.
9	CHAIRMAN PREISSE: Okay. And you walked
10	us through the rest of this
11	MEMBER SINNOTT: Yes.
12	CHAIRMAN PREISSE: that issue to my
13	satisfaction anyway.
14	MEMBER SINNOTT: I believe that takes us
15	to an allegation by the protestor of improper
16	completion of the Circulator Statement.
17	MS. PATTON: Again, we heard the
18	circulator of the local liquor option does not seem
19	to be a registered voter. We simply made sure that
20	the information is complete. We do not check the
21	residency, but in this case again the particular
22	person who circulated the petition, Mr. Ibrahim, is
23	registered to vote at 1032 East Long Street.
24	CHAIRMAN PREISSE: Okay.
25	MEMBER MARINELLO: So it's 97 with

39 taking Wiley off? 1 2 MS. PATTON: Correct. 3 MEMBER SINNOTT: We need to do that by Board action. I move the invalidation of the 4 5 signature provided by -- is Ryan --6 MS. PATTON: Wiley Ross. 7 MEMBER SINNOTT: It's Wiley Ross. Here 8 we go. Invalidation of the signature provided by 9 Wiley Ross. 10 CHAIRMAN PREISSE: Second. 11 MEMBER SEXTON: Second. 12 DEPUTY DIRECTOR PAYNE: It's been 13 properly moved and seconded that we take the count 14 down to 97 with the taking off of Wiley Ross. All 15 those in favor signify by saying aye. 16 (Vote taken.) 17 DEPUTY DIRECTOR PAYNE: All opposed, 18 same sign. 19 (No response.) 20 DEPUTY DIRECTOR PAYNE: Motion carries. 21 We are at 97 signatures. 22 MEMBER SINNOTT: Well, then I move that 23 the Board deny the protest and that the local option 24 shall appear on the November 6, 2018, General 25 Election ballot.

40 1 MEMBER MARINELLO: I second. 2 DEPUTY DIRECTOR PAYNE: All those in 3 favor signify by saying aye. 4 (Vote taken.) 5 DEPUTY DIRECTOR PAYNE: All opposed, 6 same sign. 7 (No response.) 8 DEPUTY DIRECTOR PAYNE: Motion carries. 9 Do you want to deal with Tee Brother 10 company? 11 MR. WEINGART: Excuse me. I'm sorry to 12 interject, but there are a couple of things that I 13 need clarification on. Did I mess it up for you guys? 15 CHAIRMAN PREISSE: No. I don't think that what evidence you provided really altered our 16 consideration of the paper evidence in front of us. 17 MR. SULLIVAN: Thank you. 18 19 CHAIRMAN PREISSE: I don't know if that 20 answers your question. 21 MEMBER SINNOTT: It does. 22 DEPUTY DIRECTOR PAYNE: Do we want to 23 proceed to the next local option? 24 MEMBER SINNOTT: Yes, Tee Brother. 25 MS. PATTON: Next, Colleen Guezennec did

12	MEMBER SINNOTT: Carla, to make sure, so
13	you're counting 97 signatures on this one?
14	MS. PATTON: Yes, that is correct. I
15	believe that that's what the protestor has indicated
16	as well, so we are in concurrence with the 97 valid
17	signatures that were certified.
18	MEMBER SINNOTT: In the interest of
19	time, it looks as though Issue I on Tee Brothers is
20	the same as Issue I on 20th and Long.
21	MS. PATTON: That is correct.
22	MEMBER SINNOTT: Issue II on Tee
23	Brothers is the same as Issue II on 20th and Long?
24	MS. PATTON: Correct.
25	MEMBER SINNOTT: Which takes us to the

1 printed signatures, please. 2 MS. PATTON: On Page 5 you will see the 3 list of signatures that the protestor has identified on the left-hand side of being that on the petition 4 itself, the right-hand side being on file with our 5 6 Board. In this particular case Marschell Folds 7 actually signed twice, one with a printed, one with a cursive. The cursive would have been valid -- would 8 9 have been a validated signature. The one that's 10 presented in front of you would have been invalidated 11 as a duplicate signature. 12 MEMBER SINNOTT: Okay. So Marschell 13 Folds signed once -- once printing and then signed 14 cursive? 15 MS. PATTON: Correct, and we validated 16 the cursive signature, which is not shown on this 17 protest. The signature that's shown on the protest 18 was not validated as a valid signature. 19 DIRECTOR LEONARD: So the printed 20 signature wasn't counted as part of the 97 valid 21 signatures? 2.2 MS. PATTON: The printed was not part of 23 the 97 valid. 24 It was a duplicate? MEMBER SINNOTT: 25 MS. PATTON: It would have been a

duplicate signature. Dora Zepf again signed the 1 petition twice, once with the printed and once with 2 cursive, and that's going to be the same scenario 3 with Marschell Folds, where we validated the cursive 4 and invalidated the one that's before you on the 5 6 protest. So, again, the one before you is not part 7 of the 97 valid signatures. 8 Candace Johnson, we have an updated 9 signature to -- better than what they're claiming on 10 here of misspelling the name, and you see she does -on their findings, she -- with her signature she does 11 12 spell it with an I, not an A (indicating), and we 13 have nothing, you know, further on Williams or D. 14 Minnifield. 15 MEMBER SINNOTT: Well, what's our past 16 practice when somebody named John Smith signs J. 17 Smith? Have we counted that through the years? 18 MS. PATTON: If you are able to 19 determine that that is the voter that's signing, then 20 we accepted that. 21 MEMBER SINNOTT: Meaning that everything 2.2 else checks out? 23 MS. PATTON: Correct. 24 MEMBER SINNOTT: And is that true about 25 Williams and Minnifield?

1 MS. PATTON: Yes. 2 MEMBER SINNOTT: So like if you take 3 Minnifield, for example, do we know that -- it says David Minnifield on here. Do we know that there's 4 5 someone not at the same address --6 MS. PATTON: Correct. If there were two 7 people with the initial D. Minnifield, we would have probably marked it as an invalid signature of 8 9 non-genuine, not being able to tell who it would be. 10 CHAIRMAN PREISSE: What's the next 11 issue, Carla? 12 MS. PATTON: The same signatures. The 13 protestor has identified on the petition some of the 14 similarities with a signature from line to line of 15 different voters. This would typically indicate that 16 a circulator has gone through and signed signatures, 17 signed voters' signatures rather than obtaining the 18 actual voter's signature itself. 19 MEMBER MARINELLO: But they matched up 20 with what you have on file or you wouldn't have 21 counted it? 22 MS. PATTON: Yeah. If we found that 23 there were similarities with the signatures, we would 24 have, again, given the credit, the benefit of the 25 doubt to the voter, if they would have been the

2	signature, you will see that several of those were
3	marked as invalid. I believe what the protestor is
4	giving us with this is that if they're non-genuine

8	MEMBER SINNOTT: How many of these
9	signatures did you find invalid?
10	MS. PATTON: Any of the ones without a
11	checkmark, so out of there's one, two, three, four
12	five there's only six signatures presented on that
13	page that looks like it has a validated mark,
14	indicated by a checkmark to the left. The others
15	were marked as either not registered or is
16	non-genuine, which is also used when you can't you
17	don't have a similarity with the signature, not
18	knowing if it's a circulator or another voter signing

20	MEMBER SINNOTT: I'm not finding
21	anywhere within the packet a description or a
22	quotation from the statute that Carla just referred
23	to about how we invalidate the entire petition if
24	there is
25	MEMBER MARINELLO: I count six.

2	MEMBER SINNOTT: Would you repeat,
3	Carla, what's your understanding of the standard for
4	invalidation of the entire petition.
5	MS. PATTON: If it is believed that
6	signatures of voters have been forged, then that
7	entire part-petition would be discarded as an invalid
8	part-petition.
9	CHAIRMAN PREISSE: What's the authority
10	on that?
11	MEMBER SINNOTT: The protestor provides
12	some statutory language here.
13	MS. PATTON: They're coming out it
14	comes from the Guide to Local Liquor Options, Revised
15	Code 3501.38, 3503.06(C)(1)(a) and 3599.36, which
16	includes that, "if a circulator knowingly permits
17	an unqualified person to sign a petition paper or
18	permits a person to write a name other than" his
19	or her own "on a petition paper, that"
20	entire "petition paper is invalid; otherwise, the
21	signature of a person not qualified to sign shall be
22	rejected but shall not invalidate the other valid
23	signatures on the paper."
24	Again, we give the benefit of the doubt,
25	that a husband may have signed for a wife, we won't

48 1 invalidate the entire part-petition. We'll just 2 invalidate the signature as not genuine. MEMBER SINNOTT: Carla, on this 3 4 part-petition how many signatures are you counting? 5 MS. PATTON: Thirty, that appear on this 6 particular --7 MEMBER SINNOTT: And only six were valid? 8 MS. PATTON: Of that I can see. 9 I'm 10 not -- I can't see the markings for those that appear 11 on the right-hand side. It does appear that it may 12 come from a separate part-petition. The ones on the 13 right, that appear on the right of those, I mean, two 14 of those were marked to be valid signatures. The 15 remainder of them were marked as not registered or 16 not registered at the address, and then the first one 17 that you see appears to be a non-genuine. 18 MEMBER SINNOTT: If you can take us to 19 the next issue. 20 MS. PATTON: The next issue is again 21 similar, was dealing with --22 CHAIRMAN PREISSE: Which one are you on, 23 please? 24 MS. PATTON: This is Issue III with the 25 Circulator Statement on Page 8.

8	what's the next one?
9	MS. PATTON: Again, that's the
10	non-genuine signatures, and the first three listed,

14	MEMBER SEXTON: On Page 9 which ones
15	were validated?
16	MS. PATTON: The first three signatures
17	on Page 9 were invalidated. The second two or those
18	last two were validated as valid signatures.
19	Again, continuing on with non-genuine
20	signatures
21	CHAIRMAN PREISSE: Page 10?
22	MS. PATTON: Yes, Page 10. The
23	signature on the left is from the petition. The
24	signature on the right is from the system, and that
25	continues to Page 11, with the final signature being

50 marked as the protestor finding it as being --1 2 claiming to be non-genuine. 3 MEMBER MARINELLO: What was the status on Page 10 of the signatures, all validated? I can't 4 5 tell. 6 MS. PATTON: Yes, all were validated. 7 And the one on Page 11 was also validated. 8 MEMBER SEXTON: So on Page 10 we validated the first one? 9 10 MS. PATTON: We validated all the 11 signatures on Page 10. 12 MEMBER SEXTON: Understand, on our 13 sheets some are very, very --14 MEMBER MARINELLO: Hard to read. 15 MEMBER SEXTON: -- difficult, especially 16 No. 1 and the second one from the bottom on mine. 17 MS. PATTON: I can provide the 18 part-petition itself, if that would help. 19 MEMBER MARINELLO: Well, it's the 20 signature on file with the Board that we can't read. 21 MS. PATTON: I'm sorry? 22 MEMBER MARINELLO: It's the signature on file with the Board that we can't read. It's all 23 24 black, at least mine is. 25 MS. PATTON: (Indicating.)

51 1 MEMBER MARINELLO: That's better. 2 MEMBER SEXTON: I don't know if yours is 3 hard to read, but the first one and second to last 4 one, it's a lot better on that copy. 5 MEMBER SINNOTT: Yeah. CHAIRMAN PREISSE: Thank you for that. 6 7 What was -- that brings us to which point? 8 MS. PATTON: Issue V, the illegible 9 signatures/not found at address. They have pointed 10 out a signature in which we -- based on the address, 11 we were able to find a Telisa Monagan, of which her 12 registration is here with the signature on it, which 13 we -- actually we validated and gave credit to based 14 on the address listed on the petition and 15 similarities with the signature. You see the 16 "Monagan" and the signature on the petition. 17 MEMBER SEXTON: No. 5 (indicating). 18 CHAIRMAN PREISSE: Okay. Next. 19 MS. PATTON: The next is in regards to 20 the affidavit that was filed with Tee Brother. Maybe 21 the protestor has been confused, but the affidavit is 22 accurate as what's listed in the protest, the 23 affidavit for Jehad Alhajahmad on behalf of Tee 24 Brother Company, and in the information that they 25 provided, Muktar Ibrahim owns the d/b/a of Long &

23	go public. It's okay for a spouse to sign their
24	spouse's name, I heard that today. Did you hear
