4	DEPUTY DIRECTOR PAYNE: First item
5	on the agenda is the allocation of paper ballots
6	well, actually yeah, paper ballots for the
7	August 8th Election. I'm going to call upon
8	Katrina McReynolds, the supervisor of our
9	operations department to go over that. And then I
LO	will ask her after that if she wouldn't mind doing
<b>L1</b>	the machine allocation.
L2	MS. MCREYNOLDS: Good afternoon.
L3	In front of you is Exhibit A, the
L4	August 2023 Special Election initial paper ballot
15	recommended allocation. With no previous true like
16	election to compare to, data was examined from the
۱7	2019 and 2021 General Election, as well as the 2018
18	August Special Congressional Election that was held
19	for the then 12 Congressional districts.
20	Per the Ohio Secretary of State
21	Election Official Manual, Section 5.07, ballot
22	quantities, the Board is required to provide
23	printed paper ballots for provisional voters that
24	is equal to the number of provisionals cast in that

precinct in a previous like election, plus five percent of that number. With the new ID laws in effect, and this being the first county-wide election under the new laws, we anticipate there may be a few more provisionals than in the past. Calculations for provisionals use the highest number of provisionals cast in any precinct from those previous elections examined. And then we rounded that number up to the 25 ballots. Therefore, 25 ballots are being provided for provisional purposes in each precinct.

In addition to the provisional ballots, the allocations before you incorporate the allocation of ballots for voters that choose to vote in paper by choice, regular ballot. With the hybrid voting system that we utilize, the allocations of paper ballots for regular voters for this election is at the discretion of the Board. In looking at the number of ballots cast at the poll in the same election examined for provisional ballot allocations, we took the highest turnout of any precinct in those elections, and applied that percentage to the number of registered voters for this election. We then took six percent of that

number and then rounded up to the next increment of 25. If a location runs low on a particular ballot style, we do have the ability here on Election Day to produce paper ballots on demand, and have them delivered within a short amount of time.

At this time we would ask that the Board approve the recommended paper ballot allocations for the August 2023 Special Election.

DEPUTY DIRECTOR PAYNE: Thank you,

10 Katrina.

MEMBER SEXTON: So how -- do we have anything to reference in August full countywide special election in the last --

MS. MCREYNOLDS: No.

DIRECTOR WHITE: We don't. Carla, who does, and Katrina, who run the allocations, in looking at previous like elections, what Carla determined was the last time there was a countywide election or state-wide election with Constitutional amendments in August was 1926. So we really are in uncharted waters here. That's why they looked at 2018 Special Congressional, which was in August, and then looked at 2019, 2021, thinking similar types of turnout.

1	The highest precinct total in any of
2	those elections was 53% turnout. That was the
3	basis of the allocations that were used to
4	determine what we would allocate the paper ballots
5	on for our upcoming August 8th election.
6	MEMBER SEXTON: Yeah. Because I
7	remember we had one in Columbus in 2009, and I
8	think turnout was around 14%. And anything
9	countywide that we would have, you know, to compare
LO	it to.
L1	DIRECTOR WHITE: Yeah, as a matter
<b>L2</b>	of fact, Mr. Sexton, I just looked it up, it was
L3	19%.
L <b>4</b>	MEMBER SEXTON: 19.
L5	DIRECTOR WHITE: Yeah. For that
L6	special election for city tax increase. And that
<b>L7</b>	counted for about two-thirds of the county.
L8	MEMBER SEXTON: Okay.
L9	CHAIRMAN JAFFE: Sounds like we're
20	doing the best we can with historical data.
21	MEMBER MARINELLO: I move that the
22	Board adopt the paper ballot allocation formula in
23	Exhibit A compiled by the Board staff for the
24	August 8th Election.

9	will turn it over to Katrina McReynolds on the
LO	voting machine allocation.
<b>L1</b>	MS. MCREYNOLDS: You should also
12	have in front of you Exhibit B, the August 2023
13	Special Election initial voting equipment
L <b>4</b>	recommended allocation. This election we have 282
15	polling locations that will be open for voting on
16	Election Day. We are using paper pollbooks again
۱7	this election; so there is no allocation for
18	electronic pollbook equipment. Each location is
19	set to receive one express vote ballot marker for
20	roughly every 350 registered voters in that
21	location, with no less than three express vote
22	ballot markers, and at least one of those being a
23	kiosk express vote ballot marker for the ADA
24	purposes. The DS200 ballot scanners are allocated

1	at one for every seven ballot markers assigned to
2	the location. With all locations receiving at
3	least one. The recommended allocation calls for a
4	total of 2,661 express vote ballot markers and 489
5	DS200 ballot scanners to be deployed for use at the
6	polling locations on Election Day.
7	At this time, we would ask the Board
8	to approve the recommended voting equipment
9	allocation for the August 2023 Special Election.
10	DIRECTOR WHITE: Thank you, Katrina.
11	CHAIRMAN JAFFE: So for this one
12	we're allocating based on registered voters so we
13	don't have to worry about estimating it?
14	DIRECTOR WHITE: That's correct.
15	And this is the typical allocation that we use.
16	MEMBER SEXTON: Mr. Chairman, I move
17	that the Board adopt the voting machine allocation
18	formula in Exhibit B compiled by the Board staff
19	for the August 8th election.
20	CHAIRMAN JAFFE: Second.
21	DEPUTY DIRECTOR PAYNE: It's been
22	properly moved and seconded. All those in favor of
23	the motion, signify by saying aye.
24	All opposed, same sign.

11 1 Motion carries. 2 (Vote taken; motion passed.) 3 DEPUTY DIRECTOR PAYNE: Next item on 4 the agenda is poll worker pay increase. And I will 5 turn that over to the manager of the precinct 6 election officials division, Steve Bulen. 7 MR. BULEN: Thank you, Deputy 8 Director Payne. 9 Good afternoon, Mr. Chairman, 10 Members of the Board. 11 In 2015, the precinct election 12 official division got together and created a 13 mission statement that has guided us since that 14 time. And we set a goal to recruit, train and 15 place the best poll workers who were committed to 16 serving voters with excellence and civic pride. 17 And I can tell you that since that time, I believe 18 our team has met that goal. However, recently, 19 it's been increasingly difficult to recruit not 20 only the quantity, but the quality of poll worker 21 that helps us meet that standard, meet that goal,

fulfill our mission. We believe that this pay

maintain those high standards.

raise will go a long way in ensuring that we will

I believe that you have in front of 1 2 you a sheet that kind of outlines what it is we 3 would like to propose. Ohio Revised Code 4 stipulates the amount of money that a poll worker 5 can earn on Election Day. They have a range that 6 they have set up, and we are at the highest of that range, that's the 133.72. 7 That cannot be adjusted 8 except lowered, and so the Ohio Secretary of State 9 does allow for that pay to be augmented through 10 things like training sessions and other activities. 11 So that's where we propose to increase the poll 12 worker pay as you see outlined on the sheet in 13 front of you.

I would just respectfully request that you help us maintain the quantity and quality of poll workers that we need to run every election here in Franklin County.

DEPUTY DIRECTOR PAYNE: Thanks, Steve.

DIRECTOR WHITE: And if I may piggyback off of Mr. Bulen. You know, one of the things that has been somewhat challenging recently in terms of recruitment, but also I think over the years the depth and breadth of the poll worker

position has grown and changed. We ask a lot of our poll workers. We ask them to do a lot. We ask them to do a lot with technology, we ask them to do a lot, and commit a lot of time to training, working on Election Day. We now ask poll workers to set up on Monday nights, which didn't exist as of a couple of years ago. So we're asking them to do more. On average, with Election Day pay and how we would augment that pay through training and other activities, currently a base poll worker on average would earn about \$9.60 an hour. based on a 20-hour sort of time commitment of Election Day training, Monday night setup. With your approval, we would raise the rate to where a base poll worker would be earning a little over \$15 an hour. So we think that's commensurate with what we're seeing in the workplace today in terms of paying individuals. And so we would ask that you would accept that, and that would go a long way towards recruitment in our efforts to recruit good poll workers here in Franklin County. MEMBER SEXTON: Just a couple of questions. So the voting location manager,

obviously, is the highest paid. You know, they do

1 all of these. But we are moving Monday night from 2 basically 50 to 90; the training session, which is 3 what, two, two and a half hours? 4 MR. BULEN: For our VLMs it's three 5 hours. 6 MEMBER SEXTON: Okay. Three hours 7 at 80, and then pretty much these -- what's the 8 PMP? 9 MR. BULEN: So PMP is an acronym for 10 practice makes perfect. It's a weekend review 11 session that we allow poll workers to participate 12 in the weekend before the election. And so we have 13 sessions where they can come and get a quick 14 review, have any last minute questions answered. 15 And that takes place Friday, Saturday, and Sunday 16 before the election. 17 MEMBER SEXTON: Okay. 18 MR. BULEN: It's been very 19 successful. Because our training can start five 20 weeks, six weeks ahead of an Election Day, and so 21 we want to provide an opportunity for people to 22 come and get a quick review, because a lot of life 23 happens between maybe my training and Election Day. 24 MEMBER SEXTON: Okay. So what's the online?

MR. BULEN: So during the pandemic, we offered an online component that we saw the value to that because we can allow poll workers to do some training from their home that we track, and can verify that they completed. And it allows us to cover some basic things when it comes to serving as a poll worker, what time do you arrive, you know, bring your snacks, bring your lunch. Just some basic overall generalities that we can cover online, that we now don't have to cover in person; thus, allowing us to keep that time. VLM training used to be four hours, but because we can now do also online training, we can reduce the in-person class just to three. And that way, hopefully, we will retain more, because they're there for a shorter amount of time, and do the online training then at their leisure. MEMBER SEXTON: Okay. And what is the ride-a-long? MR. BULEN: So at the end of every election, Mr. Chairman, we're responsible for bringing the supplies back to the Board of

Elections, the voting location manager is

1 responsible for that. However, they must have a 2 poll worker of the opposite party with them --3 MEMBER SEXTON: Oh. Gotcha. 4 MR. BULEN: -- and so that person 5 stays extra, comes back to the Board of Elections, 6 sometimes they may come from Grove City, and then 7 the VLM takes them back to their car at the voting 8 location. And that ensures we have bipartisan poll 9 workers returning supplies on election night, which 10 is required. 11 So that would be MEMBER SEXTON: 12 added -- whoever does the ride-a-long would be 13 added to their regular -- it would be \$20 more to 14 their regular pay? 15 MR. BULEN: That is correct. That 16 is correct. And there will be one per location. 17 MEMBER SEXTON: Okay. Thank you. 18 MR. BULEN: Sure. 19 CHAIRMAN JAFFE: One other question. 20 I recall in 2020 there was a special additional 21 training pay bump for the November 2020 election 22 for poll workers. I don't know if you remember off 23 the top of your head what we did then. 24 I believe it was a MR. BULEN:

1	one-time COVID
2	CHAIRMAN JAFFE: Right.
3	MR. BULEN: You're asking how much
4	was that, Mr. Chair?
5	CHAIRMAN JAFFE: Yeah. Hazard pay
6	kind of thing is how it was characterized.
7	MR. BULEN: 50, maybe. I think it
8	was maybe 50.
9	DIRECTOR WHITE: That sounds
10	correct.
11	MR. BULEN: But that was one time.
12	That funding came from a different source.
13	MEMBER SEXTON: It came from the
14	grant we got, yeah.
15	CHAIRMAN JAFFE: And did we see
16	better recruitment as a result of that to the
17	extent we can measure?
18	MR. BULEN: I would say it had to
19	help. It had to help.
20	CHAIRMAN JAFFE: Okay.
21	MR. BULEN: Honestly, sir, I take it
22	one election at a time. And I know that we're
23	gearing up for an August election where we may have
24	some challenges finding enough poll workers. So

1	we've done different things over the years to kind
2	of help with that. I think this is an
3	across-the-board increase that will make a huge
4	difference, I really, really do.
5	CHAIRMAN JAFFE: Okay. Thank you.
6	MEMBER MARINELLO: Well, I hope it
7	helps. And I move the Board approve the poll
8	worker pay increase as shown on Exhibit C.
9	CHAIRMAN JAFFE: Second.
10	DEPUTY DIRECTOR PAYNE: It's been
11	properly moved and seconded. All those in favor of
12	the motion, signify by saying aye.
13	All opposed, same sign.
14	Motion carries.
15	MR. BULEN: Thank you.
16	(Vote taken; motion passed.)
17	DEPUTY DIRECTOR PAYNE: The next
18	item on the agenda is the hiring of Brennon Woods
19	as a clerk in filings and petitions. Brennon comes
20	to us, he's been previously a legislative page in
21	the Ohio House. He was a constituent aide for a
22	Representative in the Ohio House. He has a
23	political science degree from The Ohio State
24	University. And he played a varsity sport when he

1	was at Otterbein.
2	And stand up, Brennon, and I will
3	let you figure out what sport he played.

5	DIRECTOR WHITE: I thought it might
6	have been squash.

24	properly moved and seconded. All those in favor,

20 signify by saying aye. 1 2 All opposed, same sign. 3 Motion carries. 4 (Vote taken; motion passed.) 5 DEPUTY DIRECTOR PAYNE: 6 Congratulations, Brennon. 7 DIRECTOR WHITE: Congratulations. 8 Welcome. 9 DEPUTY DIRECTOR PAYNE: That's all I 10 see on the agenda. 11 MEMBER SEXTON: I just had a 12 question. Katrina had mentioned that we have 282 13 polling locations this time. Last August, I think 14 it was, if my numbers are right, we had like 309 15 and we wound up filling 155. So the question I 16 have is what's the thought on how we're going --17 are we going to be consolidating as many precincts 18 for this election as we did a year ago? Or just

19 the thoughts on if we're going to be able to get to 20 a number of hours served is 4,000. So if we can 21 get to that, I assume we will have to consolidate 22 precincts, consolidate voting locations, I should 23 say, and you know, there's notices for all of that

that have to go out --

24

1 DIRECTOR WHITE: That's correct.

2 MEMBER SEXTON: One or two --

DEPUTY DIRECTOR PAYNE: We went from 387 to 282. We called all of our voting locations that we had last election, and there were 25 that weren't available for a myriad of reasons. And so we have 282. And we are combining them. We will send out notices to those people that are affected. Some of them are permanent changes and some of them are temporary changes. So we will send out notices to all of those people affected, letting them know their new polling location, be it temporary or permanent.

just to piggyback off of that, I think, last year, August, there was a different line of thinking last year. So last year for the second primary in August, we had — it was for legislative districts, and we had — that came a little later to us than this one did. And also, too, we had a number of uncontested races for that election. So we were more purposeful in combining locations last year to save dollars and to, you know, save on the amount of poll worker resources we would need. The line

of thinking this year is a little different. It's a full countywide, it's an issue, and we know it's an issue in every precinct. So we don't have any uncontested races, and so we think there will be a bigger turnout. Last August was seven percent. We believe it will be bigger. We don't know how much, obviously, but we know it will be bigger. And so with that, we wanted to keep intact as many 9 locations as we could. So our logistics department did make those calls, we were able to figure out it was 25 not available. And so we will do everything we can to keep everything operating, just knowing that, you know, this is a full election with an issue on every ballot. So nothing uncontested, so to speak, as we did a year ago.

pure pollbooks. So we will still have to, at minimum, have four precinct election officials per precinct. That's the law. If you are using electronic pollbooks, the Board can reduce that number from four to two, but because we are using the paper pollbooks, we have to maintain the four. So we still have to recruit at minimum 35.

MEMBER SEXTON: 52.

DEPUTY DIRECTOR PAYNE: 35 to 52.

But we always try to recruit about 5,000 knowing that that's roughly what we need in order to have a comfortable election, so we know that voters have a good experience. And also we know there's just drop-off. So that's why we shoot for 5,000, knowing we want to have a good voting experience, and we will have some drop-off, people not showing

up. It's usually, what, 15 to 20% sometimes. 1 2 People who get trained, come to poll worker 3 training, get trained, go through the entire 4 process, and then not show up on Election Day. It 5 happens every election. 6 DEPUTY DIRECTOR PAYNE: 7 specifically asking about poll workers or actual 8 locations? 9 MEMBER SEXTON: Just, well, I mean 10 locations, but normally one follows the other. 11 we can't get the poll workers --12 DEPUTY DIRECTOR PAYNE: We have 13 already solidified the 282 locations. 14 CHAIRMAN JAFFE: I think last year 15 we made the conscious decision to consolidate as 16 much as possible because we only had a couple of 17 contested races. 18 If I may, Director. MR. BULEN: 19 DIRECTOR WHITE: Yes. 20 MR. BULEN: Our really cool board 21 just agreed to a poll worker pay raise; so that 22 will help. 23 MEMBER SEXTON: Try to get some

24

press out of that, so.
