

It's Safe, Secure, and Simple

- Absentee Voting is a three step process:
  - 1 Request an application, or download and print vour own
  - 2 Turn in application
  - **3** Receive ballot, mark selections and fill out ID envelope and return ballot by deadline
- **Commonly missed items on forms:** 
  - Signature
  - Date of Birth
  - Selecting Party of Choice (During Primary Elections)



- Last Four Digits of Your Social Security Number
- Driver's License Number
- ✓ Track your Absentee Ballot from time of Request to Ballot Acceptance using BallotTrax:
