

PROPOSED BOND ISSUE

SHALL BONDS BE ISSUED BY THE SOUTH-WESTERN LOCAL SCHOOL DISTRICT, FRANKLIN COUNTY, OHIO, FOR THE PURPOSE OF PURCHASING REAL ESTATE AND EASEMENTS, CONSTRUCTION AND IMPROVEMENT OF FIREPROOF HIGH SCHOOL AND ELEMENTARY BUILDINGS, PURCHASE OF FURNITURE AND FURNISHINGS, AND SITE IMPROVEMENTS IN THE SUM OF TWO MILLION FIVE HUNDRED THOUSAND DOLLARS (\$2,500,000.00) AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE TWO (2) MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO TWENTY (\$0.20) CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY THREE (23) YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS.
