

PROPOSED BOND ISSUE

CANAL WINCHESTER LOCAL SCHOOL DISTRICT

SHALL BONDS BE ISSUED BY THE CANAL WINCHESTER LOCAL SCHOOL DISTRICT, FRANKLIN & FAIRFIELD COUNTIES, OHIO, FOR THE PURPOSE OF ACQUISITION OF REAL ESTATE, CONSTRUCTION OF A NEW SCHOOL BUILDING, REMODELING AND CONSTRUCTING ADDITIONS TO SCHOOL BUILDINGS, SITE IMPROVEMENT AND FURNITURE, FURNISHINGS AND EQUIPMENT FOR THE SAME IN THE SUM OF FOUR HUNDRED THIRTY-FIVE THOUSAND, TWO HUNDRED DOLLARS (\$435,200.00) AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE TWO AND FIVE-TENTHS (2.5) MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO TWENTY-FIVE CENTS (\$.25) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR MAXIMUM PERIOD OF TWENTY-TWO (22) YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?

SHALL BONDS BE ISSUED BY THE MADISON LOCAL SCHOOL DISTRICT, FRANKLIN COUNTY, OHIO, FOR THE PURPOSE OF ACQUISITION OF REAL ESTATE, CONSTRUCTION OF ADDITIONS AND IMPROVEMENTS TO EXISTING SCHOOL BUILDINGS AND NEW SCHOOL BUILDINGS, LANDSCAPING AND ACQUISITION OF FURNITURE, FURNISHINGS AND EQUIPMENT FOR SAME IN THE SUM OF THREE HUNDRED TWENTY THOUSAND DOLLARS (\$320,000.00) AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE EIGHTY-TWO HUNDREDTHS (.82) MILL FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO EIGHT AND TWO-TENTHS CENTS (\$.082) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY-FOUR (24) YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?
