PROPOSED BOND ISSUE AND ADDITIONAL TAX LEVY

SHALL BONDS BE ISSUED BY THE BOARD OF EDUCATION OF THE SCIOTO-DARBY LOCAL SCHOOL DISTRICT FOR THE PURPOSE OF CONSTRUCTING A JUNIOR HIGH SCHOOL BUILDING AND AN ELEMENTARY SCHOOL BUILDING, CONSTRUCTING ADDITIONS TO AND REMODELING EXISTING SCHOOL BUILDINGS, ACQUIRING AND IMPROVING SCHOOL SITES, PROVIDING SCHOOL SEWAGE AND WATER SUPPLY FACILITIES, AND FURNISHING AND EQUIPPING SCHOOL BUILDINGS, IN THE SUM OF \$610,000.00 AND A LEVY OF TAXES TO BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE .97 MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO 9.7 CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY-ONE YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS.

SHALL AN ADDITIONAL LEVY OF TAXES BE MADE FOR THE BENEFIT OF THE SCIOTO-DARBY LOCAL SCHOOL DISTRICT FOR THE PURPOSE OF PAYING THE COST OF THE PURCHASE OF CLASS-ROOM FACILITIES FROM THE STATE AT THE RATE OF ONE-HALF MILL FOR EACH ONE DOLLAR OF VALUATION EXCEPT THAT IN THOSE YEARS IN WHICH THE TAX RATE FOR DEBT SERVICE OUTSIDE THE TEN MILL LIMITATION IS LESS THAN THREE AND ONE-HALF MILLS, THE RATE SHALL BE INCREASED TO THAT RATE WHICH IS THE DIFFERENCE BETWEEN FOUR MILLS AND THE TAX RATE FOR DEBT SERVICE OUTSIDE THE TEN MILL LIMITATION, UNTIL THE PURCHASE PRICE IS PAID BUT IN NO CASE LONGER THAN TWENTY-THREE YEARS?
