

PROPOSED CHARTER AMENDMENT

CITY OF UPPER ARLINGTON

PROPOSAL TO AMEND SECTION XVI OF THE CHARTER OF THE CITY OF UPPER ARLINGTON TO READ AS FOLLOWS:

THE AGGREGATE AMOUNT OF TAXES THAT MAY BE LEVIED BY THE COUNCIL WITHOUT A VOTE OF THE PEOPLE, FOR ALL MUNICIPAL PURPOSES, ON PROPERTY WHICH IS TAXABLE ACCORDING TO VALUE, SHALL NOT EXCEED 8 MILLS ON EACH DOLLAR OF TAXABLE VALUATION. TAXES MAY BE LEVIED OUTSIDE OF THESE LIMITATIONS UPON APPROVAL BY A MAJORITY OF THE ELECTORS OF THE CITY VOTING THEREON AT A NOVEMBER ELECTION OR IN ANY MANNER PROVIDED BY GENERAL LAW FOR VOTING LEVIES OUTSIDE THE STATUTORY LIMITATIONS.

THE COUNCIL SHALL NOT ENACT ANY ORDINANCE LEVYING AN INCOME TAX EXCEPT UPON APPROVAL BY A MAJORITY OF THE ELECTORS OF THE CITY VOTING THEREON AT A GENERAL OR SPECIAL ELECTION HELD NOT LESS THAN 60 DAYS AFTER THE ADOPTION BY COUNCIL OF A RESOLUTION CALLING FOR SUCH ELECTION, WHICH RESOLUTION SHALL SET FORTH THE RATE OF THE PROPOSED TAX AND THE PURPOSES FOR WHICH THE RECEIPTS THEREFROM SHALL BE USED. IN THE EVENT OF AN AFFIRMATIVE VOTE, THE PROCEEDS OF SUCH LEVY MAY BE USED ONLY FOR THE SPECIFIED PURPOSES.
