PROPOSED BOND ISSUE

SCIOTO-DARBY CITY SCHOOL DISTRICT

SHALL BONDS BE ISSUED BY THE SCIOTO-DARBY CITY SCHOOL DISTRICT, FRANKLIN AND UNION COUNTIES, OHIO, FOR THE PURPOSE OF CONSTRUCTING, FURNISHING AND EQUIPPING A NEW HIGH SCHOOL BUILDING AND A NEW ELEMENTARY SCHOOL BUILDING, ADDING TO, FURNISHING AND EQUIPPING SCHOOL BUILDINGS, IMPROVING SCHOOL SITES AND ACQUIRING REAL ESTATE FOR SCHOOL PURPOSES IN THE SUM OF FOUR MILLION TWO HUNDRED EIGHTY-FIVE THOUSAND DOLLARS AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE 4.4 MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO \$0.44 FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF 23 YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?
