PROPOSED BOND ISSUE

MADISON LOCAL SCHOOL DISTRICT

SHALL BONDS BE ISSUED BY THE MADISON LOCAL SCHOOL DISTRICT FOR THE PURPOSE OF ACQUIRING REAL ESTATE; CONSTRUCTING NEW SCHOOL BUILDINGS, ADDITIONS TO EXISTING BUILDINGS, AND ATHLETIC FACILITIES; REMODELING SCHOOL BUILDINGS; ACQUIRING FURNITURE, FURNISHINGS AND EQUIPMENT; AND LANDSCAPING AND SITE IMPROVEMENT IN THE SUM OF SEVEN MILLION DOLLARS AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE SEVEN AND TWO-TENTHS MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO SEVENTY-TWO CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY-THREE YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?
