PROPOSED TAX LEVY (11.3 MILLS) ADDITIONAL

WESTERVILLE CITY SCHOOL DISTRICT

SHALL A LEVY BE IMPOSED BY THE WESTERVILLE CITY SCHOOL DISTRICT FOR THE PURPOSE OF PROVIDING FOR EMERGENCY REQUIREMENTS OF SAID DISTRICT TO PREVENT THE TEMPORARY CLOSING OF ONE OR MORE SCHOOLS WITHIN SAID DISTRICT IN THE SUM OF \$2,490,000 AND A LEVY OF TAXES TO BE MADE OUTSIDE OF THE TEN-MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE ELEVEN AND THREE-TENTHS MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO ONE DOLLAR AND THIRTEEN CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A PERIOD OF TWO YEARS?






