





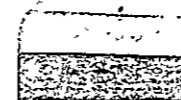

WESTERVILLE CITY SCHOOL DISTRICT

SHALL BONDS BE ISSUED BY THE BOARD OF EDUCATION OF THE WESTERVILLE CITY SCHOOL DISTRICT FOR THE PURPOSE OF IMPROVING SCHOOL FACILITIES BY CONSTRUCTING, MAKING BUILDING AND EQUIPMENT ADDITIONS TO, REMODELING, RENOVATING, FURNISHING, AND EQUIPPING BUILDINGS AND OTHER FACILITIES FOR SCHOOL PURPOSES, ACQUIRING REAL ESTATE FOR SCHOOL PURPOSES, AND MAKING ROADWAY, PARKING, PLAYGROUND, ATHLETIC FIELD, STADIUM, AND OTHER SITE IMPROVEMENTS IN THE SUM OF TWO MILLION SEVEN HUNDRED THIRTY THOUSAND DOLLARS AND LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE ONE AND FIVE-HUNDREDTHS MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO TEN AND ONE-HALF CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF THIRTEEN YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?

SHALL BONDS BE ISSUED FOR THE BENEFIT OF THE WESTERVILLE PUBLIC LIBRARY BY THE BOARD OF EDUCATION OF THE WESTERVILLE CITY SCHOOL DISTRICT FOR THE PURPOSE OF CONSTRUCTING AN ADDITION TO AND REMODELING OF THE WESTERVILLE PUBLIC LIBRARY, FURNISHING AND EQUIPPING THE ADDITION, AND IMPROVING REAL ESTATE FOR OFF-STREET PARKING IN THE SUM OF ONE MILLION FOUR HUNDRED FIFTY THOUSAND DOLLARS AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE FOUR-TENTHS MILL FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO FOUR CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY-THREE YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?
