AN ADDITIONAL TAX FOR THE BENEFIT OF MADISON TOWNSHIP FOR THE PURPOSE OF PROVIDING AND MAINTAINING MOTOR VEHICLES, COMMUNICATIONS, AND OTHER EQUIPMENT, USED DIRECTLY IN THE OPERATION OF A POLICE DEPARTMENT, OR THE PAYMENT OF SALARIES OF PERMANENT POLICE PERSONNEL, OR FOR THE PAYMENT OF THE COSTS INCURRED BY TOWNSHIPS AS A RESULT OF CONTRACTS MADE WITH OTHER POLITICAL SUBDIVISIONS IN ORDER TO OBTAIN POLICE PROTECTION AT A RATE NOT EXCEEDING TWO AND NINE-TENTHS MILLS ( 2.9 ) FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO TWENTY-NINE CENTS ( \$0.29 ) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR FIVE YEARS ( 5 ).
