

AN ADDITIONAL TAX FOR THE BENEFIT OF THE HILLIARD CITY SCHOOL DISTRICT FOR THE PURPOSE OF CURRENT EXPENSES AT A RATE NOT EXCEEDING SIX AND FIVE-TENTHS MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO SIXTY-FIVE CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A CONTINUING PERIOD OF TIME.
