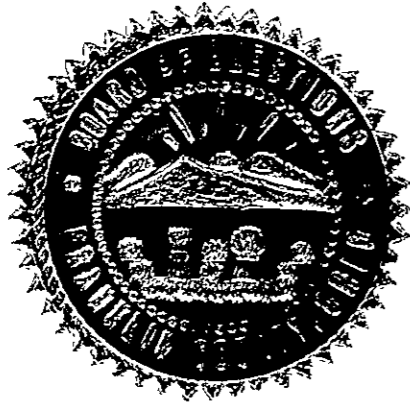

CANAL WINCHESTER LOCAL SCHOOL DISTRICT

A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE

AN ADDITIONAL TAX FOR THE BENEFIT OF THE CANAL WINCHESTER LOCAL SCHOOL DISTRICT FOR THE PURPOSE OF PROVIDING FOR PERMANENT IMPROVEMENTS OF THE DISTRICT INCLUDING CONSTRUCTING, REMODELING, RENOVATING, AND OTHERWISE IMPROVING BUILDINGS, STRUCTURES AND OTHER SCHOOL FACILITIES, FURNISHING AND EQUIPPING THE SAME AND LANDSCAPING AND IMPROVING THE SITES THEREOF AT A RATE NOT EXCEEDING THREE AND SEVEN-TENTHS MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO THIRY-SEVEN CENTS (\$0.37) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A PERIOD OF TWO YEARS.
