SOUTH-WESTERN CITY

A Majority Affirmative Vote is Necessary for Passage.

An additional tax for the benefit of the South-Western City School District for the purpose of **CURRENT EXPENSES** at a rate not exceeding eight and nine-tenths (8.9) mills for each one dollar of valuation, which amounts to eighty-nine cents (\$0.89) for each one hundred dollars of valuation, for a continuing period of time.
