# 18 PROPOSED BOND ISSUE  
CITY OF GRANDVIEW HEIGHTS

A Majority Affirmative Vote is Necessary for Passage.

Shall bonds be issued by the City of Grandview Heights for the purpose of IMPROVING, RENOVATING, CONSTRUCTING, FURNISHING AND EQUIPPING BUILDINGS TO HOUSE MUNICIPAL FIRE, POLICE, AND ADMINISTRATIVE FUNCTIONS AND MAKING RELATED SITE IMPROVEMENTS TOGETHER WITH ALL NECESSARY APPURTENANCES, in the principal amount of \$6,500,000, to be repaid annually over a maximum period of 26 years, and an annual levy of property taxes be made outside the ten-mill limitation, estimated by the county auditor to average over the repayment period of the bond issue 2.51 mills for each one dollar of tax valuation, which amounts to \$0.251 for each one hundred dollars of tax valuation, commencing in 2002, first due in calendar year 2003, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?

# 2 PROPOSED BOND ISSUE  
CITY OF WESTERVILLE

A Majority Affirmative Vote is Necessary for Passage.

Shall bonds be issued by the City of Westerville for the purpose of PAYING THE COSTS OF IMPROVING THE PROVISION OF MUNICIPAL FIRE SERVICES, INCLUDING THE CONSTRUCTING, FURNISHING AND EQUIPPING OF BUILDINGS TO HOUSE MUNICIPAL FIRE FUNCTIONS INCLUDING RELATED SITE IMPROVEMENTS, AND THE ACQUISITION OF SAFETY VEHICLES AND COMMUNICATION EQUIPMENT, INCLUDING ALL RELATED APPURTENANCES in the principal amount of \$2,575,000, to be repaid annually over a maximum period of 20 years, and an annual levy of property taxes be made outside the ten-mill limitation, estimated by the county auditor to average over the repayment period of the bond issue 0.24 mills for each one dollar of tax valuation, which amounts to \$0.024 for each one hundred dollars of tax valuation, commencing in 2002, first due in calendar year 2003, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?

CITY OF WESTERVILLE

A Majority Affirmative Vote is Necessary for Passage.

An additional tax for the benefit of the City of Westerville for the purpose of PROVIDING AND MAINTAINING FIRE APPARATUS, APPLIANCES, BUILDINGS, OR SITES THEREFOR, OR SOURCES OF WATER SUPPLY AND MATERIALS THEREFOR, OR THE ESTABLISHMENT AND MAINTENANCE OF LINES OF FIRE ALARM TELEGRAPH, OR THE PAYMENT OF PERMANENT, PART-TIME, OR VOLUNTEER FIREFIGHTERS OR FIREFIGHTING COMPANIES TO OPERATE THE SAME, INCLUDING THE PAYMENT OF THE FIREFIGHTER EMPLOYER'S CONTRIBUTION REQUIRED UNDER SECTION 742.34 OF THE REVISED CODE, OR PURCHASE OF AMBULANCE EQUIPMENT, OR THE PROVISION OF AMBULANCE, PARAMEDIC, OR EMERGENCY MEDICAL SERVICES OPERATED BY A FIRE DEPARTMENT OR FIREFIGHTING COMPANY at a rate not exceeding 3.4 mills for each one dollar of valuation, which amounts to \$0.34 for each one hundred dollars of valuation, for a continuing period of time, commencing in 2002, first due in the calendar year 2003.

# 5 PROPOSED BOND ISSUE  
BLENDON TOWNSHIP

A Majority Affirmative Vote is Necessary for Passage.

Shall bonds be issued by Blendon Township for the purpose of PAYING THE COSTS OF IMPROVING THE PROVISION OF TOWNSHIP FIRE SERVICES, INCLUDING THE CONSTRUCTING, FURNISHING AND EQUIPPING OF BUILDINGS TO HOUSE MUNICIPAL FIRE FUNCTIONS INCLUDING RELATED SITE IMPROVEMENTS, AND THE ACQUISITION OF SAFETY VEHICLES AND COMMUNICATION EQUIPMENT, INCLUDING ALL RELATED APPURTENANCES in the principal amount of \$425,000, to be repaid annually over a maximum period of 20 years, and an annual levy of property taxes be made outside the ten-mill limitation, estimated by the county auditor to average over the repayment period of the bond issue 0.24 mills for each one dollar of tax valuation, which amounts to \$0.024 for each one hundred dollars of tax valuation, commencing in 2002, first due in calendar year 2003, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?

BLENDON TOWNSHIP

A Majority Affirmative Vote is Necessary for Passage.

An additional tax for the benefit of Blendon Township for the purpose of PROVIDING AND MAINTAINING FIRE APPARATUS, APPLIANCES, BUILDINGS, OR SITES THEREFOR, OR SOURCES OF WATER SUPPLY AND MATERIALS THEREFOR, OR THE ESTABLISHMENT AND MAINTENANCE OF LINES OF FIRE ALARM TELEGRAPH, OR THE PAYMENT OF PERMANENT, PART-TIME, OR VOLUNTEER FIREFIGHTERS OR FIREFIGHTING COMPANIES TO OPERATE THE SAME, INCLUDING THE PAYMENT OF THE FIREFIGHTER EMPLOYER'S CONTRIBUTION REQUIRED UNDER SECTION 742.34 OF THE REVISED CODE, OR PURCHASE OF AMBULANCE EQUIPMENT, OR THE PROVISION OF AMBULANCE, PARAMEDIC, OR EMERGENCY MEDICAL SERVICES OPERATED BY A FIRE DEPARTMENT OR FIREFIGHTING COMPANY at a rate not exceeding 3.4 mills for each one dollar of valuation, which amounts to \$0.34 for each one hundred dollars of valuation, for a continuing period of time, commencing in 2002, first due in the calendar year 2003.

LICKING CO JT VOC SD PROP BOND ISSUE

PROPOSED BOND ISSUE

LICKING COUNTY JOINT VOCATIONAL SCHOOL DISTRICT  
(Licking, Delaware, Fairfield, Franklin, Knox and Muskingum Counties)

A Majority Affirmative Vote is Necessary for Passage.

Shall bonds be issued by the Licking County Joint Vocational School District for the purpose of CONSTRUCTING ADDITIONS TO AND RENOVATING AND IMPROVING EXISTING BUILDINGS AND FACILITIES, INCLUDING HEALTH AND SAFETY UPGRADES AND IMPROVING ACCESS FOR THE DISABLED; ACQUIRING LAND, INTERESTS IN LAND AND FACILITIES OR CONSTRUCTING FACILITIES, AS NECESSARY; FURNISHING AND EQUIPPING THE SAME; AND LANDSCAPING AND IMPROVING THE SITES THEREOF in the principal amount of Thirty-Five Million Dollars (\$35,000,000) to be repaid annually over a maximum period of twenty-one (21) years, and an annual levy of property taxes be made outside the ten mill limitation, estimated by the county auditor to average over the repayment period of the bond issue one (1) mill for each one dollar of tax valuation which amounts to ten (\$0.10) cents for each \$100 of tax valuation, commencing in 2002, first due in calendar year 2003, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?

**MADISON-PLAINS LOCAL DISTRICT  
MADISON, FAYETTE, AND FRANKLIN COUNTIES**

**A Majority Affirmative Vote is Necessary for Passage.**

**Shall a levy be imposed by the Madison-Plains Local School District for the purpose of AVOIDING AN OPERATING DEFICIT, in the sum of \$625,975 per year, and a levy of taxes be made outside of the ten-mill limitation estimated by the county auditor to average 3.75 mills for each one dollar of valuation, which amounts to \$0.375 for each one hundred dollars of valuation, for a period of 5 years, commencing in 2002, first due in the calendar year 2003?**
