
**President and Vice President; Unite States Senator; Justices of the Supreme Court; Judges of the 10<sup>th</sup> District Court of Appeals; Representative to Congress; State Senator; State Representative; County Commissioner; Prosecuting Attorney; Clerk of the Court of Common Pleas; Sheriff; County Recorder; County Treasurer; County Engineer; Coroner; Member of the State Board of Education; and Judges of the Court of Common Pleas.**
