





A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE.

AN ADDITIONAL TAX FOR THE BENEFIT OF THE HAMILTON LOCAL SCHOOL DISTRICT FOR THE PURPOSE OF CURRENT OPERATING EXPENSES AT A RATE NOT EXCEEDING SIX AND NINE-TENTHS ( 6.9 ) MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO SIXTY-NINE CENTS ( \$0.69 ) FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A CONTINUING PERIOD OF TIME.
