Ohio Campaign Finance Reporting Calendar

2013 Annual ¹	Jan. 31, 2014 to disclose activity through Dec. 31, 2013
Pre-Primary	April 24, 2014 to disclose activity through April 16, 2014
Post-Primary	June 13, 2014 to disclose activity through June 6, 2014
Semiannual ²	July 31, 2014 to disclose activity through June 30, 2014
Pre-General	Oct. 23, 2014 to disclose activity through Oct. 15, 2014
Post-General	Dec. 12, 2014 to disclose activity through Dec. 5, 2014
2014 Annual ³	Jan. 30, 2015 to disclose activity through Dec. 31, 2014

These deadlines are based on the **2014** primary and general election dates. Activity related to special elections may require reporting on different dates. Filing entities submitting reports to a county board of elections are encouraged to contact the board for special elections dates and filing deadlines not included on this calendar.

Additional Filing Requirements for Statewide Candidates

Monthly reports are due of any statewide, not General Assembly, candidate campaign committee to report contributions received during the months of July, August and September.

In 2014 these reports are due on the following dates:

July contributions:	August 5, 2014
August contributions:	September 4, 2014
September contributions:	October 3, 2014

Monthly reports are independent of any other report. The data listed in these reports are not repeated in any subsequent report.

¹§3517.10 (A)(4) The 2013 annual is not required of any filing entity for which a 2013 post-general is required.

²§3517.10 (A)(4) Requires the semiannual to be filed by statewide and county candidates in non-election years and completely exempts all judicial candidates.

³§3517.10 (A)(3) Requires the Annual report to be filed no later than the last business day of January. In 2015, the last business day is Friday, January 30.

- April 14 Secretary of State and boards of elections must send notice to candidates to file pre-election campaign finance reports..... [R.C. 3517.11](#)
- June 3 Secretary of State and boards of elections must send notice to candidates to file post-primary election campaign finance reports..... [R.C. 3517.11](#)
- July 21 Secretary of State and boards of elections must send notice to candidates required to file semiannual campaign finance reports [R.C. 3517.11](#)
- Oct. 13 Secretary of State and boards of elections must send notice to candidates to file pre-general election campaign finance reports [R.C. 3517.11](#)
- Dec. 2 Secretary of State and boards of elections must send notice to candidates to file post-general election campaign finance reports..... [R.C. 3517.11](#)

- Jan. 20 Secretary of State and boards of elections must send notice to candidates required to file annual campaign finance reports [R.C. 3517.11](#)
