1 MR. PAYNE: Are we ready,
2 Mr. Chairman?

3 CHAIRMAN PREISSE: Yes.

4 MR. PAYNE: I will go ahead and take
5 roll call.

6 MEMBER SHUMAKER: Present.

7 CHAIRMAN PAYNE: Mike Sexton.

8 MEMBER SEXTON: Here.

9 CHAIRMAN PAYNE: Doug Preisse?

10 CHAIRMAN PREISSE: Here.

11 MR. PAYNE: And Meredith Freedhoff.

12 MEMBER FREEDHOFF: Here.

13 MR. PAYNE: We have a quorum,
14 Mr. Chairman.

15 The first item on the agenda is the
16 approval of the minutes, and I believe Erin sent
17 those out for the September 8, 2025 meeting of the
18 Franklin County Board of Elections.

19 MEMBER FREEDHOFF: Mr. Chairman,
20 Meredith Freedhoff. I move that the board approve
21 the minutes of the September 8, 2025 meeting of the
22 Franklin County Board of Elections as submitted.

23 MEMBER SHUMAKER: Chairman, Jamie
24 Shumaker. I second the motion.

1 MR. PAYNE: It's been properly moved
2 and seconded. All of those in favor of the motion
3 signify by saying aye.

4 (All members of the board voted unanimously by
5 saying aye.)

6 MR. PAYNE: All opposed, same sign.
7 Motion carries.

8 The next item on the agenda is to
9 hire Xali Oxenreider as clerk of voter services.
10 I'm going to turn that over to Anton White, our
11 director of the Franklin County Board of Elections.

12 MR. WHITE: Thank you, David.

13 It's my pleasure to present Xali
14 Oxenreider for full-time employment to the Franklin
15 County Board of Elections.

16 Xali has been with us in seasonal
17 employment since September of 2022, and she has
18 become a very valuable part of the voter services
19 team.

20 She has a wide range of
21 responsibilities. She's helped to train new
22 seasonal employees that have come into the office,
23 and so we really appreciate her knowledge and her
24 work efforts she's given since she's been here. In

1 addition to her seasonal employment, she's also
2 served as a voting location manager since 2020 at
3 one of our larger locations, the American Postal
4 Union, it's been a precinct location, so one of the
5 largest ones we have in the county.

6 So we're excited to have her join us
7 in a full-time capacity and excited for her to
8 start her career here.

9 And pending any questions, I would
10 ask for the approval.

11 CHAIRMAN PREISSE: Sounds good. I
12 don't have any questions.

13 MEMBER SHUMAKER: Chairman, Jamie
14 Shumaker. I move that the Franklin County Board of
15 Elections hire Xali Oxenreider as a voter services
16 clerk, full-time position, beginning September 22,
17 2025 at the rate of \$21.50 per hour.

18 CHAIRMAN PREISSE: Doug Preisse. I
19 second the motion.

20 MR. PAYNE: It's been properly moved
21 and seconded. All of those in favor, significant
22 by saying aye.

23 (All members of the board voted unanimously by
24 signifying aye.)

1 MR. PAYNE: All opposed, same sign.

2 Motion carries.

3 Congratulations.

4 (Applause.)

5 MS. OXENREIDER: Thank you.

6 MR. PAYNE: The next item on the
7 agenda is the withdrawal of a candidate for Blendon
8 Township Trustee. I'll turn that over to Jeff
9 Mackey, manager of petitions and filings.

10 MR. MACKEY: September 30, we
11 received written notice from Andy Lugar that he
12 wished to withdraw from the race for Blendon
13 Township Trustee.

14 CHAIRMAN PREISSE: We have
15 everything we need, right? I read the short and
16 sweet note.

17 MEMBER FREEDHOFF: Will he still be
18 on the ballot?

19 MR. MACKEY: Yes.

20 MEMBER FREEDHOFF: So you will have
21 signage at the location?

22 MR. MACKEY: We do have those
23 printed up already.

24 CHAIRMAN PREISSE: Printed up? You

1 must have presumed you knew what we were going to
2 do.

3 MEMBER FREEDHOFF: Just in case.

4 Mr. Chairman, Meredith Freedhoff, I
5 move that the board accept the withdrawal of Andy
6 Lugar from the election for Blendon Township
7 Trustee.

8 MEMBER SEXTON: Mr. Chairman,
9 Michael Sexton, I'll second.

10 MR. PAYNE: It's been properly moved
11 and seconded.

12 All of those in favor or the motion,
13 signify by saying aye.

14 (All members of the board voted unanimously by
15 saying aye.)

16 MR. PAYNE: All opposed, same sign.
17 Motion carries. The next item on the agenda is the
18 ballot allocation for the November 4 General
19 Election, and I will call on Carla Patton who's our
20 manager of operations to go through that.

21 MS. PATTON: Good afternoon. You
22 have Exhibit A that is in front of you. This
23 exhibit is the same as it was presented to you at
24 the last regular board meeting when we did our

1 initial allocation. So we're asking that you
2 approve this for a second time.

3 There are no changes to this
4 allocation based on the formulation that we used
5 for the previous board meeting. The allocation
6 does meet all of the requirements set forth in
7 Chapter 5 Section 508, the ballot quantities in the
8 election official manual set forth by the Secretary
9 of State.

10 Unless you have any other questions
11 on the formulation, we would ask that you approve
12 the allocation set forth in Exhibit A.

13 CHAIRMAN PREISSE: Any questions
14 from anybody?

15 MR. SEXTON: Mr. Chairman, see no
16 questions, Michael Sexton, I move the board adopt
17 the paper ballot allocation formula in Exhibit A
18 compiled by the board staff for the November 4
19 General Election.

20 CHAIRMAN PREISSE: Doug Preisse,
21 second the motion.

22 MR. PAYNE: It's been moved and
23 seconded.

24 All of those in favor of the motion,

1 signify by saying aye.

2 (All members of the board voted unanimously by
3 saying aye.)

4 MR. PAYNE: All opposed, same sign.
5 Motion carries.

6 I'll ask Carla to go over the
7 allocation of voting machines and poll votes for
8 the November 4 General Election.

9 MS. PATTON: So Exhibit B is the
10 final allocation for the voting equipment.

11 Again, there were no changes to the
12 formulation in this, and you'll see the total at
13 the bottom of the allocation for how many pieces of
14 equipment we are deploying.

15 This allocation will be more than
16 ample for the turnout we expect this election so we
17 would ask that you approve Exhibit B as is set
18 before you.

19 MEMBER FREEDHOFF: Carla, are you
20 expecting a turnout? Do you have a range of what
21 you think or a number? You said low turnout?
22 You're expecting low turnout?

23 MS. PATTON: My estimate is possibly
24 around 20, 25 percent turnout.

1 MEMBER FREEDHOFF: Thank you.

2 CHAIRMAN PREISSE: Any questions
3 from anybody? Okay.

4 MEMBER SHUMAKER: Hearing no
5 questions, Jamie Shumaker, I move that the board
6 adopt the voting machine allocation formula Exhibit
7 B compiled by the board staff for the November 4
8 General Election.

9 MEMBER FREEDHOFF: Mr. Chairman, I
10 second.

11 MR. PAYNE: It's been moved and
12 seconded.

13 All of those in favor, signify by
14 saying aye.

15 (All members of the board voted unanimously by
16 saying aye.)

17 MR. PAYNE: All opposed, same sign.
18 Motion carries.

19 The next item on the agenda is the
20 2026 health insurance contributions.

21 I'm going to turn that over to our
22 HR manager Chris Walter to go over that.

23 MR. WALTER: Good afternoon, board
24 members, my name is Chris Walter. I'm the HR

1 director of the board of elections.

2 What you have in front of you is the
3 calendar year 2026, the board of commissioners
4 bi-weekly contribution health rate for health
5 insurance and its employees.

6 The single rate will increase from
7 \$85 to \$96 per pay. And the family and domestic
8 partners rate will increase from \$189.50 to \$214
9 even per pay.

10 In addition a contribution holiday
11 will be given for the first pay in January 2026.
12 As a result, the agency and its employees will pay
13 zero for this first pay in January 2026.

14 And this contribution holiday will
15 reduce the annual cost of the healthcare rate from
16 13 percent down to 8 percent, for both the agency
17 and the employees.

18 I recommend that we accept the board
19 of commissioners rate adjustment and request board
20 approval.

21 MR. PAYNE: Thank you, Chris.

22 MEMBER SHUMAKER: One question, have
23 they always done this holiday pay or is this the
24 first time?

1 MR. WALTER: This will be the first
2 time.

3 MEMBER SHUMAKER: Okay.

4 CHAIRMAN PREISSE: I don't have any
5 questions. Does any other board member?

6 MEMBER FREEDHOFF: I do not.

7 MEMBER SEXTON: Seeing there are no
8 questions, Mr. Chairman, Michael Sexton, I move the
9 board adopt the 2026 employee health insurance
10 single and family contribution rates recommended by
11 the board of commissioners.

12 CHAIRMAN PREISSE: Doug Preisse,
13 second the motion.

14 MR. PAYNE: It's been properly moved
15 and seconded. All of those in favor of the motion,
16 signify by say aye.

17 (All members of the board voted unanimously by
18 saying aye.)

19 MR. PAYNE: All opposed, same sign.
20 Motion carries.

21 MR. WHITE: Thank you, Chris.

22 MR. WALTER: Thank you.

23 MR. PAYNE: The next item on the
24 agenda is the voter information that we send out to

1 households with registered voters in them, and I
2 will turn that over to Erin Gibbons who is our
3 executive manager.

4 MS. GIBBONS: Good afternoon, board
5 members. I believe all of you have in your packets
6 a copy of our annual General Election voter
7 information guide.

8 This would go to all households with
9 a registered voter in Franklin County. It includes
10 information on how to sign up to be a poll worker.
11 It includes information about voter ID, voting on
12 Election Day, early voting, as well as absentee
13 voting. It has general information regarding dates
14 and deadlines, and what items are on the ballot.

15 This would cost \$36,013.59, and so
16 with your approval, I would recommend that we pass
17 this. Thank you.

18 MR. WHITE: Thank you.

19 MR. PREISSE: This is a -- does this
20 go out in the -- what rate does that go out on?

21 MR. WHITE: It goes out at the
22 lowest rate possible based on...

23 MS. GIBBONS: It's the nonprofit
24 rate.

1 MR. PAYNE: I think it would be 23
2 cents or something. Is that?

3 MS. GIBBONS: It's about 24 cents,
4 yeah.

5 CHAIRMAN PREISSE: Why are we
6 listing the Apple Wallet paragraph?

7 MS. GIBBONS: It's to let folks know
8 that they cannot use their Apple ID for voting
9 purposes.

10 CHAIRMAN PREISSE: Just a proactive
11 alert?

12 MS. GIBBONS: Yes.

13 CHAIRMAN PREISSE: Good, I think. I
14 looked at the electronic version, but I appreciate
15 another minute or two to look at the printed
16 version.

17 MEMBER SHUMAKER: Is this just going
18 to be folded in half? Is what this is?

19 MS. GIBBONS: Yeah.

20 CHAIRMAN PREISSE: Very good catch.

21 MEMBER FREEDHOFF: It's missing a
22 period under "important election information, know
23 before you go," that first paragraph, if you're
24 going to use all of the -- periods -- there's a

1 period after levies, I think that got deleted.

2 MS. GIBBONS: Okay.

3 MEMBER FREEDHOFF: Or missed.

4 MS. GIBBONS: We can fix that.

5 MEMBER FREEDHOFF: That's pretty
6 good. One dot.

7 CHAIRMAN PREISSE: It looks nice.

8 MEMBER FREEDHOFF: I think it's
9 really helpful, a lot of information on it. All of
10 the deadlines, too.

11 Did you decide which company you're
12 using?

13 MS. GIBBONS: Yes. The purchase
14 order should be in your packet. We're going with
15 Basement. They were the cheapest vendor.

16 MEMBER FREEDHOFF: Basement?

17 MS. GIBBONS: Yes. That's the
18 company we used last year.

19 MEMBER FREEDHOFF: Great.

20 MS. GIBBONS: Yeah.

21 CHAIRMAN PREISSE: Looks nice, I
22 think. Any other thoughts or concerns here?

23 MEMBER FREEDHOFF: Mr. Chairman,
24 Meredith Freedhoff. I move that the board

1 authorize the printing and mailing of 495,100 voter
2 information guides to all registered voters
3 households at a cost of 36,013.59 for printing and
4 \$118,323 for postage.

5 MEMBER SEXTON: Mr. Chairman,
6 Michael Sexton. I'll second the motion.

7 MR. PAYNE: It's been properly moved
8 and seconded. All of those in favor of the motion,
9 signify by saying aye.

10 (All members of the board voted unanimously by
11 saying aye.)

12 MR. PAYNE: All opposed, same sign.
13 Motion carries.

14 MS. GIBBONS: Thank you.

15 MR. PAYNE: I don't show anything
16 else on the agenda, Mr. Chairman.

17 CHAIRMAN PREISSE: Sounds good.
18 Who's the new guy?

19 MS. GIBBONS: This is Eli Redfern
20 from the prosecutor's office.

21 MR. REDFERN: Nice meeting you.
22 Thank for having me.

23 CHAIRMAN PREISSE: Assistant county
24 prosecutor?

1 MR. REDFERN: Yes.

2 CHAIRMAN PREISSE: Are you related
3 to former Chairman Redfern?

4 MR. REDFERN: Yes. Don't hold it
5 again me.

6 CHAIRMAN PREISSE: What's your
7 connection?

8 MR. REDFERN: A nephew.

9 CHAIRMAN PREISSE: Nephew. Okay.
10 Distant enough that we're going to treat you good
11 or well.

12 Move to adjourn.

13 Welcome.

14 MR. SHANNON: Mr. Chairman, can we
15 be afforded an opportunity to speak, or do we have
16 to come back at a later day?

17 CHAIRMAN PREISSE: What -- do we
18 know about this?

19 MR. SHANNON: She put in a speaker
20 slip earlier.

21 MS. SHANNON: I didn't know the
22 agenda when I put that in.

23 CHAIRMAN PREISSE: How are we guided
24 here?

1 MR. WHITE: I mean, typically, when
2 someone puts in a speaker slip -- I think we
3 probably just missed it. We would notify you of
4 the speaker slip. I guess we missed it. I
5 apologize if we missed it in this in instance.

6 Did you want to speak on the matter
7 that was before the board today?

8 MS. SHANNON: Another matter, sir.

9 MR. WHITE: That would be up to you,
10 if you want to hear another matter that's not on
11 the agenda.

12 CHAIRMAN PREISSE: We'll indulge for
13 ten minutes. How about that?

14 MR. SHANNON: I'll be very brief.

15 CHAIRMAN PREISSE: Okay. Please
16 come up and for the record, state your name and
17 address. I think is what we need, right?

18 MR. SHANNON: Sure. Thank you,
19 Mr. Chairman.

20 Members of the board, Mike Shannon.
21 My address is 5166 Aetna Road, Whitehall, Ohio.

22 I just recently got familiar with
23 your rules. I do appreciate the opportunity to
24 speak on a non-agenda item. And for that reason, I

1 will be very brief.

2 Jane Shannon, my wife, is a school
3 board member for the City of Whitehall.

4 She filed for reelection, and her
5 petitions were deemed insufficient because
6 approximately nine or ten signatures were ruled
7 invalid because they were printed as opposed to
8 being cursive.

9 I filed on behalf of Jane a request
10 for reconsideration based on a number of factors.
11 Primarily, the fact that we supplementally provided
12 affidavits from eight of the electors who are
13 registered voters at the prescribed address, who
14 indicated that consistent with Ohio case law, they
15 did specify that they signed the document, and that
16 their printed version is legally enforceable as is
17 the cursive version.

18 Those affidavits were submitted for
19 the request for reconsideration. We were under the
20 impression that the board would have to conduct a
21 hearing similar to the matter that went to the
22 Supreme Court just a couple of years ago; and in
23 waiting for that hearing, we checked in September,
24 because Labor Day was your normally scheduled day,

1 we were told it would be the following week. That
2 day, September 2, we did get the board of complaint
3 letter indicating they had denied the petition for
4 the reasons I stated.

5 We would respectfully submit that
6 the Supreme Court case is right on point that's
7 referred to in that letter, as well as the letter I
8 sent to the chairman and copied generically, the
9 emails that were available online to the director
10 and deputy director as well as the gentleman in
11 charge of petitions.

12 We firmly believe that Jane is not
13 as concerned about her inability to serve as she is
14 the disenfranchisement.

15 In this case, nine electors who are
16 duly registered to vote, who exercised their right
17 to petition and support Jane, to the extent those
18 signatures were determined invalid, perhaps, by
19 some administrative means, seems to be counter to
20 the Ohio law as specified in the Supreme Court
21 case, which that I could reference, but right now
22 I'm drawing a blank on it. I could look at my
23 notes, but I want to be respectful of your time.

24 MS. SHANNON: Brown.

1 MR. SHANNON: Yes. Thank you.
2 Remarkably similar, versus the Brown School
3 District.

4 Again, the facts were almost
5 identical. The Court found that you're not
6 authenticating the signature. You're
7 authenticating that the signatures are of the
8 registered voter, which in all cases, that the
9 affidavit supports was the case.

10 Finally, we filed in 2021, as you
11 know, the number of signatures, as designated by
12 the census, it was 25 signatures in 2021. Out of
13 an abundance of caution, before filing this year,
14 we were told it was 75 signatures based on that
15 same census.

16 Whitehall was the only suburb in
17 Franklin County whose census has actually gone down
18 since it was done in 2020.

19 However, we learned that your 2020
20 census data, perhaps, was not available in August
21 of 2021 due to the pandemic, and that perhaps you
22 didn't receive those new numbers until September of
23 2021.

24 Obviously, candidates were not

1 advised of that change, and I only bring it up
2 because we were only able to file the 82
3 signatures; however, 68 were determined valid.
4 They were the same people that historically had
5 supported Jane in her six years -- six decades of
6 public service to the city. Thank you for your
7 time.

8 She would like to address the board
9 as well.

10 MEMBER FREEDHOFF: Thank you.

11 CHAIRMAN PREISSE: Any questions?
12 We've heard some of this before, right? And now,
13 I'm taken a little bit unaware because I'm trying
14 to refresh my memory based on your comments.

15 Does this come to mind to you? Are
16 you recalling this situation?

17 MR. ZAGROCKI: Yes.

18 CHAIRMAN PREISSE: Any questions for
19 Mr. Shannon?

20 MR. SHANNON: And I did not mean to
21 come in unannounced, but the case is Village of
22 Georgetown versus Brown County Board of Elections,
23 and it's good law. They did change a lot of
24 existing law and some misconceptions about the

1 authenticity of the voter vis-a-vis the signature.

2 And, again, we don't want to be
3 confrontational or adversarial at all.

4 I know my sharp, legal mind tells me
5 that my wife will not be able to get on the ballot
6 and that's a fait accompli, but she honestly wants
7 to make sure it doesn't happen to somebody else
8 similarly situated in the future.

9 CHAIRMAN PREISSE: I want to ask you
10 or your wife or both of you what is it you're
11 seeking?

12 MR. SHANNON: We want to make the
13 board aware that, as you were apparently were
14 unaware, that we filed for a reconsideration. We
15 cited the appropriate case law, we peripherally
16 asked the board to take action, and, despite -- I
17 mean, your staff has been great. We are not
18 throwing anybody under the bus. Some of the girls
19 at the front desk said they saw me so much they
20 nominate me for employee of the month.

21 So but it was my --

22 MR. WHITE: Good for an eight-hour
23 day.

24 MR. SHANNON: But it was my

1 responsibility to get my bride of 48, six months
2 and 17 days on the ballot. I screwed up.

3 But in defense, I would say that I
4 legally screwed up. So I want the board to be
5 aware of it. This is important to her. She's much
6 more articulate than me. I'll sit down unless you
7 have any additional questions for me, and I do
8 appreciate your indulgence very much.

9 CHAIRMAN PREISSE: Thank you.

10 MS. SHANNON: I'm an elementary
11 school teacher. I don't like adults.

12 CHAIRMAN PREISSE: Just look at us
13 and think of us as the six-year olds we all were
14 and still reside within us.

15 MS. SHANNON: Good afternoon and
16 thank you for listening. I sure appreciate it. I
17 mean it. Even though I understand kind of too late
18 unless you want to stop the presses.

19 Anyway, I have been a resident of
20 Whitehall 68 for years. I served in Whitehall
21 School District in the City of Whitehall for over
22 40 years, so kind of a long time. I'm telling my
23 age. I think I pretty much know everybody in the
24 City of Whitehall. By the way, one of the

1 addresses that was not accepted said the street
2 that I lived on and my husband too, we grew up
3 together, was Whitehall Drive, and they only put
4 Whitehall; and just FYI, there's no other street in
5 the whole City of Whitehall that has the name
6 Whitehall in it, FYI. I don't expect you all to
7 know that or anybody else, but anyway.

8 However, I do have a denial of the
9 civil rights of these people which should be the
10 opportunity to vote for me after they signed, and
11 swear on an affidavit that they signed, who they
12 are, that's who they are, even though their
13 signature was printed. It would match the print on
14 their original register, however, you sign and went
15 to the library, you swear, anyway, I was to run for
16 the city school board again, vigorously endorsed by
17 my colleagues.

18 I taught, like I say, elementary
19 only 1 through 5. I'm not sure about adults here.

20 I retired in 2019 from Whitehall
21 Schools. I loved teaching my grades 1 through 8.
22 I loved being on the board. I loved, loved
23 representing my constituents and my colleagues and
24 I love my kids. That's why I am there.

1 I enjoyed working for the union. We
2 had a great relationship. I filed the petition, as
3 my husband already said, I'm not even going to go
4 over all of that. However, I do want to say
5 something, I'm an elementary school teacher. In
6 the year 2010, I taught elementary so I taught
7 cursive.

8 2012, in particularly, in the State
9 of Ohio, we were not permitted to teach cursive
10 because we had to concentrate on the core
11 requirement curriculum at that time. So we were
12 not allowed. So there were many kids I could do
13 code with because they can't read or they couldn't
14 write, and they still are -- they graduated now,
15 probably registered voters at this point, that
16 cannot write cursive, that do not know how -- they
17 cannot read it either.

18 So I'm just suggesting something,
19 maybe this might be a good idea. So I had to
20 concentrate on the core curriculum and those
21 people, like I say, are probably voters. So I was
22 commissioned by the governor of the State of Ohio
23 as a notary public as well. So I understand the
24 oath and the seriousness of saying you so swear in

1 that you are, blah, blah, blah, and everything in
2 the document is true to the best of your ability.
3 And I'm not -- I don't care what's in that
4 document. They call me every name in the book.
5 I'm notarizing this person swore to that. So that
6 is an important commission.

7 And I have them sign the affidavit.
8 They did all that my husband said they did, would
9 do, everything else was particularly correct. I
10 understand particularly if the address is
11 incorrect, gotcha. That zip code incorrect,
12 gotcha. I understand that totally, but there is a
13 problem, perhaps, our lives change from day to day?
14 If I sign -- the way I sign my name, when I
15 registered, compare my signature to, it's nothing
16 like I do today.

17 I have osteoarthritis. It's
18 debilitating, and it's progressive. So I don't
19 look anything -- my signature looks nothing like
20 that, or very little like it. I'm just concerned
21 that these people like I have, it's a disability or
22 any kind of disability may not match that
23 particular signature, and that concerns me because
24 when a staff member, they don't know. You know,

1 though don't know those people. They're just doing
2 what they're told to do, and compare those
3 signatures that are on file.

4 In conclusion, like I said, I taught
5 cursive over the past many, many years, and they
6 finally realized -- just within the past -- 2018, I
7 believe, that we need to know that because our
8 historical documents are in cursive. It was really
9 difficult in high school for those children to
10 understand, those students. And so I have a
11 concern about that.

12 Maybe I have a suggestion, if it's
13 at all possible, I don't know, but maybe another ID
14 to help ID those people be the last four digits of
15 the Social Security number. That's used a lot. So
16 it doesn't give away all of the personal, you know,
17 all the rest of it, of course, but just a
18 suggestion. And I realize -- thank you for letting
19 me talk, but I do realize I'm not going to be on
20 this time. But I just thought for the future, just
21 something to think about policy change, perhaps.
22 Thank you so much for letting me talk.

23 CHAIRMAN PREISSE: Thank you. Any
24 questions or thoughts?

1 MR. WHITE: If I may. So as the
2 board is aware, every election we have candidates
3 that we do not certify valid for any number of
4 reasons. One of the biggest reasons is for lack of
5 signatures or signatures we cannot authenticate.

6 And Jeff Mackey stepped in the room.
7 Jeff Mackey can speak to our process. The process
8 we go through to check -- to verify signatures we
9 have on file.

10 But as a result of not certifying
11 candidates to the ballot, we get a number of
12 requestss for reconsideration. The Ohio Elections
13 Official Manual and state law does not stipulate
14 that the board has to hear a request for
15 reconsideration. It's up to the board to decide
16 whether or not that would occur.

17 So I can tell you for this past
18 August filing and in the previous May election,
19 we've had request for reconsiderations. We had one
20 back in May, a candidate requested reconsideration.
21 He brought in signatures. He brought in
22 affidavits. We denied that request. He took us to
23 court, and the Court found in our favor.

24 So we appreciate the effort. And so

1 I wanted to have that as a bit of background for
2 the record, that this is not a unique situation.

3 We deal with this each election and
4 we have to look at the circumstances and make those
5 determinations as to whether or not the board is
6 going to hear a request for reconsideration. And
7 if Jeff Mackey wants to add anything, petitions and
8 campaign finance office, you're welcome to add to
9 that, but this is just a bit of a background.

10 MEMBER FREEDHOFF: I have a Supreme
11 Court case cited. Can someone tell me what that
12 is.

13 MS. SHANNON: Georgetown versus --
14 it's the Board of Education, isn't it?

15 MR. SHANNON: Yes.

16 MS. SHANNON: Georgetown Board of
17 Education.

18 MR. SHANNON: Georgetown versus
19 Board of Education.

20 MS. SHANNON: I'm sorry.

21 CHAIRMAN PREISSE: Georgetown versus
22 Brown County Board of Education.

23 MS. SHANNON: Yes, sir.

24 CHAIRMAN PREISSE: Also, just for

1 the record, Mr. Shannon said that we were evidently
2 unaware of the request for the consideration.

3 This may be further disappointing to
4 you, but we were aware of it and decided based on
5 the circumstances and our advice of counsel, that
6 there wasn't -- we weren't going to go through with
7 it.

8 MS. SHANNON: Okay.

9 CHAIRMAN PREISSE: So we were aware
10 of it. Glad you're bringing these matters, not to
11 our attention, but further in your opinion.

12 I'll suggest that we have an
13 internal conversation so we don't violate a
14 meeting. I wonder if Ms. Shumaker and I might sit
15 with the staff because you and I haven't spent time
16 together, and you're a newbie.

17 You know, so often we find things
18 out of our control. We're an administrative body.
19 We don't make laws, but we're running into issues
20 all the time where legislature can help us. This
21 may or may not be a situation like this.

22 MS. SHANNON: We do at the school
23 board too as well. I totally empathize. We run
24 into that too, but thank you. I don't want to keep

1 you any longer. I appreciate you listening to me.
2 That's pretty much it.

3 Thank you.

4 CHAIRMAN PREISSE: Thank you.

5 MS. FREEDHOFF: Thank you for being
6 a teacher and for fighting for cursive.

7 I have a 26-year old who cannot read
8 cursive.

9 MS. SHANNON: Our kids in high
10 school struggle. We thought, no, this cannot go
11 on.

12 CHAIRMAN PREISSE: The stenographer
13 wants to bring back shorthand, but we're drawing
14 the line there.

15 Move to adjourn.

16 MEMBER FREEDHOFF: Second.

17 (Thereupon the meeting was concluded at 3:40 p.m.)
